To Chair Pinsky, Vice Chair Kagan, and Committee members,

My name is Onyinye Alheri and I live in Baltimore, Maryland, in the 40th Legislative district. I am writing to urge the House Appropriations Committee to issue a favorable report on HB0015 and establish a Governor's Office of Immigrant Affairs

In order to lead healthy lives with dignity, freedom and respect, US migrants benefit best from holistic community-based resources that provide guidance on a path to naturalization and sufficiency. Immigrants comprise nearly 15% of Maryland's population and 10% of Baltimore's population (both numbers that are growing steadily each year. These populations are disproportionately uninsured and less likely to access social services to which they are entitled, often for fear of retaliation and persecution from government agencies.

Undocumented migrants do not qualify for many social services including Medicaid, SSI and SNAP, while documented migrants qualify but often face significant barriers to access. Although migrants can obtain coverage via their employers, many are low-income and tend to be employed in industries that do not offer employee-sponsored coverage. Without access to a living wage and healthcare coverage, immigrant communities face significant barriers in obtaining the healthcare that they need. Further, the effects of deportation have a lasting impact on migrants and our families, inducing trauma and further displacement.

Maryland can better address the needs of its migrant communities by establishing aGovernor's Office of Immigrant Affairs, which can create a network of trusted community-based centers that provide migrant services while reducing interaction and collaboration with persecutive agencies like ICE. The services provided at this office can increase access to language programs, assist migrants with the naturalization process, connect migrants to workforce development programs, and reduce the exploitation of migrants. I support this effort because it will increase access to essential healthcare services and reduce health disparities for immigrant communities. Thank you for your time and consideration.

Catholic Charities of Baltimore strongly supports SB 85, which would establish the Governor's Office of Immigrant Affairs.

Inspired by the gospel to love, serve and teach, Catholic Charities provides care and services to improve the lives of Marylanders in need. As the largest human service provider in Maryland working with tens of thousands of youth, individuals, and families each year, we stand in solidarity with the immigrant community in Maryland. Through our work at the Esperanza Center, located in the Baltimore neighborhood of Fells Point, we offer our new neighbors ESOL classes, healthcare, legal services, family reunification services and general information.

Each day, Catholic Charities staff interact with Marylanders facing challenges and difficulties, those challenges and difficulties have only escalated during the Pandemic. COVID-19 has laid to bare longstanding inequities in our systems, especially when it comes to the immigrant community. The immigrant community has a disproportionate share of essential workers and a disproportionate share of positive cases. At the same time, the community was denied stimulus payments, often lacked access to healthcare and faced the digital divide.

In Baltimore City, the Mayor's Office of Immigrant Affairs (MIMA) not only played a key role in convening and advocating for services to the immigrant community during the Pandemic, but they have a history of standing with the immigrant community in Baltimore. Established in 2014, MIMA has been a dedicated partner of immigrant-supporting organizations and groups in Baltimore, advocating for immigrants across city agencies to make sure that programs and policies are accessible, equitable and supportive of the immigrant community. MIMA also highlights the contributions the immigrant population has made to Baltimore.

This bill envisions replicating MIMA at the state level with a cabinet-level office that would work with immigrant communities and state agencies. The office would be tasked with establishing a network of providers, increasing access to ESOL classes, assisting with immigration legal matters, leveraging immigrants' skills and strengthening the relationship between immigrants and the broader community. These are much needed services that would benefit immigrants across the State.

On behalf of the individuals and families we work with, Catholic Charities of Baltimore appreciates your consideration, and urges the committee to issue a favorable report for SB 85.

Dear Chairperson Pinsky, Vice Chairperson Kagan, and Members of the Senate Education, Health, and Environmental Committee:

The Maryland Commission on Civil Rights ("MCCR"; "The Commission") is the State agency responsible for the enforcement of laws prohibiting discrimination in employment, housing, public accommodations, and state contracts based upon race, color, religion, sex, age, national origin, marital status, familial status, sexual orientation, gender identity, genetic information, physical and mental disability, and source of income.

Senate Bill 85 establishes the Governor's Office of Immigrant Affairs and its structure. The Office is mandated to connect immigrants with community resources and support services; support initiatives to increase equity and opportunity with immigrants; reduce barriers to accessibility for immigrants due to language barriers; advise the Governor concerning matters affecting immigrants; coordinate with other state agencies to ensure resource delivery that serves the need of immigrants, and provide support to local governments to support immigrants and their communities. The Office will also be required to submit an Annual Report with specific information on June 15, beginning in 2022.

Unlawful discrimination based on race and national origin continue to be chronic issues facing Marylanders, especially within immigrant communities. Providing access to resources and support services to those who are marginalized and disenfranchised is an effective way to eradicate unlawful discrimination and to promote equality. Leveraging the resources and knowledge of the state government and its partners builds more secure, vibrant, and cohesive communities for everyone's benefit.

For these reasons, the Maryland Commission on Civil Rights urges a favorable vote on SB85. Thank you for your time and consideration of the information contained in this letter. The Maryland Commission on Civil Rights looks forward to the continued opportunity to work with you to improve and promote civil rights in Maryland.

Senate Bill 85 establishes the Governor's Office of Immigrant Affairs to create a network of neighborhood-based centers providing immigrant services, assisting immigrants with the naturalization process or applying for Deferred Action for Childhood Arrivals (DACA), assist law enforcement in combating crimes against immigrants, and promote civic and economic participation among immigrant communities.

Maryland is a vibrant and diverse state. Approximately 15 percent (911,582) of our population is foreign-born and just over 7 percent (443,489) are noncitizens. Between 2010 and 2014, nearly 300,000 people in Maryland lived with at least one undocumented family member; and 7 percent of U.S. citizen children in Maryland live with at least one undocumented family member. For years, these Marylanders have lived under the constant threat of detention and deportation – an often cruel and inhumane system that rips families apart and captures immigrants with and without lawful status. Senate Bill 85 counteracts some of the federal hostility towards immigrants that we have witnessed over the past four years by ensconcing in the State executive branch a Governor's Office of Immigrant Affairs to help these Marylanders navigate our systems.

² While immigration raids increased significantly under the Trump Administration, prior federal administrations also arrested and deported Maryland residents and some immigration enforcement is expected to continue under the Biden Administration.

Section 9-3304 of the bill requires the Director of Immigrant Affairs to file annual reports to the Governor and General Assembly describing the activities of the Office to include: (1) summaries of calls and queries received through the hotline and website; (2) information on English for Speakers of Other Languages (ESOL); (3) the estimated number of immigrants assisted; (4) the status of workforce development programs; and (5) any other relevant information.

The Office of the Attorney General supports policies, like those proposed in SB 85, that promote the provision of services to immigrants residing in Maryland. Therefore, we urge a favorable report on SB 85.

Persons have the right to immigrate and thus government must accommodate this right to the greatest extent possible, especially financially blessed nations: "The more prosperous nations are obliged, to the extent they are able, to welcome the foreigner in search of the security and the means of livelihood which he cannot find in his country of origin. Public authorities should see to it that the natural right is respected that places a guest under the protection of those who receive him." Catholic Catechism, 2241. Therefore, the Conference strongly supports legislation that supports the dignity of immigrants and their families.

RE: SB 85 - Establish Governor's Office of Immigrant Affairs - OPPOSED

Dear Senator Pinsky and Committee Members,

I do not think it Is appropriate to establish an Office of Immigrant Affairs in the Office of the Governor to assist illegal immigrants with immigration status and to assist them with employment and business opportunities at the expense of Maryland citizens. Many United States and legal Maryland residents could use help with gaining skills and finding jobs but there is no special Office for them in the Governor's Office. This legislation, no matter how well intended, is a slap in the face of legal immigrants and Maryland citizens.

I support legal immigration in numbers that we, as a country, can accommodate. I do not support encouraging more people to migrate to the United States illegally. I agree that most illegal immigrants come to the United States to build a better economic life. However, we are in the middle of a pandemic. Our economy is hurting. Adding an additional state budget item of \$400,000 annually is unacceptable. Maryland citizens and taxpayers are spending billions of dollars each year to educate and pay for health care for illegal immigrants living in Maryland. Establishing an Office of Immigrant Affairs and providing the services called for in SB 85 will encourage additional illegal immigration.

TESTIMONY IN OPPOSITION TO SB-85 (CREATION OF GOVERNOR'S OFFICE OF IMMIGRANT AFFAIRS)

My testimony is in opposition to SB-85. First, what will be the cost of these services which the taxpayers will pay for but not be able to avail themselves of? Also would not such office attract other non-citizens to the state which would naturally increase the cost?

Second, is not this bill a duplicative effort? The services listed are already being provided to non-citizens. In Montgomery County, many of them are filtered through CASA of Maryland and non-profits but financed by the County.

Not only are non-citizens assisted in "matters related to immigration", Montgomery County provides funds for attorneys to handle deportation cases. That is a service not provided for taxpayers in civil cases which a deportation case is.

Third, Section 9-3033 of the bill provides employment information and referrals to non-citizens which puts them in direct competition with tax paying citizens for resources and jobs. In the existing economic situation in this state and nationally, it is highly inequitable to ask taxpayers to pay for employment services they cannot use.

Fourth, there is concern about the involvement the proposed office has with the police. The language is far too expansive and requires specificity to make sure the neither the office staff nor the non-citizen gets the impression the office has been deputized by the Police.

Finally, there is the language regarding enhancing civic engagement by the non-citizen. It should be made clear that the non-citizen does not have the right to run for office or vote.



Dear Chairman Pinsky and other distinguished members of the Committee,

My name is Shari Rendall and I am the Director of State and Local Engagement at the Federation for American Immigration Reform (FAIR). FAIR is an non-profit, non-partisan organization of concerned individuals who believe that our immigration law must be reformed to serve our nation's interests.

FAIR advocates for immigration policies that reduce the harmful impact of illegal immigrataion on national security, public safety, the economy, jobs, education, healthcare and the environment.

Founded in 1979, FAIR has three million members and supporters nationwide including approximately 12,300 in Maryland. On behalf of our members and supporters, I am writing to express FAIR's strong opposition to Senate Bill (SB) 85. FAIR opposes the establishment of the Governor's Office of Immigrant Affairs.

The Governor's Office of Immigrant Affairs is tasked with establishing a "network of neighborhood-based opportunity centers" that among other things will provide immigration services to illegal aliens, assisting illegal aliens with matters relating to immigration status which includes helping DACA individuals with their applications, connecting illegal and legal aliens with employment resources, assisting local governments in the development of activities to enhance civic engagement, and creating a hotline to disseminate information and refer for services.

Creating special services and privileges for one segment of the population tells residents that certain segments of the population are more favored than others and it sows distrust in the government. Instead of directing these resources to the needs of the community as a whole, it is promoting "welfare rights" for those who are illegally in the country.

Moreover, creating a Governor's Office of Immigrant Affairs institutes policies that direct resources to illegal aliens, shifting the cost of illegal

immigration onto Maryland taxpayers. It will also serve as a magnet for more illegal immigration resulting in higher costs of living, reduced job availability, lower wages, and higher crime rates in the State.

Additionally, it will put a strain on Maryland's capacity to help the truly needy in the state. The COVID-19 pandemic has already stretched state resources dramatically. Maryland cannot afford new offices and programs that do not directly benefit Marylanders but those who are here illegally.

This bill suggests that it is important to create trust in the immigrant community and that is accomplished through civic engagement. However, instead of creating trust, it will cause division among Maryland residents.

My name is Amy Waychoff, and I have lived in Montgomery County for over 33 years. Thank you for giving me the opportunity to provide testimony on SB085. This legislation would set up a Governor's Office of Immigrant Affairs that would administer a costly "network of neighborhood-based opportunity centers" to provide immigration services to illegal and legal aliens. It is clear from the language of the bill that the main focus of the advocacy provided by this office would be for illegal aliens. Setting up such an office would be just one more example of the Maryland legislature's attempt to make the state a magnet for more illegal aliens. The more free services provided for illegal aliens, the greater the incentive for illegal aliens to make Maryland their home. This in turn results in higher costs of living, reduced job availability, lower wages, and higher crime rates.
