### **Bill Summary:**

Senate Bill 571 creates an interstate licensed professional counselors compact, to be enacted when nine other states have also passed legislation substantially similar to this Act.

### **Background:**

Kennedy Krieger Institute is dedicated to improving the lives of children and young adults with developmental, behavioral, cognitive and physical challenges. Kennedy Krieger's services include inpatient, outpatient, school-based and community-based programs.

<u>Licensed Professional Counselor Services</u>: Kennedy Krieger provides approximately 134,000 behavioral health appointments to 15,000 families per year, of whom over 1000 live outside of the state of Maryland.

Out of State Services: Kennedy Krieger Institute provides specialized services to patients nationally and internationally. In pre-pandemic times, families would need to make arrangements to complete the potentially costly and time consuming trip to Kennedy Krieger Institute to obtain the skilled services their child and/or family required. In our current and uncertain time with COVID-19, the telehealth service delivery model enabled our providers to see patients from 44 of the 50 states in 2020 but barriers with licensure and regulations can cause significant delays and sometimes, an inability to provide the specialized care. With the complete services offered both at Kennedy Krieger Institute locations, in our community, and in the homes of our patients and their families combined with our geographic proximity to numerous surrounding states, there has been and will continue to be extreme struggles in providing care in the absence of an interstate compact.

### **Rationale:**

An interstate compact will allow a formal and legal relationship amongst states that promote a common agenda, to improve the health and wellbeing of the patients and families that we serve so they can live their lives to the fullest. An interstate compact will allow families across participating states to have access to the highest quality of licensed professional counseling services available, while also decreasing the burdens placed on the patient, family, and healthcare system. In addition to improving access to counseling services, the interstate compact would ensure quality control of out of state providers by creating practice requirements and an oversight process. Though the need for an interstate compact has existed for many years, the COVID-19 pandemic has pushed this need to the forefront. Telehealth allows increased access to quality care with a potential that cannot be fully realized with the current absence of an interstate licensure compact. As states begin to modify their telehealth waivers and remove the expedited licensure policies put into place due to the pandemic, access to care and continuity of care will be restricted and, as a result, the full potential of those who need specialized services will not be realized. Many national professional counseling organizations have been working on and supporting interstate compacts for years, including, but not limited to, the American Counseling Association, the American Association of State Counseling Boards, the Association for Counselor Education and Supervision, the American Mental Health Counselors Association, and the National Board for Certified Counselors.

The Licensed Clinical Professional Counselors of Maryland (LCPCM) supports *Senate Bill 571* – *Interstate Licensed Professional Counselors Compact*. This bill would enter Maryland into the Interstate Licensed Professional Counselors Compact, which was developed by a National Portability Taskforce comprised of various stakeholders including the American Mental Health Counselors Association (AMHCA).

### **What the Compact Does**

The Interstate Licensed Professional Counselors Compact will become effective once 10 states pass identical legislation. Once this occurs, licensed clinical professional counselors in Maryland will be able to work in states which have entered into the compact. Currently, professional counselors are required to obtain separate licensure in each state they want to practice in.

Clinical professional counselors licensed in Maryland would still be required to meet all licensure requirements set out by the Maryland Board of Professional Counselors and Therapists. In addition, individuals licensed in other states would be subject to Maryland's laws and regulations when providing services in Maryland through the compact. This includes the Board's requirement that all in-state and out-of-state applicants complete the Maryland Law Assessment to determine if applicants are familiar with Maryland's laws and ethical code related to safe and effective practice across several content areas.

### **Benefits of the Compact**

<u>Increased Access to Care through Telehealth</u>: Even prior to the current health care pandemic, Marylanders across the state experienced difficulties accessing behavioral health services. We have seen over the past year the importance that telehealth in meeting the demand for behavioral health services, at a time when we know that there are not enough behavioral health providers overall. The inclusion of a telehealth section in the compact highlights the importance of telehealth across state

lines, while ensuring professional counselors abide by the rules of their home state and the state in which their client is located.

Improved Continuity of Care: One of the major benefits of establishing a compact in Maryland is allowing consumers to access their provider when the provider resides or relocates to another state. As each state has its own unique rules regarding reciprocity, delays in obtaining licensure are commonplace when moving from one state to another. Compacts have the benefit of ensuring that individuals will be able to more readily begin providing services when relocating, while still meeting an agreed upon set of education and training standards. This not only benefits professional counselors, it also benefits employers, which often recruit out-of-state providers in order to meet workforce shortages.



Please accept my testimony in support of SB 571 – The Interstate Licensed Professional Counselors Compact. I am a Montgomery County resident and a member of the Maryland Counseling Association (MCA).

I hold a license to practice as a Licensed Clinical Professional Counselor, and I'm recognized as a Board Approved Supervisor in the Practice of Clinical Professional Counseling by the Board of Professional Counselors and Therapists for Maryland. I also hold professional licenses issued by the Commonwealth of Virginia Department of Health Professions Board of Counseling and the Board of Professional Counseling in the District of Columbia.

Often, clients work or travel from Maryland to neighboring jurisdictions. Possessing interstate practice privileges becomes an ethically necessary yet expensive proposition when providing behavioral health services in such a highly mobile region.

The Compact is a critical initiative that would eliminate barriers to the interstate practice of professional counseling. The Counseling Compact would improve client access to professional counseling services and enhance public protection through a shared interstate licensure data system.

The Counseling Compact utilizes a "mutual recognition" model of interstate practice, whereby Compact member states agree to "recognize" valid licenses issued by other member states. To use the Compact, a professional counselor must have a license in good standing in their home state—their primary state of residence—and the home

state must be a member of the Compact. When a licensee wants to work in another member state (known as a "remote state"), the licensee must obtain a "privilege to practice" from the Counseling Compact Commission, the interstate body composed of member state officials tasked with administering the Compact upon its enactment by ten states. A privilege to practice is equivalent to a license to practice professional counseling in the remote state.

The Counseling Compact preserves each member state's authority to protect public health and safety through the existing state regulatory structure. Unlike national licensure initiatives that supersede state regulatory authority, an interstate compact allows a member state to continue to determine the requirements for licensure in that state, as well as to maintain that state's unique scope of practice for all professional counselors practicing in that state, whether through a state-issued license or through a privilege to practice.

Membership in the Counseling Compact would confer many benefits for the State of Maryland. For example, the Compact:

- Improves access to professional counseling services for residents of Maryland;
- Preserves the existing state-based licensure system;
- Improves continuity of care for residents;
- Contains a specific prevision allowing for interstate practice via telehealth;
- Simplifies and speeds up the current interstate licensure process;
- · Requires continuing education for all who practice under the Compact; and
- Improves portability for military spouses:

Overall, the Counseling Compact will support military families, improve access to and continuity of care for Maryland residents, and increase license portability for professional counselors based in neighboring jurisdictions while maintaining the current state system licensure.

This Compact is important to me because counselors and clients are more mobile than ever. This compact will increase the likelihood that clinicians can continue working with their clients without interrupting their care when the client moves out of state. It would also mean that therapists are able to meet with their clients while they are out of state for work or family. At present, the current laws result in gaps when clients go out of state temporarily, and it results in clients needing to find new providers when they move. Gone are the days when people grow up in one place and stay there for the rest of their lives. Our professions and the legislation that guides them need to change with the times, so that they reflect people's real lives.

The Rural Maryland Council **Supports** SB 571 - Interstate Licensed Professional Counselors Compact. The purpose of SB571 is to create a compact of licensed professional counselors. The compact will allow counselors who are licensed in their home state to also be able to practice within the other states in the compact. This compact will only come into effect after ten states enact the compact as law. Each state that wants to enter the Compact must meet certain requirements, such as having certain educational and legal requirements set for a counselor to be licensed in the state. A counselor that wants to provide services to one of the member states must also meet certain requirements, such as being licensed by their home state, meeting educational requirements, paying any fees, and meeting any jurisdictional requirements of the remote state where they are seeking to practice.

The goal of the Compact is to increase access to professional counseling services by recognizing licensees from other states. By allowing a licensed counselor that is licensed in another state to practice in remote states through the Compact, it will allow for more access to licensed counselors, specifically in the areas that lack these types of specialty services. Rural areas tend to lack access to specialty healthcare, including access to mental health services. The bill will also allow for counselors to provide telehealth services to remote states. This once again would help the rural areas of the membership states. Because many licensed counselors may not be located near the residents of rural areas, rural residents are often forced to go without getting the counseling they need. Expanding the number of licensed counselors available will allow for more rural residents to have access to the specific counselor that best suits their needs.

While the country as a whole is facing a shortage in mental healthcare workers, these shortages are the worst in rural and non-metropolitan areas. According to the American Journal of Preventative Medicine, 65% of non-metropolitan counties do not have a psychiatrist compared to only 27% of metropolitan counties, and 47% of non-metropolitan counties do not have access to a psychologist compared to only 19% of metropolitan counties.

SB571 would allow for more access to counselors for those who are in need of them by allowing counselors who are already licensed in their home state to provide counseling to individuals in other membership states. The Council respectfully asks for your **favorable support** of SB571.

Dear Chair Pinsky:

On behalf of the Maryland Hospital Association's (MHA) 60 member hospitals and health systems, we appreciate the opportunity to comment on Senate Bill 571.

Just 39,080 of the estimated 436,278 people in Maryland who need substance use disorders (SUD) treatment receive it—roughly 9%. Maryland hospitals support measures to strengthen our health care workforce. Yet, the state faces an ongoing shortage of behavioral health professionals qualified to treat people with SUD.

Streamlining the process to license professional counselors in multiple states—through the interstate compact allowed in SB 571—would improve access to care, particularly for specialized services.

Lack of licensure portability is one of the most critical issues impacting counselors and clients and harms access to mental health services for Marylanders in underserved areas. It also fails to address the mobile nature of health care providers, forces patients to seek new counselors when they move, and prohibits counselors from continuing their work with patients who move to a new jurisdiction. Most states require counselors to be licensed in the state where the patient resides, which limits tele-behavioral health options. It is difficult for counselors to transfer their licenses from one state or jurisdiction to another due to independent jurisdictional licensing rules and regulations. Interstate compacts, established by SB 571, address these issues.

Compacts offer a pathway for counselors to move seamlessly from one state to another. Compacts work on rules and regulations agreed to by participating states to allow health occupation boards to maintain their authority over licensed professionals. This committee passed similar legislation to ensure nurses and doctors have comparable compacts, which successfully improved access to needed services. We urge the committee's *favorable report* on this bill to ensure access to robust behavioral health services for Marylanders suffering from mental health and substance use disorder conditions.

Chair Pinsky, Vice Chair Kagan, and Members of the Committee:

Senate Bill (SB 571) will increase meaningful access to counseling services, including mental health and substance use disorder services, by eliminating barriers currently precluding out-of-state professional counselors from serving Maryland patients. The Nurse Licensure Compact and the Interstate Medical Licensure Compact have been successful in increasing the availability of healthcare practitioners in Maryland and the Counseling Compact that would be established under SB 571 will be another important step in achieving this goal.

The Counseling Compact will enhance licensure portability for practitioners wishing to practice across state lines while allowing the Maryland State Board of Professional Counselors and Therapists (BOPCT) to protect patients through enhanced sharing of licensure information. The Counseling Compact does not limit BOPCT's ability to protect public health and safety through existing Maryland statutory and regulatory frameworks. Under the Counseling Compact, BOPCT will continue to determine requirements for licensure and the scope of practice for all professional counselors wishing to practice in Maryland.

Since taking office, Governor Hogan and Lieutenant Governor Rutherford have remained committed to addressing the heroin and opioid epidemic, including expanding access to critical behavioral health and substance use disorder treatment services. The COVID-19 pandemic has only exacerbated the need for these critical treatment services. Drug overdose deaths in Maryland and across the United States have increased since the beginning of the pandemic.

In keeping with the Governor and Lieutenant Governor's commitment to reducing barriers to critical behavioral health services, the Counseling Compact will result in a much needed increase in the number of professional counselors in Maryland. According to data from the Maryland Medicaid Program and the Behavioral Health Administration, the number of people who accessed mental health services increased from 7,398 in 2019 to 106,642 in 2020. Improving access to mental health and substance use disorder treatment services will remain critical even after the COVID-19 pandemic has ended.

For these reasons, the Administration respectfully requests the Committee accept the following amendment and vote favorably on SB 571.

#### **AMENDMENT**

On page 29, in line 29, strike "shall take effect July 1, 2021" and substitute "<u>is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three-fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted".</u>

#### **Rationale:**

After consulting with stakeholders, including substance use disorder treatment services providers, we concluded that there is an immediate need for more professional counselors in Maryland.
