I thank Senator Salling & your committee for hearing my testimony today in favor of SB807, Commission for (Men &) Fatherhood. I wrote the bill and created a fiscal note projection. Two points before the getting to the merits of the bill

- 1.) The Commission should focus on biological fatherhood; that was my request when I wrote it and posture Sen. Jill Carter favors. We of course need bi-partisan effort for passage
- 2.) I believe the fiscal note to be accurate (which is to say, this bill will save Maryland money, likely in its first year after passage). It should be understood that whoever is leading this commission must have an eye toward cost savings, etc. to allow this commission to be self-sustaining as well as a vehicle for cost savings through evaluation of systems, services, policies, family law which is harmful to society & state expenditures (as well as fathers, men and children).

One cannot refute the obvious areas of opportunity whereby promoting fatherhood will save Maryland money.

I formerly incepted & chaired the Maryland affiliate of the National Parents Organization. Once I saw that their efforts were largely theatrical, I honed my efforts as a solitary effort. I worked directly for the Sr. Operations Manager at the largest child-support agency in the state. I reported to the Division Chief/appellate attorney of the state's CINA unit, housed within Baltimore City Dept. of Juvenile Services.

I am not an attorney; I am a father. If my child had needed a baseball icon or an oil rigger for me to stay in my child's life, I would have wielded a baseball bat or a 2-foot pipe wrench... it just so happened my child needed someone who could "engage" the legal system and other systems that intersect with fatherhood. So I have learned what I could along the journey.

Tender-Year Doctrine

So why do fathers need an attorney? Due to Maryland's longstanding "tender-year doctrine", favoring mothers in child custody outcomes. Because it was not just subjective bias by court/family law personnel; tender-year doctrine has been an established practice in Maryland.

“..Moreover, elevation of women's legal status during the nineteenth and twentieth centuries also contributed to the movement from 'paternal' to 'maternal' preference.⁸ Maryland adopted the maternal preference presumption, considering mothers to be the natural custodians of young children,⁹ and courts generally granted custody to mothers unless they were found to be unfit.¹⁰”

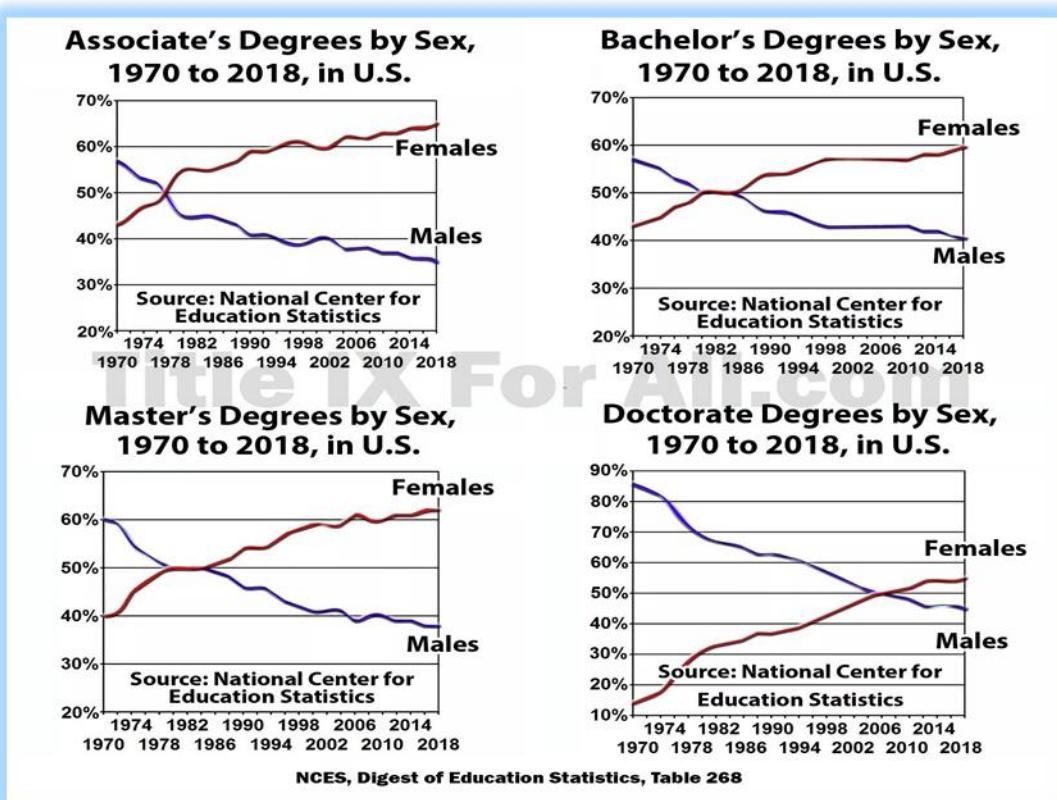

Research shows that fathers' involvement is important. A 2006 study from the U.S. Department of Health and Human Services found that involved fathers increased academic and social achievement at all stages of childhood, and that adolescents in particular with highly involved dads had better verbal skills and higher overall achievement.

How to Revive the American Dream In Blue-Collar America

When it comes to marriage, the nation is increasingly divided. Among college-educated Americans the news about marriage is surprisingly **good**: divorce is down, nonmarital childbearing is rare, and the vast majority of children are raised in **stable**, married homes. But for Americans without college degrees, the news is **sobering**: divorce is high, nonmarital childbearing has never been higher, and **about half** of children will see their parents' marriage or relationship break down and spend a portion of their lives in a home headed by a single parent.

This growing marriage divide poses obvious problems for children being raised outside of an intact family in poor and working-class communities. It's now well known that children raised in an unstable or single-parent family are much less likely to acquire the human capital, and to avoid detours like a teenage pregnancy or a spell in prison, they need to flourish in today's increasingly competitive marketplace.

Cohort studies have revealed the overall protective and positive effect of father involvement on offspring social, educational, behavioral, and psychological outcomes – throughout infancy, childhood, adolescence and adulthood. Short- and long-term positive outcomes include those pertaining to psychological health, externalizing and internalizing behavioral problems, **substance misuse, criminality or delinquency**, economic disadvantage, capacity for empathy, peer relationships, nontraditional attitudes to earning and child care, satisfaction with adult sexual partnerships, and self-esteem and life-satisfaction (Fatherhood Institute, 2013b; Feldman, Bamberger, & Kanat-Maymon, 2013; Flouri, 2005; Flouri & Buchanan, 2004; Kim, Mayes, Feldman, Leckman, & Swain, 2013; Martin, Ryan, & Brooks-Gunn, 2007; Pattnaik & Sriram, 2010; Pleck & Masciadrelli, 2004; Sarkadi, Kristiansson, Oberklaid, & Bremberg, 2008).

Disengaged and remote father-child interactions, as early as the third month of life, have been found to predict externalizing problems in children longitudinally (Ramchandani et al., 2013). Fathers' sensitiv-

VATICAN CITY — In his general audience catechesis on Jan. 28, Pope Francis turned to the role of fathers, saying that they play an irreplaceable role in family life, and their absence leaves children prey to false idols.

"When children feel neglected by fathers who focus only on their problems, on their work or their own personal realization, this creates a situation of orphans in the children and youth of today, who live disoriented, without the good example or prudent guidance of a father," the Pope said.

Pope Francis directed his words to pilgrims gathered in the Vatican's Paul VI Hall for his Wednesday address. Continuing his catechesis on the family, the Pope spoke on the theme of fatherhood.
