Chairman Pinsky and member of the Education, Health, and Environment Committee,

Senate Bill 838 is common sense legislation that would require voter identification to cast a ballot but expands the types of identification that can be used beyond driver's license or state photo ID to a number of proofs of identity.

Senate Bill 838 expands the definition of voter ID to include a utility bill, bank statement, government check, paycheck, or any other government document; a voter notification card; or the specimen ballot mailed to the voter by a local board,

Over thirty states have some form of voter ID requirement to vote in person. With trust in elections at a low ebb, this simple step to verify a voter's identity helps ensure a one-person-one-vote system and cuts down even on human errors. Maryland has had cases in the recent past of people registered in multiple states voting in both, and, anecdotally I have had constituents experience situations where someone in another county checked off their name in a poll book by mistake – causing them to have to fill out a provisional ballot.

Particularly as we move more and more to voting at early vote centers and allow for people to vote at any polling place, having a simple ID check will not just verify that fraud isn't taking place but also help eliminate human error. SB 838 can give voters more confidence that all who vote do so legally.

Dear Senators:

On behalf of the more than 1300 members of the Maryland Federation of Republican Women (MFRW), representing citizens from across Maryland, I am writing to ask you for a Favorable Report on SB 838.

We believe this bill preserves and respects the rights of all registered voters. Requiring a voter to present a photo ID (or other approved document) protects the integrity of every voters' vote. Currently, anyone who knows a registered voter's name, address, and month/day of birth can vote as that person on a regular ballot. When an individual votes on a regular ballot, it is permanent. There is no way to remove this vote once it has been cast. By requiring a voter to present photo ID (or other approved document), the integrity of the election is preserved.

Those who oppose requiring Voter ID often cite that not all voters have photo ID and that obtaining an acceptable form of ID is difficult for these people. We believe this bill addresses many of those concerns. An individual who does not have photo ID can still prove their identity through a bank statement, utility bill, paycheck, or similar document. Even if an individual still cannot prove their identity through one of these means, he or she may still vote but will use a provisional ballot. These ballots are reviewed after election day. If the voter is found to be eligible, then the vote is counted. If not, the vote is not counted. No other voter's vote is affected. The rights of all are preserved.

Therefore, the members of the Maryland Federation of Republican Women request a Favorable Report for SB838.

### Testimony on SB 838 Election Law – Polling Places – Proof of Identity Education, Health, and Environmental Affairs

### Position: Unfavorable

Common Cause Maryland opposes SB 838, which would require proof of identity to vote.

Voting is celebrated as the most fundamental form of civic participation in a democracy, a means by which all voices are counted on an equal basis. Restrictive photo identification requirements undermine this goal because they prevent eligible voters from participating, impose enormous and unjustified costs on states, and do not achieve the goals they claim to work towards.

Studies show that those without ID are disproportionately likely to be Black, Latino, low-income voters, young adults, senior citizens, and people with disabilities. For many of these eligible persons, it is no simple matter to obtain the necessary ID — the hurdles involved can make doing so difficult, and in some cases, impossible.

Having a certified copy of one's birth certificate is a prerequisite to obtaining identification from a DMV. However, many people do not have their birth certificate, have lost it, or never had one in the first place. Given that a driver's license is the most typical form of ID required to vote, it stands to reason that citizens without identification do not necessarily have an easy way to physically get to the offices they need to go to in order to get ID. And even can travel be arranged, the limited hours of service many DMVs provide, combined with long waits at the DMV, creates a third barrier for obtaining identification.

The risk of disenfranchisement is far greater than the evidence of voter fraud in Maryland. Millions of citizens residing in states with these restrictive laws do not currently possess the requisite photo ID needed to vote. And while there is anecdotal evidence of voter fraud, there is no proof that fraud is occurring on a scale that would necessitate this type of measure – or outweigh its risks.

SB 838 would roll back basic protections that allow all registered voters to engage in our democratic process, and we urge an unfavorable report.

The Office of Attorney General (the "OAG") urges this Committee to unfavorably report SB 838.

Senate Bill 838 seeks to require election judges to establish a voter's identity and verify the voter's address prior to permitting the voter to cast a regular ballot. Voter ID requirements have historically served to disenfranchise the elderly, people of limited means, and people of color.<sup>1</sup> Maryland law should seek to expand the franchise to as many eligible citizens as possible, not to constrict the franchise to only those individuals with ID and proof of address.

For the foregoing reasons, the Office of the Attorney General urges an unfavorable report on SB 838.

### **TESTIMONY IN OPPOSITION OF SB 838**

**Election Law – Polling Places – Proof of Identity** 

Senate Education, Health and Environmental Affairs Committee March 3, 2021

**Marylanders Against Poverty (MAP) strongly opposes SB 838,** which would require the identity of voters to be verified via current government-issued photo identification, certain government documents with an address, a voter notification card, or sample ballot mailed to the voter.

**SB 838 is unnecessary.** SB 838 is a solution to a non-existent problem. The most comprehensive national study on instances of voter fraud found there were only 2,068 alleged election-fraud cases since 2000 – and only ten of these cases were in-person voter fraud. The majority of the fraud cases were related to absentee ballots and registration errors – things that would not be addressed by voter ID laws. Of the 2,068 cases, only two of the alleged cases were in Maryland and neither was in-person voter fraud.<sup>1</sup>

SB 838 will disproportionately affect communities of color, women, and seniors. A study out of Harvard and Tufts Universities found that Black voters are still more likely to lack adequate identification to vote under voter ID laws, concluding there is clear racial disparity on voting rights.<sup>2</sup> This complements the study conducted by the Brennan Center which found that 11% of voting-age United States citizens do not have current and valid photo ID and that the percentage was even higher for low-income individuals (15%), minorities (25%), and the elderly (18%).<sup>3</sup> Another recent study conducted after the proliferation of voter ID laws in other states demonstrated that voter ID laws depresses Latino turnout by 9.3 points, Black and African American turnout by 8.6 points, and Asian American turnout by 12.5 points.<sup>4</sup> To quote the study, "we find that voter identification laws do, in fact, substantially alter the makeup of who votes and ultimately do skew democracy in favor of whites [...] Voter ID laws may represent one of the Nation's most important civil rights issues."<sup>5</sup>

SB 838 will disenfranchise individuals experiencing homelessness. Keeping personal identification safe and secure without stable housing is nearly impossible; people often become the victims of theft or their documents deteriorate when exposed to the elements. Institutions such as hospitals, jails, and shelters often discard all of an individual's belongings – including identifying documentation. A person leaving a domestic violence situation may not be able to retrieve important documents. Although SB 383 does allow for sample ballots, government documents, and voter notification cards to count as identification, individuals that experience homelessness do not often have an addresses where such mail can be delivered and accessed reliably. Regarding the list of accepted government documentation, many individuals living in poverty – and especially those experiencing homelessness – often do not have utility bills, pay stubs, and other such documents. Ultimately, SB 838 would create significant barriers to voting especially for the most vulnerable Marylanders.

**SB 838 is costly.** In order to inform voters of the changes in required documentation needed to vote, past fiscal notes indicates it would cost upwards of \$500,000 just for

voter outreach for one year. That does not include the additional provisional ballots that would need to be printed, or the need to hire additional election judges in order to properly implement the voter identification requirement in populated jurisdictions. Moreover, most of the states with voter ID laws are facing expensive legal challenges, and through litigation several state laws have been overturned.<sup>6</sup> As Maryland struggles with a difficult budget, inserting an expensive new voting requirement - when there is no research to indicate widespread in-person voter fraud exists - is a grossly inefficient use of State resources.

**SB 838 creates an excessive – and unwarranted – barrier to the constitutional right to vote.** Marylanders living in or near poverty are already economically disenfranchised, and SB 838 will generate voter disenfranchisement for Marylanders who lack proper identification and the means to obtain required documentation for voting. The right to vote is central to our democracy; therefore, it must be protected. Any initiative that might disenfranchise eligible voters must meet the highest burden of proof. This bill cannot meet that burden.

The Maryland Developmental Disabilities Council (DD Council) is an independent, public policy organization that works to improve policies, programs and services that support people with developmental disabilities and their families in our communities. The DD Council is led by people with developmental disabilities and their families. From that perspective, <u>the DD Council opposes SB 838</u> which may disenfranchise many eligible voters who do not have government issued photo identification.

### WHY do we oppose this legislation?

- > Voting is a fundamental right that Maryland's citizens with disabilities want and need to participate in.
- People with developmental disabilities are the least likely to own a car and possess a driver's license, which is the most common form of identification.
- Federal law guarantees the right to vote to a person with a developmental disability who understands what it means to vote, yet access remains a problem for voters with disabilities.
- Requiring a government issued photo identification card or other documentation creates an additional barrier to voting and is not needed to address any documented problem.

### WHAT does this legislation do?

- Requires an election judge to establish a voter's identity by requiring the voter to present a photo ID or other proof of identity.
- Requires a voter to vote a provisional ballot if the voter is unable to provide certain proof of identity.
- Prohibits a person from knowingly and willfully voting or attempting to vote under a false form of identification.

The reality is that there is no substantial evidence of widespread fraud by voters who actually come to the polls to vote. Federal laws such as the Help America Vote Act (HAVA), the Voting Rights Act of 1965 and the National Voter Registration Act of 1993 were enacted to make voting easier and increase voter participation.

SB 838 creates a burden for people with developmental disabilities and creates an additional barrier to entire group of people to exercise their fundamental right to vote. Therefore, **the DD Council opposes**.
