Maryland LCV supports HB503: Environment-Office on Climate Change-Establishment, and we thank the sponsor for his leadership on this issue.

This year the Maryland General Assembly will, once again, be taking up legislation to take bold steps to address the growing crisis of climate change. With more than 3000 miles of shoreline, and more than 270,000 acres less than 10-feet above sea level, Maryland is one of the most vulnerable states in the nation to the effects of climate change. In addition to the rise in extreme weather events and other climate-change related natural disasters, many parts of Maryland are increasingly experiencing "sunny day flooding," and extreme heat events that disproportionately affect communities already overburdened with pollution and negative health impacts. The Conference supports environmental legislation that recognizes the integral ecosystem in which we live. In his encyclical, On Care for Our Common Home (*Laudato Si'*), Pope Francis states that "*What kind of world do we want to leave to those who come after us, to children who are now growing up? This question not only concerns the environment in isolation; the issue cannot be approached piecemeal.*"

Laudito Si' is not an endorsement of specific public policy proposals; rather, it seeks to illustrate the importance of protecting our common home and issue guidance as to how to listen to all voices in solving this massive global crisis. Pope Francis explains that "[t]o take up these responsibilities and the costs they entail, politicians will inevitably clash with the mindset of short-term gain and results which dominates present-day economics and politics. NARAL Pro-Choice Maryland urges Members of the House Environment and Transportation Committee to issue **a favorable report on HB0503 - Environment - Office on Climate Change - Establishment**, sponsored by Delegate Pat Young.

Our organization is an advocate for reproductive health, rights, and justice. As part of our efforts to protect reproductive freedom for all Marylanders, we work to ensure every individual has the right to decide if, when, and how to form their families, and to parent in good health, in safety, and with dignity. In doing so, we support the establishment of the Office on Climate Change to ensure the Commission's recommendations are implemented. The effects of climate change are increasingly threatening human health, with unique adverse reproductive and sexual health consequences related to air, water, and soil pollution, extreme heat, and natural disasters.

Research has demonstrated the reproductive health outcomes associated with environmental pollution include infertility, abnormal menstruation and puberty, endometriosis, recurrent pregnancy loss, polycystic ovarian syndrome (PCOS), fetal death, prenatal growth abnormalities, reduced gestational period, low birth weight,¹ pregnancy-induced hypertension and preeclampsia,² and genital and breast cancers.³ Additionally, rising global temperatures is making heat a more serious threat to pregnant persons going forward; exposure to unusually hot temperatures can lead to changes in length of gestation, birth weight, stillbirth rates, and neonatal stress.⁴ These health outcomes can cause enduring mental and physical trauma to pregnant persons and the infants they deliver. Substantial research has shown that low birth weight infants may be more at risk for many health problems; some may become sick in the first six days of life or develop infections, others can suffer from long term problems such as delayed motor skills and social development or learning disabilities.⁵ Furthermore, increased instances of natural disasters result in a disruption of reproductive health services which can lead to unplanned pregnancies; conversely, natural disasters can displace families and leave them

The Commission on Climate Change has clearly outlined the threats of climate change to Marylanders with emphasis on the need to protect the most vulnerable populations, including low-income urban residents who are more exposed to environmental pollution and extreme heat, and coastal populations at higher risk of flooding and mold exposure.⁷ Establishing the Office on Climate Change is essential to implement solutions which will mitigate further environmental degradation and protect human health and access to healthcare. For these reasons, NARAL Pro-Choice Maryland **urges a favorable committee report on HB0503.** Thank you for your time and consideration.

Globally, nationwide, and in Maryland we are facing a growing, existential climate crisis. The signs are everywhere: unprecedented fires raging in California; record superstorms; analysis showing that the Colorado River has lost over a billion tons of water; huge decreases in winter snow in Maryland; flooding in Annapolis; and many, many more.

In Maryland, we have legislatively committed to significantly reducing our greenhouse gas emissions. The Greenhouse Gas Reduction Act declares that "[t]he State shall reduce statewide greenhouse gas emissions by 40% from 2006 levels by 2030." Enivir. Art. sec. 2-1204. Legislation introduced this session – the Climate Solutions Now Act (HB583) – would update this target to 60% by 2030, to reflect recent analyses by the Intergovernmental Panel on Climate Change, and require Maryland to achieve net-zero emissions by 2045.

This bill would help advance these efforts by establishing an Office on Climate Change in the Office of the Governor. We therefore urge a favorable report.

The Maryland Association of Counties (MACo) **SUPPORTS** HB 503 with amendments. The bill would establish the Office on Climate Change in the Office of the Governor, responsible for a multitude of actions surrounding the State's response to climate change. MACo amendments would add uncodified language clarifying that the new office would not gain unnecessary regulatory oversight.

HB 503 establishes an Office on Climate Change required to (1) facilitate the implementation of the Maryland Commission on Climate Change's recommendations; (2) ensure state agencies address climate change; (3) perform research and investigations into climate change topics identified by the Commission; (4) assist local government in developing climate change plans; and (5) report to the Governor and General Assembly on State actions to mitigate the effects of climate change.

Counties are on the front line of the effects of climate change, especially sea level rise and saltwater intrusion. As counties continue to combat climate change in a variety of ways, state support can be a valuable asset. Many counties do not have one department dedicated to climate change or sustainability, but those that do report highly of its effectiveness in coordinating larger efforts and providing support to the rest of the local government. The State should provide research and guidance to counties to plan and develop local actions that address the impacts of climate change in a way that best serves their residents.

MACo amendments to the bill would simply make clear that the Office on Climate Change would not implicitly gain regulatory authority to enact mandates on local government. This reinforces the intent of the original bill to create this Office to serve as a resource. Accordingly, MACo urges the Committee to provide a report of **FAVORABLE WITH AMENDMENTS** for HB 503.

MACo amendments:

On page 3, after line 15, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding any other provision in this Act, this Act shall not be interpreted to grant any new regulatory or oversight authority to either the Maryland Commission on Climate Change or the Office of Climate Change that did not exist prior to its passage. The role of the Office is intended to be advisory and facilitating, and any recommendations for new policy, standards, or requirements – including any affecting local governments or nongovernmental stakeholders – would require legislative enactment before having the effect of requiring, regulating, or prohibiting any function or activity."

On page 3, in line 16, strike "2" and substitute "<u>3</u>".

Dear Chair Barve and Members of the Committee:

The Maryland Department of the Environment (MDE or the Department) has reviewed House Bill 503-*Environment – Office on Climate Change – Establishment.* The Department would like to provide a letter of concern, given the risk of duplication and inefficiency considering current and comprehensive coordination among agencies on climate change, a continuing priority for the Hogan Administration.

House Bill 503 would establish the Office on Climate Change ("Office") within the Governor's Office. Provisions in this bill would likely duplicate work currently being performed by MDE in coordination with the Governor, the Governor's cabinet agencies, the Chesapeake Bay Subcabinet, and the Maryland Commission on Climate Change ("MCCC" or "the Commission"). The specific provisions that would be established under this bill are discussed in detail below.

The bill would require the Office to "coordinate with the Commission on Climate Change to ensure the Commission's recommendations are implemented". MDE Chairs the MCCC and works in partnership with the Commission and other State Agencies to implement the recommendations that the Commission makes for action by state agencies. It is important to note that some recommendations may need legislative action, which would impact the ability of the executive branch of government to ensure, per the bill language, that those recommendations are implemented. Recently, the MCCC unanimously approved a recommendation for Maryland to adopt ambitious GHG reduction goals. The Commission, informed by the latest scientific findings on necessary action by developed nations to limit global temperature increases and by the research and analysis of reduction opportunities by the Commission's Greenhouse Gas Mitigation Working Group (MWG), recommended a 50% reduction of GHG emissions by 2030. The Department released the executive summary of the forthcoming 2030 GGRA Plan wherein the Department and the other Maryland state agencies advanced a portfolio of measures that will reduce Maryland's 2030 GHG emissions to 48.7% below 2006 levels, very nearly achieving the Commission's recommended 2030 goal.¹ The Department intends to supplement that plan shortly with updated estimates incorporating additional federal policies that will almost certainly bring Maryland's emissions below the 50% goal, once the incoming federal administration provides more detail on its immediate climate policy actions.

Secondly, the bill would require the Office to "ensure that each State agency addresses: (i) ways the agency can mitigate the causes of climate and (ii) the impacts of climate change in the agency's programs, policies, and financial expenditures." The requirement for State agencies to perform the above provisions already exists in State law under Environmental Article § 2-1305, which among other provisions, requires each State agency to "review its planning, regulatory, and fiscal programs to identify and recommend actions to more fully integrate the consideration of Maryland's greenhouse gas reduction goal and the impacts of climate change." The Department coordinates with other State Agencies to perform these tasks under the current law.

The bill would also require the Office to "(3) initiate and oversee any additional research or investigations the Office determines are necessary to address factors that the office determines are substantial in fighting climate change but are not included in the commission on climate change's recommendations." As mentioned above, in addition to the work that MDE does in coordination with the MCCC, MDE's Climate Change Program develops Maryland's long term climate plans under the Greenhouse Gas Reduction Act. Developing the plans involves comprehensive emissions and economic impact analyses to evaluate the programs and initiatives needed in order to address climate change and meet or exceed the goals in the GGRA. The Climate Change Program also regularly performs additional research and analysis on specific topics.

Next the bill would require the Office to "work with local governments to: (i) develop and implement local climate change plans and (ii) identify resources needed for the implementation of local climate change plans." Per current Environmental Article § Section 2-1302, one member of the Maryland Association of Counties and one member of the Maryland Municipal League represent local governments on the MCCC. There is currently active coordination between the MCCC, MCCC MWG, MCCC Adaptation and Response Working Group (ARWG) and local governments. As an example, the ARWG works with the Maryland Climate Leadership Academy. The Academy provides training for local government officials and employees on various ways to plan how to adapt to and mitigate the consequences of climate change.

Lastly, the bill would require the Office to "report annually to the Governor and the General Assembly regarding the state's efforts to mitigate the causes of, prepare for, and adapt to the consequences of climate change." This is duplicative of the current requirement under § Section 2-1304 for the MCCC to submit an annual report to the "Governor and General Assembly, on the status of the State's efforts to mitigate the causes of, prepare for, and adapt to the consequences of climate change, including future plans and recommendations for legislation, if any, to be considered by the General Assembly."

The Maryland Department of Health (MDH) respectfully submits this letter of information on House Bill (HB) 503 - Commission on Student Behavioral Health and Mental Health Treatment.

HB 377 would establish the Commission on Student Behavioral Health and Mental Health Treatment and require the Commission to study matters regarding student behavioral health and mental health treatment and make recommendations on actions to improve current student behavioral health practices and programs. The Commission would be required to report its findings and recommendations to the Governor and the General Assembly on or before December 1, 2021, and December 1, 2022.

Due to ongoing COVID-19 response efforts, MDH unfortunately does not have the fiscal or personnel resources to implement this bill if it is passed. Many of MDH's current personnel have already increased their workload and absorbed additional tasks that are critical to the COVID-19 response.

We recognize and value the importance of this bill and its impact on Marylanders. As such, we respectfully request this bill be held and reintroduced in the 2022 Session. We look forward to working with the bill sponsor(s) and appropriate stakeholders in the interim.
