AMENDMENTS TO HOUSE BILL 699
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, after “of” insert “prohibiting a person from driving a motor vehicle on a certain highway or property in the State while the person’s license or privilege to drive is suspended for a violation of the Maryland Vehicle Law not occurring during the operation of a motor vehicle;”; and in the same line, strike “repealing” and substitute “establishing”.

AMENDMENT NO. 2

On page 2, in line 18, strike “under” and substitute “FOR A VIOLATION OF THE MARYLAND VEHICLE LAW NOT OCCURRING DURING THE OPERATION OF A MOTOR VEHICLE, INCLUDING A VIOLATION OF”.

On page 3, in lines 1, 2, and 6, in each instance, strike the brackets; in line 1, strike “paragraph (2)” and substitute “PARAGRAPHS (2) AND (3)”; in the same line, strike “A”; in line 6, strike “\$50”; in line 7, after “(2)” insert “(I) A PERSON CHARGED WITH A VIOLATION OF SUBSECTION (H) OF THIS SECTION:

- 1. MUST APPEAR IN COURT; AND
- 2. MAY NOT PREPAY THE FINE.

(II) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (H) OF THIS SECTION IS SUBJECT TO A FINE NOT EXCEEDING \$50.

(3) (I);

in the same line, strike “(h) or”; in lines 9 and 11, strike “(i)” and “(II)”, respectively, and substitute “1.” and “2.”, respectively; after line 11, insert:

“(II) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (I) OF THIS SECTION IS SUBJECT TO A FINE NOT EXCEEDING \$500.”;

and in line 29, after “(d)” insert “**(1) A PERSON CHARGED WITH A VIOLATION OF THIS SECTION:**

(I) MUST APPEAR IN COURT; AND

(II) MAY NOT PREPAY THE FINE.

(2)”.

On pages 3 and 4, strike beginning with “is” in line 29 on page 3 down through the first bracket in line 2 on page 4 and substitute “**IS SUBJECT TO**”.

On page 4, in line 2, strike the brackets; and in the same line, strike “**\$50**”.
