I live in a community where there are 400 plus homes, a number of these homes back up to Seth Demonstration Forest. There are two entrances into these woods, one from our community and one at the opposite end with an entrance from a county road. People enjoy the tall canopy of trees and the wide natural paths. People walk with their dogs, grandchildren, for themselves and a few horseback riders visit. This bow hunt designated area has 5 Sundays at this time during the best part of the year to be in the woods. Increasing Sunday hunting would prevent visiting Seth Forest the complete fall and it could certainly cause human involved hunting accidents to those not aware.
