**Reserve Studies-MC 3-21** 

Position: Oppose

Dear Del. Barve & members of the Environment & Transportation Committee:

We regret to inform you that, due to the Community Associations Institute's National Public Policy to oppose mandatory reserve requirements for community associations, we are required to oppose HB567. Previously, we opposed only on the basis that we were supporting a similar statewide bill (HB313), but we must now oppose that bill, as well.

Should this bill go forward, we would like to point-out some issues our management members have found with the Prince George's legislation that passed last year and maybe these can be resolved through amendment.

- 1. There are at least two recommended funding methods cited in most reserve studies: Cash Flow and Component. The law does not state which method is to be used.
- 2. The law provides for full funding, but does not state whether that means depositing the recommended amount each year or catching-up on prior years' underfunding, which could be substantial.

We might suggest that the minimum contributions shall be the lesser of the recommended funding level for either Cash Flow or Component Methods. If an association is short of the recommended balance, they should have up to two years to secure an updated study so that the study can recommend a new annual funding level that will achieve a suitable minimum balance.
