The Mid-Atlantic P.A.N.D.A. is in Favor

We represent the Mid Atlantic P.A.N.D.A. Coalition (Prevent Abuse and Neglect through Dental Awareness). We were established in 2000, our mission is "To create an atmosphere of understanding in dentistry and other professional communities which will result in the prevention of abuse and neglect through early identification and appropriate intervention for those who have been abused or neglected." Dentists and Dental Hygienists (Dental Professionals) are mandated by the State of Maryland to report suspected cases of abuse and neglect. Our coalition has established a Continuing Education (CE) course that educates Dental Professionals and other how to recognize, report, or refer. The Maryland State Board of Dental Examiners has deemed this course as a mandatory CE requirement for Dentists and Hygienists to renew their licenses. We also address domestic violence, elder abuse and human trafficking in our CE course.

This bill will allow for flexibility in making preventive dental appointments for Medicaid participants, and it will not add any additional financial burden to the Maryland Medicaid. Preventive dental treatment is especially important to the total health of an individual. When you allow for flexible timing of these appointments it will help families to better align their appointments; especially when transportation is an issue for this population. This practice is not foreign to the General Assembly since they have already made this type of prevision for privately insured individuals is 2012.

### The Maryland State Dental Association Supports SB 485 – Dental Prophylaxis Care and Oral Health Exams

SB 485 corrects a problem that often creates a hardship for dental patients, and which not infrequently denies them covered dental care. Currently the Maryland Dental Medicaid Program provides coverage for dental prophylaxis care and oral health exams twice a year. However, the second dental visit for this care cannot be less than 180 days since the previous treatment. Unfortunately, life does not operate on a six-month schedule of availability.

For example, last year one of our dentists had a medically compromised school child come to his office as a new patient. As the dentist later learned, it had been 5 months and three weeks since the child's last dental cleaning in another dental office. Coverage was denied by Medicaid's Maryland Healthy Smiles Dental Program. It is an absurd situation when care is covered if 180 days has elapsed, but not when it has been 170+ days between visits. These kinds of situations are not infrequent among students, expectant mothers, and families who are being moved by the military. It is more equitable and sensible to continue to limit these services to twice a year, but cover second treatments if they are provided at an interval of not less than 120 days.

This is the current law in the dental health insurance world. This General Assembly passed legislation in 2012 mandating this same requirement for all dental insurers regulated by the State. However, that law does not apply to Medicaid. This bill will bring Medicaid into conformity with the rest of the dental coverage world, and provide equity in dental care for children who must rely on Medicaid for their oral health needs.

For these reasons the Maryland State Dental Association urges that SB 485 be given a favorable report.

### Testimony in Support of SB 485

### Medical Assistance – Dental Prophy & Oral Health Exams

Senate Finance Committee

Tuesday February 16, 2021

Madam Chair, Mister Vice Chair, and members of the Senate Finance Committee, thank you for the opportunity to provide written today in support of SB 485. My name is Charles Doring and I am general dentist in Rockville Maryland. Along with providing dental care in an office setting, I also provide portable dentistry and I am on the medical staff of several nursing homes in Montgomery County. I also serve as the Legislative Affairs Committee Chair for the Maryland State Dental Association, was recently named to the Provider Advisory Board of the Maryland Health Smiles (Medicaid) program, and I am also a member of the Deans Faculty at our dental school, the University of Maryland School of Dentistry (UMSOD).

HB 547 Medical Assistance - Dental Prophy & Exams is a great bill that the Maryland Dental Association and I strongly supports. Nine years ago, I worked with Senator Nancy King to pass a similar bill that states insurance companies must pay benefits for covered preventive services as long as the last service was greater than 120 days prior. This is helpful for students, expecting mothers, pre-surgical dental clearance for procedures such as organ transplants, and individuals and families of those being deployed when benefits have been denied in the past due to frequency between preventive care visits. Unfortunately, life does not operate on a 6-mouth schedule of availability. Last year, I had this very same issue with a Medicaid patient. A Medicaid medically compromised grade school child present to my office 5 months and 3 weeks post her last dental cleaning in another office. Preventive care benefits were denied by the program administer, Skygen. When Senator King and I inquired to the contractor and the Maryland Department of Health, we were told by the Department of Health that Medicaid is exempt for it is not insurance (see accompanying letter). This bill corrects this loophole and allows preventive services to occur with some flexibility in scheduling. The bill should be cost neutral for it does not add to the annual maximum for preventive services provided but should cut administrative staff time in the process of handling rejected claims.

For these reasons, I ask for a favorable report on HB 547.

Dear Skygen Dental Consultant:

I am filing an authorized written appeal on behalf of the family of Maryland Healthy Smiles patient

Written consent from her guardian father is attached. This appeal deals with the issue concerning the intent of Maryland Law, concerning the frequency of covered preventive dental services. This is an issue that I have previously disclosed to the Maryland Health Department, the Director of the Maryland Office of Oral Health, the Maryland State Dental Association, Skygen Representative Latia Mitchner, Maryland State Delegate Bonnie Cullison and Maryland State Senator Nancy King. I feel that Maryland Healthy Smiles administrator, Skygen, is not following Maryland Law that went into effect 10/1/12 with the passage of SB 849, legislation that was sponsored by Senator Nancy King. First, I will explain the law then, I will relate the law to my appeal.

The bill was entitled "Health Insurance-Dental Preventive Care-Coverage". Senator King was concerned when patients presented to the dental office for a covered preventive dental benefit (ie: dental cleaning) but the prior dental visit was just shy of 6 months. In my office, this has occurred when a civilian has been deployed overseas, child presenting before the start of school term, a female in their last trimester of pregnancy, may not be available after child birth for preventive services, and patient's undergoing medical procedures (ie: organ transplants) need prior dental clearance before surgery.

### 2012 SB 849 states:

- (b) A carrier that provides coverage for dental preventive care one or more times during a plan year shall provide coverage if:
  - (1) Benefits are available; and
- (2) Any other requirements for the coverage of the dental preventive care are met.(c) If the dental preventive care is covered more than one time during the plan year, the dental preventive care:
  - (1) May be provided at intervals of not less than 120 days; and
- (2) May not exceed the number of times covered by the policy or contract. Senator King has always been a strong advocate for preventive medical and dental care. The intent of the law is to cover those instances, where preventive care is required past 120 days

from last visit but, may not be readily available after a 6 month time. The purpose of the law is clear, timely preventive care prevents a lot of problems later down the road. The Maryland Healthy Smiles programs administered by Skygen should be good stewards of preventive oral care and provide preventive dental benefits as directed in the intent of this law.

My office Maryland Healthy Smiles coordinator Mrs. Antonia McRoy informed me that we recently had a Maryland Healthy Smiles Claim that was denied when an adolescent, a patient with down syndrome initially presented to our dental office for preventive care just prior to the start of school in early September (date of service 9/4/19). Her father brought her in just 10 days prior to the previous 6 month dental care at her former dental office (previous date of service 3/14/19). I could have re-scheduled her at a time where her Dad would have had to take her out of school, but she needed the care and I wanted to do the most appropriate care for her and her family.

I am appealing this case for the benefit of all the patients who need timely preventive dental care, when appropriate, not based on a 6 month benefit period. Maryland Healthy Smiles is a great program that helps those who need the utmost in dental care. I feel the rules for frequency of preventive care should conform to Maryland Law.

Thank you for your correspondence to Senator Nancy King regarding the frequency of coverage for preventive dental care for the Maryland Healthy Smiles Dental Program. Senator King has asked the Maryland Department of Health (MDH) to review your concern.

MDH recognizes your commitment to Medicaid recipients and your efforts in helping Senator King pass the 2012 SB 849 legislation. MDH has reviewed the information you sent, and determined that the Dental Benefits Administrator, SKYGEN USA, is not in violation of 2012 SB 849. This legislation does not apply to the Medicaid Program; therefore, this legislation does not apply to preventive care covered by the Maryland Healthy Smiles Dental Program. MDH does allow for Medicaid-eligible children to receive dental preventive care at frequencies less than six months under the Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) program as long as they are medically necessary according to COMAR 10.09.05, Dental Services.



The Maryland Dental Action Coalition strongly supports *House Bill 547 – Maryland Medical Assistance Program – Dental Prophylaxis Care and Oral Health Exams*. The bill will provide more flexibility to Medicaid enrollees to obtain critical preventive dental services. The Maryland General Assembly already established similar flexibility for privately insured individuals through HB 1356 in 2012.

The Maryland Medical Assistance Program covers two dental cleanings (prophylaxis) and oral health exams a year in a preventative services visit. Currently, Medicaid participants must wait at least 6-months between appointments. The bill would allow Medicaid participants to obtain preventative services just 4-months after their last appointment. Total coverage would still be capped at two preventative service visits a year, but there would be more flexibility in the timing of appointments. This flexibility will help individuals and families facing challenges such as:

- Families who are trying to align the appointments of siblings;
- People with mobility challenges who need to avoid traveling in the winter to appointments;
- People facing significant family or work obligations in 6-months and need to obtain care a little earlier; and
- Pregnant women who want to schedule an appointment before their due date.

Maryland Medicaid spends over \$10 million a year on avoidable emergency room visits for dental conditions. We should take common-sense steps, such as HB 547, to make it easier for individuals to obtain regular preventative services. The Maryland General Assembly has already granted more flexibility for coverage in private dental insurance. We ask for a favorable report on HB 457, so that the same flexibility is extended to people with Medicaid. As a general dental provider for more than 30 years, I am excited about and fully supportive of this bill. Reducing the eligibility period from 180 days down to 120 days between dental exams is a useful tool to help ensure that children receive routine dental visits and that dentists receive compensation for the services provided. Because the bill does not change the eligibility for 2 visits per calendar year, there is no expected increase in costs for services provided. The bill simply reduces denials for payment when a patient is seen earlier than the current 180 day minimum period.

## TESTIMONY IN SUPPORT OF SENATE BILL 485 - MARYLAND MEDICAL ASSISTANCE PROGRAM – DENTAL PROPHYLAXIS CARE AND ORAL HEALTH EXAMS

Benevis is a dental support organization providing non-clinical support services to dentist offices in Maryland. Benevis is dedicated to its mission to improve access to dentistry by providing the highest quality non-clinical services to some of the nation's leading dental practices. In Maryland, the nine dental practices Benevis supports specialize in providing Medicaid dental services. Those practices are one of the largest providers of Medicaid dental services in the state, providing just under 20% of the Medicaid services statewide and approximately 40% of the Medicaid services in the Baltimore City region. A key part of supporting Medicaid dental practices is ensuring that patients have reasonable access to essential preventative care, and for that reason Benevis supports Senate Bill 485.

SB485 creates parity between Medicaid and private dental insurance coverage for fundamental dental services. One major challenge to Medicaid dental providers is the low "show" rate for patient appointments. This is often a reflection of scheduling, transportation and other factors that disproportionately impact Medicaid patient populations. Increasing flexibility for Marylanders facing these challenges is an important step toward increasing access to key services, particularly for families seeking pediatric care.

#### **POSITION: SUPPORT**

Chair Kelley, Vice Chair Feldman, Senator Augustine, and members of the Finance Committee, the Maryland Rural Health Association (MRHA) is in SUPPORT of Senate Bill 485 Maryland Medical Assistance Program – Dental Prophylaxis Care and Oral Health Exams.

MRHA supports this legislation that a prohibits a limit on the frequency of dental prophylaxis care or oral health exams that requires the dental prophylaxis care or oral health exams to be provided at an interval greater than 120 days within a plan year.

Rural communities suffer from chronic lack of oral and dental care services, and this legislation would increase the available number of services provided to patients that are desperately needed in these communities. It is imperative to bridge gaps in accessing these desperately needed oral and dental health services in rural Maryland.

MRHA's mission is to educate and advocate for the optimal health and wellness of rural communities and their residents. Membership is comprised of health departments, hospitals, community health centers, health professionals, and community members in rural Maryland.

Rural Maryland represents almost 80 percent of Maryland's land area and 25% of its population. Of Maryland's 24 counties, 18 are considered rural by the state, and with a population of over 1.6 million they differ greatly from the urban areas in the state.

And while Maryland is one of the richest states, there is great disparity in how wealth is distributed. The greatest portion of wealth resides around the Baltimore/Washington Region; while further away from the I-95 corridor, differences in the social and economic environment are very apparent.

MHRA believes this legislation is important to support our rural communities and we thank you for your consideration.

Dear Chair Kelley and Committee Members:

The Maryland Department of Health (MDH) is submitting this letter of information on Senate Bill (SB) 485 – Maryland Medical Assistance Program – Dental Prophylaxis Care and Oral Health Exams. SB 485 would require MDH to lift the current requirement that prophylaxis care or oral health exams be provided at an interval greater than 120 days within a plan year. The bill would take effect on January 1, 2022.

Maryland Medicaid covers dental services for children, pregnant women, adults in the Rare and Expensive Case Management (REM) Program, and former foster care youth up to age 26. Benefits for these populations are not subject to a financial cap. MDH also operates an Adult Dental Pilot Program for adults 21 through 64 years of age enrolled in both Medicaid and Medicare. Services through the Adult Dental Pilot Program are subject to an \$800 per person annual cap. MDH currently limits the frequency for certain prophylactic services to once every six months.

For FY22, MDH estimates that SB 485 would have a fiscal impact of \$2.3 million, subject to a 54% federal match (\$1.2 million in Federal funds, \$1 million in State funds). The cost for FY23 is estimated to be \$4.7 million (\$2.6 million Federal funds, \$2.2 million State funds). Costs would increase each subsequent fiscal year. MDH expects the fiscal impact will be largely due to increased utilization of services by children.
