Dear Chair Kelley and Members of the Committee,

I am writing to introduce Senate Bill 51 – Tri-County Council for Southern Maryland – Property Management – Southern Maryland Regional Agricultural Center. This bill would authorize the Tri-County Council for Southern Maryland to act as the property manager for the new Regional Agricultural Center which is currently being built in Charlotte Hall.

The Southern Maryland Regional Agricultural Center (RAC) will be a tremendous resource for the agricultural community in St. Mary's County and the four other counties throughout the region. When completed, the RAC will include a retail storefront, a commercial kitchen, fresh and frozen storage capability, facilities to cut and wrap meats, and space for educational and apprenticeship programs. The facility is an initiative of the Southern Maryland Agricultural Development Commission (SMADC), which is part of the Tri-County Council for Southern Maryland.

While St. Mary's County will own the facility, SMADC will be handing its day-to-day operations. In finalizing these arrangements, SMADC's counsel found that the law outlining the powers of the Tri-County Council did not grant them the authority to manage this property. St. Mary's County, the Tri-County Council, and SMADC all agree that SMADC should act as the property manager for the RAC. Senate Bill 51 will institute the technical change necessary to allow the Tri-County Council to act as property manager, which will in turn allow SMADC to operate the RAC, reflecting how all parties involved want to move forward and putting the statute in line with the memorandum of understanding for this project.

This bill has the support of the Southern Maryland Delegation. I respectfully request a favorable report on Senate Bill 51. Thank you for your consideration.

POSITION STATEMENT HB639/SB51 - Tri–County Council for Southern Maryland – Property Management – Southern Maryland Regional Agricultural Center February 23, 2021

The Southern Maryland Agricultural Development Commission (SMADC), a division of the Tri-County Council of Southern Maryland (TCCSMD) is asking for full support for HB639/SB51 - Tri–County Council for Southern Maryland – Property Management – Southern Maryland Regional Agricultural Center, entered by Senator Bailey and Delegate Davis. The Bill requests a minor change in the TCCSMD General Provisions that would allow SMADC, as their agricultural division, the ability to act as Property Managers for the Southern Maryland Regional Agricultural Center Maryland Center (RAC) that is being built in cooperation with St. Mary's County, and that will serve all five Southern Maryland counties and their agricultural producers.

The proposed change newly defines the term of "Property Management" to be the "entity responsible for the management and maintenance of real property, including, but not limited to, finding tenants, collecting rent, paying expenses and applicable taxes, maintaining utilities and systems, and otherwise doing what is necessary to manage and operate real property." The Bill also narrowly defines the scope of this work as being at "the Southern Maryland Regional Agricultural Center, which is owned and located within St. Mary's County." The reason for the change is that current TCC legislation places restrictions on the services that SMADC can offer at the RAC. A fully functional RAC capable of adding value to Southern Maryland agricultural and livestock products, aggregate and distribute those products, and provide instructional and regulatory-advice services has long been needed and a goal of Southern Maryland farmers. Considering the wealth of knowledge that SMADC brings to this project, it has always been the intention that St. Mary's County will own the RAC and SMADC will provide the expertise and personnel to run and manage the RAC for the benefit of the Region. To that end, SMADC must secure this amendment to the TCC General Provisions in order to be able to provide these services.

The following services will be offered at the RAC with SMADC's management:

A Regional Butcher Shop/Cut and Wrap Facility, a Finer Meats Processing Facility, creation of a Southern Maryland Meats Charcuterie Brand, Apprenticeship Programs and Job Training, a Meat Locker and Cold Storage Facility, a Warehouse and Distribution Site, a Commercial Kitchen, an Instructional Kitchen Classroom, and a product Storage Facility. It is forecast that the RAC will supply full-time employment for 17 Southern Maryland residents.

A fully operational RAC, with SMADC's expertise as programs and property manager, is vital to the continued growth of the agricultural economy in Southern Maryland. We ask that you solidly support this Bill for Southern Maryland agriculture.
