BILL ANALYSIS

Senate Bill 796 ("SB 796") requires the Maryland Office of Minority Health and Health Disparities ("Office") to collaborate with the Maryland Health Care Commission ("Commission") to publish and provide a report card to include the racial and ethnic composition of all individuals who hold a certain license or certificate, rather than only physicians. The bill requires the report card to include a comparison of certain information. Additionally, SB 796 requires the Office in coordination with the Commission and the Maryland Department of Health, to submit to the General Assembly a certain plan on or before a certain date.

POSITION AND RATIONALE

SB 796 calls for collaboration between the Office of Minority Health and Health Disparities ("Office"), the Maryland Health Care Commission ("Commission"), the Maryland Department of Health ("Department") to publish a "Health Care Disparities Policy Report Card" with information on racial and ethnical variations in insurance coverage, racial and ethnic composition of the health care practitioner population, and the racial and ethnic disparities in morbidity and mortality rates for communicable and non-communicable diseases identified as state priorities, such as cancer, diabetes, HIV/AIDS, and cardiovascular disease.

The Commission supports this bill as it aligns with our work to develop and publish more detailed and timely information on healthcare disparities. The Commission believes that reforms to the statute under SB 796 will convey the General Assembly's urgency about the data gathering and information dissemination on health disparities. The legislation will also enable the respective agencies to examine new approaches to information dissemination and to consider

new composite metrics that reflect the interplay of housing, nutrition, and transportation issues on health disparities.

On behalf of the Maryland Hospital Association's (MHA) 60 member hospitals and health systems, we appreciate the opportunity to comment on Senate Bill 796. The legislation would ensure access to better race and ethnicity data for our health care workforce by expanding the required data reporting beyond just physicians. Under SB 796 data for all licensees would be submitted to the Office of Minority Health and Health Disparities (OMHHD).

Meaningful public policy that improves health equity and builds a diverse health care workforce requires access to robust, accurate, and Maryland-specific data. Past efforts to improve data collection for health outcomes, quality, and patient satisfaction by race were not coordinated or sustainable. SB 796 rectifies this misalignment and empowers OMHHD to carry out its mission.

In the past, the focus has been to gather data to improve outcomes for patients. Less work has been done to track the racial and ethnic makeup of our health care workforce. Building a workforce that reflects the communities hospitals serve is critical to improve the health and wellbeing of all Marylanders. SB 796 requires all health occupations boards to include an optional question on new license applications and renewals and requires the boards to encourage licensees to provide this information. This data can guide programs to increase the diversity of our health care heroes.

COVID-19 makes it impossible to deny or ignore historic health disparities. OMHHD needs to have all available data to ensure the right targeted programs and policies are in place to advance the health of all Marylanders.

Senate Bill 796 is a recommendation of the Senate President's Advisory Workgroup for Equity and Inclusion and requires the Office of Minority Health and Health Disparities to prepare a revised health care disparities report card by December 31st, 2021. Bill Summary

SB 796 requires the Maryland Office of Minority Health and Health Disparities to collaborate with the Maryland Health Care Commission to publish a report card to include the racial and ethnic composition of all individuals who hold a license or certificate issued by a health occupations board.

Bill Rationale

MedStar Health is committed to advocating on behalf of patients for a better health care system and on behalf of all members of the care team to help them provide the best care possible. MedStar Health acknowledges that racial inequities create impediments to reaching those ends. Evaluating the performance of all members of the health care team and releasing the information to the public is an attempt to help consumers make better choices.

According to the U.S. Census Bureau, the nation's health-professions workforce does not nearly reflect the diversity of the nation. Racial and ethnic minorities are woefully underrepresented in the health professions. In the 2000 U.S. Census, African Americans accounted for nearly 12.7 percent and Hispanics accounted for nearly 12.6 percent of the U.S. population. This diversity is not reflected in the health-professions workforce. As the following table¹ shows, African Americans and Hispanics are underrepresented in both the nation's health professions and among those currently training to work in the health professions.

On behalf of Strong Future Maryland, we write in support of Senate Bill 796. Strong Future Maryland works to advance bold, progressive policy changes to address systemic inequality and promote a sustainable, just, and prosperous economic future for all Marylanders.

The work performed by the Office of Minority Health and Health Disparities (OMHHD) has proven to be of great importance to all Marylanders. Their mission of addressing social determinants of health and eliminating health disparities helps achieve the goal of providing health equity to all Marylanders, allowing them to access health care services and the ability to maintain good health. We believe collaboration between the Office of Minority Health and Health Disparities and the Maryland Health Care Commission (MHCC) is a positive way to hold these entities accountable for providing accessible health care to Marylanders.

Senate Bill 796 would expand the Health Care Disparities Policy Report Card to include all Maryland health occupations. Furthermore, from this report, racial and ethnic groups are drastically underrepresented in Maryland medical schools' graduating classes. To address these disparities, we implemented a four-year plan to address these issues, which further contributes to the people of color's adverse health outcomes in Maryland¹. With this foundation of reporting, the expansion of applicability to additional licensed health care occupations is necessary because physicians are not the only health care providers responsible for delivering health care services. According to the Maryland Hospital Association, Maryland employs 108,000 doctors, nurses, and caregivers, which provide care to millions of patients annually. With this information, it is evident that the Health Care Disparities Policy Report Card should include all healthcare system providers since they serve significant contributions in keeping Marylanders in good health.
