My name is Dr. Xavier Bruce and I am the Executive Director of Uplift In-Powerment based here in Frederick, MD. We focus on assisting underserved veterans by empowering and inspiring them beyond military life. The six problem areas that we focus on are fitness, awareness, connectedness, anxiety, depression, and energetic self-perception.

On behalf of Uplift In-Powerment, I would like to submit this letter of support for the proposed CAM for Veterans Grant Program. In addition, some of our chapter members are disabled veterans who suffer from PTSD and would greatly appreciate alternative treatments.

Many have given their lives and/or endured permanent pain and suffering while protecting our beloved country. Financial assistance for alternative

treatment will show these special veterans that our community cares about them. Please accept this letter of support for your proposed bill from our organization.

In 2013, the United States Department of Veterans Affairs released a report that from 1999 to 2010, tragically, 22 veterans a day in the United States were dying by suicide. This is a heartbreaking and tragic statistic about the brave men and women who have served our country.

David Perez was a Marylander, Veteran, and patriot with a big heart. He served in the United States Army for 11 years, he was a combat vet, and after he served his country he decided to dedicate his life to helping other veterans who served with their challenges from time served in the Military. Sadly, in the fall of 2020 David's own challenges from his time served caught up with him, and we tragically lost him way too soon. I am tired of hearing stories of so many of our veterans leaving us way too soon , and it is time to try and do something about this.

Our Combat veterans in Maryland and across the Country are struggling with stress, depression, and PTSD from their time served. A 2020 Baltimore Sun article reported that military suicides jumped by as much as 20% for 2020 compared to the same period in 2019. The increase is even greater for suicides among active duty soldiers. Those deaths were up 30% in 2020, rising from 88 last year to 114 this year as a result of Covid 19 restrictions in the US.

This bill has 2 main objectives: 1. To honor the work of what Mr. Perez did, and to keep his memory, dedication, and passion for this issue alive. 2. To help our struggling veterans in our State receive assistance for alternative forms of treatment for their time serving our country. We hope that these forms of treatment make them feel better about themselves, and raise them up, not tear

them down. Our veterans in Maryland have made the ultimate sacrifice and have fought for our freedoms. Let's do all that we can in Maryland to fight for them!
