I am writing as a follow up to our October 8, 2020 meeting which included yourself, Mr. Frank Dickson, Director of Strategic Business Initiatives for the State of Maryland and my senior staff which included the Director of Planning, Mr. Shane Grimm, the Director of Administration, Patrick Sypolt, Technical Advisor for Special Projects, Mr. Ben Martorana and my Chief of Staff, Mr. Steve Gamatoria.

At the meeting, you presented a PowerPoint presentation that included a summary of the Cushman and Wakefield study. While I appreciate the summary that was presented, I am hopeful that you can relay the full report (or at least a copy of the summary slides that were presented).

My senior staff was most encouraged by your comments relative to "incorporating the City's guidance and desire," to shift away from "highest and best use", but instead to address those City-wide goals which will (a) "maximize the historic charm of Havre de Grace", (b) "be the most appropriate use for the City", (c) create the development plan to comply within the current HDG Zoning, and (d) incorporate the Administration's outlook for addressing the "desires and concerns of the community" and "meet the goals of economic development AND community benefit."

I am also encouraged that Mr. Frank Dickson, State Director of Strategic Business Initiatives, was assigned to assist you in advancing our community goals and objectives.

With the holidays behind us, I encourage you to please reach out to either my Chief of Staff, Mr. Steve Gamatoria or specifically to my Director of Planning, Mr. Grimm to continue discussions and exchange thoughts on the redevelopment of the Harford Memorial site.
