**TITLE: Health Care Practitioners – Telehealth – Out-of-State Health Care Practitioners**

**BILL ANALYSIS:** This bill authorizes out-of-state health care practitioners to provide telehealth services to patients located in Maryland, provided the health care practitioner is licensed and in good standing in another state and registers with the appropriate health occupations board in Maryland. The bill further sets forth the requirements an out-of-state practitioner must meet in order to register with the relevant board, including completion of an application, completion of a criminal history records check, and payment of a fee. The bill establishes that an out-of-state health care practitioner must practice in accordance with the laws, rules, regulations, scope of practice, and standard of practice set forth by the appropriate board; provides a mechanism for potential discipline of an out-of-state practitioner registered to practice telehealth in Maryland; and requires each board to publish information regarding out-of-state practitioners registered with the board.

**POSITION AND RATIONALE:** The Maryland Board of Professional Counselors and Therapists (the “Board”) supports HB 732 with an amendment stating it does not apply the Board. The Board is comprised of five professional disciplines namely professional counselors, alcohol drug counselors, marriage and family therapists, art therapists, and behavioral analysts. The training requirements across disciplines varies widely by state and type of credential. Therefore, the credentials between states and discipline do not typically match up. Additionally, there is no widely accepted national organization that structures education and training in the field across disciplines. Accordingly, although it supports the intent and aims of HB 732, the Board respectfully requests an amendment that the bill does not apply to Health Occupations Article, Title 17, which governs professional counselors, marriage and family, behavioral analysts, art therapy, and alcohol and drug therapists.

**Amendment Number 1:**

On page 6, in line 12, after “1996,” insert:

“(8) THIS SECTION DOES NOT APPLY TO PROFESSIONAL COUNSELORS, MARRIAGE AND FAMILY THERAPISTS, ART THERAPISTS, BEHAVIORAL ANALYSTS, AND ALCOHOL AND DRUG THERAPISTS IN ACCORDANCE WITH TITLE 17 OF THIS ARTICLE.”

**Amendment Number 2:**

On page 13, strike lines 12 through 29, beginning with “17-301” and ending with “TELEHEALTH.”
