14th Amendment to the United States Constitution, Section 3:

No person shall be a Senator or Representative in Congress, or elector of President and Vice President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

Prince George's County, MD - The Prince George's County Young Democrats urge all members of the Prince George's County Council, municipal leaders, and the Maryland General Assembly, particularly the Prince George's County Delegation, to support the following:

- **Impeachment of President Donald Trump, for violating the 14th Amendment of the United States Constitution.**
- **House Resolution 25. Sponsored by Congresswoman Cori Bush (MO-1)**
 - This legislation will investigate and expel the GOP members of Congress who attempted to overturn the election and incited a white supremacist attack, under Section 3 of the 14th Amendment. This list of individuals includes Maryland Congressman Andy Harris and Senators Ted Cruz & Josh Hawley.
- **Investigation into all sitting elected officials in the state of Maryland, state employees, and state/local police officers regarding their involvement in planning, providing transportation to/from, or participation in the acts committed in the white supremacist coup attempt on January 6, 2021.**
 - Any sitting elected officials, state employees, state/local police officers in our state who, among other acts, provided transportation to and/or from the Capitol; incited an attack on the Capitol via digital means; or otherwise provided tacit support for the white supremacist coup attempt.
- **Immediate resignation or expulsion of Delegate Dan Cox, a sitting member of the House Judiciary Committee, and all sitting state legislators involved in the white supremacist coup attempt on January 6, 2021.**
- **Immediate resignation or expulsion of Delegate Mary Ann Lisanti.**
 - In January of 2019, news reports exposed that Delegate Lisanti, while talking with several legislators in Annapolis, referred to Legislative District 25 as a "nigger district". She was censured on February 28, 2019 and refused to resign. Given that she has refused to resign and has since been reassigned to the Ways & Means Committee, she should be expelled from the legislature for conduct unbecoming of a legislator, displaying a clear hostility towards constituents, and inability to govern in an unbiased, fair manner.
- **Immediate resignation or expulsion of Congressman Andy Harris, Senators Ted Cruz & Josh Hawley, and all other federal/state/local officials & state employees, including state/local police across the nation involved, for violating the 14th Amendment of the United States Constitution.**
