Position Statement House Bill 1252 – Income Tax – Credits for Preceptors in Areas with Health Care Workforce Shortages Ways and Means Committee February 26, 2021

The Rural Maryland Council **Supports with Amendments** HB 1252 – Income Tax – Credits for Preceptors in Areas with Health Care Workforce Shortages. In 2016 Legislation passed for the Preceptor Tax Credit Program. This Program authorizes a credit against the State income tax for individuals who have served as a preceptor in certain preceptorship programs and work in certain areas of the State with a health care workforce shortage.

A preceptorship program means an organized system of clinical experience that for the purpose of attaining specified learning objectives pairs either 1) a Medical student in a Maryland medical school with a licensed Physician who meets the qualifications as a preceptor, or 2) a Nurse Practitioner student enrolled in a nursing education program that is recognized by the State Board of Nursing with a Nurse Practitioner or licensed Physician who meets the qualifications as a preceptor. Presently under this Program, Physician Assistants are not included for the tax credit. Physician Assistants are academically prepared and highly skilled health care professionals who provide a broad range of medical services in different clinical settings, under the supervision of a Physician. The Credit would also be going to preceptors who are participating in these preceptorships with no compensation. The Council would like to see this Tax Credit Program include Physician Assistants.

Rural Maryland has previously had a shortage of workers in healthcare, which has only worsened during the COVID-19 pandemic, with facilities in rural parts of Maryland being overrun by the virus. In addition to a healthcare workforce shortage, Rural Marylanders are overall older and in worst health than their suburban counterparts. By extending the tax credit to Physician Assistants who participate as a preceptor in certain preceptorship programs and work in certain areas of the State with a health care workforce shortage, it would promote more healthcare practitioners to become preceptors in preceptorship programs, allowing more students to fulfill the requirements needed to enter the healthcare workforce in the regions that need them the most.

The Bill will also extend Chapter 385 and 386 of The Acts of 2016. This would allow for these tax credits to be distributed to certain preceptors participating in certain preceptorships who work in certain areas of the State with a health care workforce shortage past the current end date of June 31, 2021. The Senate's Budget and Taxation Committee recently gave a favorable report to this bill's companion. The Council supports the amendments added and for this bill to be amended to match the language of the companion bill. The Council respectfully requests your favorable **support with amendments** of HB1252.
