(3) OTHERWISE PENALIZE THE APPLICANT IN ACCORDANCE WITH THE STATUTES AND REGULATIONS GOVERNING THE PROGRAM FROM WHICH THE FINANCIAL ASSISTANCE ORIGINATES.

<u>2-904.</u>

PROGRAMS SUBJECT TO THIS SUBTITLE SHALL PROVIDE FINANCIAL ASSISTANCE TO QUALIFYING SOLE PROPRIETORSHIPS AND SMALL BUSINESSES WITH ONE OR MORE EMPLOYEES THAT ARE IN GOOD STANDING.

SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly that Subtitle 9 of the State Finance and Procurement Article shall apply to existing programs authorized in response to disasters that provide financial assistance to small businesses. Existing programs shall allow sole proprietorships and small businesses employing one or more employees to apply for financial assistance in accordance with Subtitle 9.";
