**Higher Education – Returned Peace Corps Volunteers – In-State Tuition**

Dear Chair McIntosh, Vice Chair Chang, and Members of the House Appropriations Committee,

As President and CEO of the non-governmental, non-profit National Peace Corps Association (NPCA), I write to urge your support for passage of House Bill 087 (and Senate companion Bill 050).

If approved and signed into law, Returned Peace Corps Volunteers (RPCVs) would be treated the same as military personnel, Americorps volunteers, and others who are exempt from the residency requirement upon returning to Maryland and seeking in-state tuition to further their education.

This common sense fix to the residency requirement is long overdue. It is obvious that RPCVs could not have resided in Maryland as their service to our nation involves living and working overseas.

Since 1961, more than 6,500 Maryland residents have been among the nearly quarter million individuals who have served our nation as Peace Corps Volunteers, working to advance peace, friendship, understanding, and collaborative assistance in 142 foreign countries.

After serving for two (or in some cases, three) years overseas, RPCVs come home with a variety of skills and experiences that benefit our state and the communities where they reside. We are proud that the spirit of service to others remains a lifelong commitment for a vast majority of Peace Corps community members.

For many, Peace Corps service results in a change in an RPCVs career path. A 2011 survey of the Peace Corps community found that at that time, a large number of volunteers who had served in the 2000s entered the fields of education and teaching, health care, and/or nonprofit work following their service. For these individuals, that likely meant additional education and training.

Peace Corps service is a financial sacrifice. Volunteers are paid for their work while in service, but paid at a rate commensurate to that received by host country nationals. This results in most if not all of their income while in service being used to cover everyday expenses.

The Peace Corps does provide volunteers with a “readjustment” allowance, a payment that accumulates each month and is set aside for volunteers at the end of their service. Recent volunteers' readjustment pay amounted to roughly \$8,000. However, having been away from home for more than two years, these funds are needed for RPCVs to reestablish themselves as they prepare for the next step in their career path. This allowance is needed and used to cover everything from rent, transportation, health care and food, to new clothing, laptops, and cell phones. Additionally, many younger RPCVs also need to resume repayment of student loans.

For these reasons and more, I join other members of the Maryland Peace Corps community in thanking you for your service to our state, and to respectfully ask you to make sure that House Bill 087 is reported favorably out of committee and approved by the House.
