On behalf of the Board of Directors of Preservation Maryland and our thousands of statewide supporters, I would like to offer our support of SB928 and our belief in the value of investing in humanities organizations statewide. Through their Maryland History Day, Museum on Main Street, and One Maryland One Book programs, Maryland Humanities reaches more than a quarter million people annually, and this legislation would help them further expand their reach by directly supporting local humanities organizations across the state.

#### SUPPORT FOR THE SHINE GRANTMAKING INITIATIVE

Preservation Maryland enthusiastically <u>supports SB928</u>, which establishes the Strengthening Humanities Investment in Nonprofits for Equity (SHINE) Grantmaking Initiative program and funds it at \$500,000 beginning in FY24. Through their Maryland History Day, Museum on Main Street, and One Maryland One Book programs, Maryland Humanities reaches more than a quarter million people annually. This legislation before you today would help them expand their impact and reach even further by directly supporting local humanities organizations throughout Maryland.

Maryland does not have a central state museum and has instead previously invested in its network of small community-based museums to better tell the full history of the state and its diverse stories. Historic and cultural museums operate in every Maryland county. Unfortunately, for nearly a decade, the primary state museum support program, the Maryland Historical Trust's Museum Assistance Grant, has gone unfunded. Without that program, these museums are struggling, and many are desperately fighting for survival, especially in the wake of the Covid-19 pandemic. Rural and urban museums alike are suffering from a lack of support, especially operating support.

For the last 50 years, Maryland Humanities has been a key partner with a history of successful grant making within the state's humanities community. In addition to their usual annual programming, over the past 18 months, Maryland Humanities has also awarded \$1.425 million in federal COVID-relief funds to 136 organizations, reaching every county and Baltimore City with much-needed operating support. Beginning this year, they will exclusively award general operating support grants to Maryland nonprofits, making them one of the first nonprofit state humanities councils nationally to do so. The SHINE Grants Initiative would allow them to continue offering this much needed operating support to local organizations who may not

qualify for other state funding from the Maryland State Arts Council, Maryland Historical Trust, or Maryland Heritage Areas Authority.

Maryland Humanities is often one of the only options for these important cultural institutions that preserve and interpret Maryland's vast and varied history. Operating support is essential to the organizations' survival but is often not provided for in other grant programs. Indeed, operating support is one of the primary unmet needs for museums and cultural institutions. With passage of this bill, Maryland Humanities will be able to sustain their expanded general operating grantmaking for more than just one year. SHINE will focus on small and mid-size humanities, arts, cultural, and educational nonprofits that may not have staff capacity or resources to be competitive in fundraising, either from government programs or other private funders. This focus on under-resourced organizations will have a positive impact in many communities across the state, allowing grantees to employ grant funds where the need is greatest for their work and those they serve.

Providing funding to these organizations is not solely altruistic. Tourism supports 143,000 jobs in Maryland – and generates over \$2.3 billion in state and local tax revenue. A major component of Maryland's tourism industry is heritage tourism – visitors looking to experience the state's rich heritage. The funding through SB928 could invest in the resources that cater to these lucrative visitors. Heritage tourists stay longer and spend more than any other category of tourist. Similar state investment in heritage tourism resources, through the Maryland Heritage Areas program, has provided a 4:1 return on the state's investment. With SHINE grants, non-profit history and humanities organizations could invest in their historic resources and move beyond 'starvation level' operations to engage new audiences and raise additional private dollars to support their evolving missions.

We encourage you to support this initiative because it is unique in addressing an unmet need faced by hundreds of nonprofit organizations throughout the state. The program would allow grantees to utilize grant funds where the need is greatest for their work and for those they serve, thereby allowing currently under-resourced organizations to have a positive impact in communities in every corner of the state.

We respectfully request a favorable report on SB928 and thank you for your consideration.

# Senate Budget & Taxation Committee Testimony from Maryland Humanities re: SB928 March 16, 2022

Maryland Humanities offers this testimony in support of proposed SB928, sponsored by Senator Guzzone. This bill would provide an annual appropriation of \$500,000 for our SHINE Grantmaking Initiative, which stands for Strengthening Humanities Investment in Nonprofits for Equity.

This is a groundbreaking new effort that revitalizes our grants program in our 50<sup>th</sup> anniversary year, providing for an exponential expansion of available funding to eligible cultural, arts, and educational nonprofits with a focus on offering public humanities programming.

Incorporating years of feedback from nonprofit organizations and lessons learned in distributing \$1.425 million in federal COVID-relief funding, Maryland Humanities will shift all of its grantmaking beginning this year from project-based to general operating support.

Nonprofit organizations have long advocated for general operating support, placing the power of determining where funds are most critically needed in the hands of recipients as opposed to funders. This is a critical step in our commitment towards creating greater equity in access to our programs and grants across the cultural sector in Maryland.

With the successful enactment of this bill, we will re-grant this funding in its entirety each fiscal year, guaranteeing at least a half-million dollar investment back into communities throughout the state. Personnel and administrative costs for running the SHINE program will be covered through other sources. This investment by the State in SHINE will allow us to:

- Focus on small and mid-size humanities, arts, cultural, and educational nonprofits that may not have staff capacity or resources to be competitive in fundraising.
- Ensure a broad geographic reach.
- Evaluate applicants and distribute funds equitably, while ensuring accountability and responsible fiscal stewardship.
- Convene annual cohorts of grantees in new networks of engagement and common purpose to amplify the state's investment, strengthening both the organizations and communities.
- Respond to the unmet needs of hundreds of organizations that may not qualify for other funding from Maryland Historical Trust, Maryland Heritage Areas Authority, or Maryland State Arts Council.

We respectfully ask the members of the committee to approve SB928 and help ensure its passage this legislative session.

Dear Chairman Guzzone and Members of the Budget and Taxation Committee, As a small nonprofit, highly dependent on grants these past two difficult years, we strongly support SB928 to extend the State of Maryland's investment in Maryland Humanities' new SHINE grantmaking initiative into FY24 and beyond.

General operating support has enabled us to continue serving our audience – children and their families and the agencies / organizations that also serve them, primarily through keeping our small staff employed. Our current projects, for the most part, are not income-earning. For example, we have added elements to the park surrounding our building to encourage outdoor explorations by local families. We are becoming skilled at creating online programming and have been able to stretch our geographic reach far beyond Maryland, particularly to Girl Scouts across the country.

The Maryland Women's Heritage Center has several times been a recipient of MD Humanities Funds:

- My organization received \$10,000 in Dec. 2021 from COVID-relief funding in 2020/2021. With that funding, we were able to support some operations in of monthly expenses, converting programs to virtual platforms as well as adapting more materials development for website usage. Much of this work is done by volunteers. We also received a smaller amount early in COVID under CARES act in 6/20 for \$5050. That also helped us in the early days of operations soon after our move into the new location at Marian House/ Women's Industrial, 333 N. Charles St in Baltimore. We were also granted \$7250 in June of 2021.
- We were granted \$2000 in Jan. 2021 to provide a program related to the importance of Voting rights and in history. In our case we covered new research involving women in MD in the suffrage movement.
- With additional funds (6/21), we developed the Valiant Maryland Women: The Fight for the Vote APP. We provided the volunteers to develop the content, research and script for the tech developer. The \$7500 was used to pay Timelooper to develop this unique APP that will be distributed to schools and around the state in the Spring 2022.
- My organization has partnered with Maryland Humanities for 8+ (?) years in presenting Women's history events and activities. The MWHC has provided a Women's History Award/scholarship to a student annually as part of the MD History Day. During the following year, we present a program with the winning student and their research.
- I have heard first-hand how impactful Maryland Humanities' grants/programs are for local grantee supports like the MWHC; portable exhibits, the Chautauqua events like the one we participated in Summer of 2021 as well as the comprehensive MD History Day.
- Our organization knows other organizations who know how scarce opportunities for general operating support are and would benefit greatly from being a SHINE recipient. Like many small non-profits, our donations continue to be down and there are limited other grants for us to apply for in the past, especially those that are eligible for operational supports. We are very bare bones, and we are very concerned where else to cut. We are leasing from another non-profit and have a very reasonable rent, but in the long run it too may have hard to sustain. Our type of work is difficult to only operate virtually, and our space is critical to Maryland visitors and students. We do have, however, our goal to still be operation to provide educational opportunities, programs and resources in our case, Maryland Women's History.

Without these critical funds over the past two years, we may NOT have been able to stay operational and productive for MD citizens. Looking at both program support and CARES/SHARP operational support, MD Humanities granted MWHC over \$24,000. We are so appreciative of the federal and state legislative and funding support.

As an organization dedicated to the preservation, promotion, and interpretation of the cultural, historic, and natural resources of Maryland's Eastern Shore, it gives Eastern Shore Heritage, Inc. immense pleasure to support Senate Bill 928 which will extend the State of Maryland's Investment in Maryland Humanities with a new "SHINE" grant initiative to support small non-profits working in the humanities.

As the Executive Director of the Stories of the Chesapeake Heritage Area, I work with multiple small nonprofit organizations many of which are entirely run by volunteers or by one full or part time staff. On behalf of the Board of Director and Stakeholders of Sumner Hall (G.A.R. Post #25, Inc.), I wish to submit this letter in support of SB928, a critical bill that will power SHINE, the new grantmaking initiative of Maryland Humanities.

Since our historic building was saved from the wrecking ball and re-opened to the public in 2015, our hard -working volunteer Board of Directors has been dedicated to making Sumner Hall a viable, self-sustaining organization. We are proud of our specific programs and initiatives funded by targeted donations and that our membership is increasing. However, we have not yet been able to raise enough non-targeted funding to reliability cover all of our operating costs and the part time paid person we need to be fully sustainable.

The funds that Sumner Hall received from Maryland Humanities' CARES and SHARP programs (\$15,000), along with a similar grant from the Maryland Heritage Areas Authority (\$20,000), allowed us to survive during the pandemic because we could use those funds to pay operating costs, including part-time staff.

That investment in our organization allowed us to continue to run our grant-funded and specially funded projects. These included: (1) raising \$100,000 in community donations to feed the poor elderly and children in Kent County; (2) adding to our children's library of texts on African American History and Culture and organizing our nearly 1,000 volumes into themed book boxes that we loan to classroom teachers; and (3) completing our three-year research project on African American veterans from Kent County.

Grants that organizations can spend on general operating costs are very important. We endorse this bill that will enable Maryland Humanities to provide the funding outlined in the SHINE grantmaking initiative. It is a solid formula for investing in Maryland's non-profit organizations in a way that will help them become sustainable entities.

Sumner Hall has appreciated its relationship with Maryland Humanities throughout the years. In addition to the CARES and SHARP grants, we were awarded a Smithsonian Museum on Main Street project in 2017 which came with many hours of Maryland Humanities' staff support that contributed to our very successful community-wide celebration of *The Way We Worked in Kent County*. Maryland Humanities is really in tune with the needs of small nonprofits across the state.

We believe that the proposed SHINE initiative will pay big dividends in our State. Helping small nonprofits cover their basic operating costs, freeing them to spend their volunteer time and energies on programs that directly serve their stakeholders, clients and communities. When an organization's initiatives, programs and projects are deemed valuable, it can raise its profile and broaden its funding base that, in turn, will lead to its sustainability.

STATEMENT OF INFORMATION

**DATE: March 16, 2022** 

**COMMITTEE:** Senate Budget & Taxation

**SUMMARY OF BILL:** SB 928 mandates an annual appropriation in the amount of \$500,000 to the Department of Planning to be used as a grant to the Maryland Humanities Council for the Strengthening Humanities Investment in Nonprofits for Equity (SHINE) grantmaking initiative.

**EXPLANATION:** The Department of Budget and Management's focus is not on the underlying policy proposal being advanced by the legislation, but rather on the annual mandated appropriation of \$500,000, which impacts the FY 2024 budget and subsequent budgets. The FY 2023 Budget allocates \$500,000 for this purpose.

DBM has the responsibility of submitting a balanced budget to the General Assembly annually, which will require spending allocations for FY 2024 to be within the official revenues estimates approved by the Board of Revenue Estimates in December 2022.

Changes to the Maryland Constitution in 2020 provide the General Assembly with additional budgetary authority, beginning in the 2023 Session, to realign total spending by increasing and adding items to appropriations in the budget submitted by the Governor. The legislature's new budgetary power diminishes, if not negates, the need for mandated appropriation bills.

Fully funding the implementation of the Blueprint for Maryland's Future (Kirwan) will require fiscal discipline in the years ahead, if the State is to maintain the current projected structural budget surpluses. Mandated spending increases need to be reevaluated within the context of this education funding priority and the Governor's tax relief proposals.

Economic conditions remain precarious as a result of COVID-19. High rates of inflation and workforce shortages may be short lived or persist, thereby impacting the Maryland economy. While current budget forecasts project structural surpluses, the impact of the ongoing COVID-19 pandemic continues to present a significant budgetary vulnerability. The Department continues to urge the General Assembly to focus on maintaining the structural budget surplus.
