House Bill 897 would authorize the Maryland Stadium Authority (MSA) to issue up to \$200 million in bonds for construction of a Sports Entertainment Facility. A Sports Entertainment Facility means a structure or other improvement in the State at which minor league or other non-major league sporting events are held. It does not include a facility at Camden Yards, a facility related to professional major league sports, or a high school, collegiate, or recreational venue.

As amended in the House, the bill also creates the Prince George's County Blue Line Corridor Facilities Fund and the Major Sports and Entertainment Event Program and Fund. The Blue Line Corridor Facilities Fund would be a revolving loan fund of up to \$400 million for construction of a convention center, amphitheater, or other functionally related structures in the area adjacent to FedEx Field. The Major Sports and Entertainment Event Program and Fund would be used to attract major events to Maryland, attract attendees to fill the seats, provide media coverage, and create a positive economic impact for Maryland.

Currently, three of the Orioles minor league franchises are located in Maryland, and the facilities in which they play must also be updated regularly to meet current Major League Baseball requirements. There are other existing and future facilities across the state that could benefit from Maryland Stadium Authority assistance and construction management.

The MSA would be authorized to finance and manage such projects after it receives a written request from the county in which the Sports Entertainment Facility is located or will be located. The request must include information about the location, non-MSA funding, and the planned use of the facility. If approved by the Board of Public Works (BPW), the MSA and the hosting county would enter into a written agreement regarding the source and method of funding, and an agreement from the county to own, market, promote, and operate the facility in a manner that maximizes the facility's economic return and to maintain and repair the facility in top condition. The Major Sporting and Entertainment Event Program and Fund would further support events at these and other venues throughout Maryland.

The Greater Baltimore Committee (GBC) strongly supports this legislation because it would allow facilities located in counties across Maryland to benefit from MSA financing and construction management, without having to enact legislation for each and every project. Despite this authorization, the MSA would not be able to unilaterally take on new projects. Once the MSA Board approves a project, it would still need to be reviewed by the General Assembly's fiscal committees and approved by the Board of Public Works, ensuring thorough oversight of the decision.

The MSA has an exemplary record of successful construction projects on stadiums, schools, conference facilities, and performing arts venues, among others. It consistently delivers projects quickly and within budget. Creating a permanent financing fund to assist counties who want to renovate or develop sports entertainment facilities will generate economic activity throughout the state, increase local and state tax revenues, and benefit the communities in which the facilities are located. The new Event Program Fund will magnify the benefits of the new facilities.

This bill is consistent with two of the key tenets in *Gaining a Competitive Edge: Keys to Economic Growth and Job Creation in Maryland*, a report published by the GBC that identifies eight core pillars for a competitive business environment and job growth:

Strategic and effective state investments in business growth. The state must commit to substantive strategic investments, leveraged with capital assets, to nurture business and job growth. Investments should include competitive and effective tax credits, business development incentives, and tactical initiatives to nurture private investment in industry growth.

Government leadership that unites with business as a partner. Maryland leaders must set a welcoming tone that communicates positive support for business, respect for the private sector as a partner, not an adversary, and reflects a strategic plan for business growth and job creation.

Creating a financing fund to help counties invest in sports entertainment facilities by partnering with the Maryland Stadium Authority without requiring legislative action for each individual project will provide benefits across the state.

For these reasons, the Greater Baltimore Committee urges the Committee to give House Bill 897 a favorable report. The Prince George's County Blue Line Corridor Fund provides an opportunity to expand commercial activity near FedEx Field resulting in greater revenue and economic impact in the region.

Good afternoon, Chair Guzzone and Vice Chair Rosapepe and honorable members of the Budget and Taxation Committee, I am Thomas Kelso, the Chairman with Michael J. Frenz, the Executive Director of the Maryland Stadium Authority (MSA) and we appreciate the opportunity to provide this written Letter of Support for HB 897 Economic Development – Sports Entertainment Facilities and Events, Prince George's County Blue Line Corridor Facilities, and Racing Facilities

To further establish Maryland as a premier destination for sports, HB 897, through the MSA, authorizes MSA to issue up to \$200 million to fund the development and /or renovations of sports entertainment facilities across the state including minor league ballparks where renovations will be necessary in order to maintain affiliations with major league teams and continue to play ball in our state. Proceeds allocated from the Maryland state lottery, up to \$25 million annually, would be used to pay debt service on the bonds issued to finance the various projects. This new fund also could be utilized by other sports entertainment venues such as equestrian centers, multi-use sports complexes and now venues for youth and amateur sports tournaments.

With the amendment to this bill, recreational facilities are eligible for funding if an economic and feasibility study demonstrates positive economic impact to the State of Maryland. The amendment also creates a one-time \$10 million Major Sports and Entertainment Grant funded from the state lottery to support Maryland's efforts to attract and retain world-class sporting events such as the Baltimore-Maryland FIFA World Cup 2026 bid, the CIAA tournament, BMW Championship, Army-Navy game and Ironman events. Of note, \$10 million is the initial deposit, thereafter an annual appropriation for the amount is needed to return it to that level.

Sports tourism is a major component of Maryland's tourism and travel industry. In the post-COVID recovery, sport tourism was amongst first in the travel industry to return, in particular youth and amateur sports that generates over \$225 million in direct spending annually for Maryland's economy.

The beloved minor league ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf offer year-round budget-friendly family entertainment and inspire economic development in those six counties in Maryland. These minor league teams provide benefits to their communities and promote synergies between the Orioles and their Maryland-based affiliates. According to the Major League Baseball Research Data Portal, since 2005, there have been 14.3 million visitors to Maryland communities through Orioles minor league operations. The minor league ballparks, and other sports and facilities across the state create jobs and generate visitor spending with the resulting tax revenues reinvested to fund essential citizen services and improve Marylander's quality of life.

In closing, HB 897 Economic Development – Sports Entertainment Facilities and Events, Prince George's County Blue Line Corridor Facilities, and Racing Facilities, further elevates Maryland as a sports and entertainment destination by investing in our facilities to maintain our professional teams, support Maryland's attraction and retention of major sports events, promote healthy lifestyles and create business opportunities across the state for years to come.

For the reasons expressed in this letter, we respectfully request a favorable report on HB 897.

Dear Delegate McIntosh and Appropriations Committee,

My name is Terry Hasseltine and I am the President of the Sport and Entertainment Corporation of Maryland. I am writing on behalf of the Sport and Entertainment Corporation of Maryland today - an organization that represents and supports several major events in Maryland. As we continue to battle the effects to COVID-19, we recognize that any support for Camden Yards will be a huge benefit to our sports eco-system. We urge you all to support increasing the debt cap listed in HB 896 as well as the joint legislation, HB897 as amended.

In order to address the long-term future of the stadiums legislation was introduced to increase the debt cap from \$235 million to \$1.2 billion. Companion legislation was also introduced to create a \$200 million fund to promote the development of sports entertainment facilities across the state, including minor league stadiums and other critical sport tourism facility assets. These minor league teams and facilities provide economic benefits to communities and promote synergies with professional teams and major event opportunities.

With the ballpark upgrades now required by the recent reorganization, Maryland's minor league teams will maintain their big league affiliations' and continue to play ball in our state. The minor leagues serve as a year- round training hub for professional baseball and creates a robust pipeline of talent for the majors. The ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf offer year-round budget-friendly family entertainment and generate economic impact in those six local communities in Maryland.

HB 897 Sports Entertainment Facilities Act of 2022, through the MSA, is an initiative to help fund the much needed capital improvements at the many sport tourism assets across the state that are critical to our efforts to bring major events to Maryland to spur our economy.

With the amendments proposed, we can expand opportunities in those facilities as well as grow and support other opportunities outside of just baseball like; soccer, equestrian, cycling,







softball, rugby, golf, cricket and lacrosse to name a few. Senators Guzzone and Rosapepe and Members of the Budget and Taxation Committee,

My name is Matt Libber, and I am the Executive Director of the Maryland SoccerPlex and Adventist HealthCare Fieldhouse in Montgomery County. I am also currently the Chair of TEAM Maryland, the sports marketing collective of the Destination Marketing Organizations (DMOs) within Maryland, as well as serve on the Board of Directors for the Sports Events and Tourism Association (SportsETA), the trade group for sports tourism organizations. Wearing all three of these hats provides great perspective on the impact that House Bills 896 and 897 would have on the economy of Maryland, and we urge you to support both House Bill 896 and 897, as amended.

Tourism is a major part of the Maryland Economy and affects every part of the State, from the mountains of Garrett County, to the I-95 Corridor, and to the communities on the Eastern Shore and Ocean City. Sports tourism is major component of the tourism industry. In the post-COVID recovery, sport tourism was the first industry to return, which, in turn, touches so many other businesses in the hospitality and retail sectors. Sports travelers, event organizers, and venues spent \$45.1 billion in 2019, which generated \$103.3 billion in business sales when including indirect and induced impacts, according to a 2020 report from Tourism Economics. In Maryland, youth and amateur sports generates over \$225 million in direct spending for our economy. Investments by the State in sports tourism pays itself through the economic impact and development around sports events. For every \$1.00 spent on tourism advertising \$31.00 flows back into the State Economy. The funding for major events in this bill is important for Maryland to stay on top of an extremely competitive market. Cities and states around the United States have seen the importance of sports tourism and the economic benefits that come with these types of events. Providing the Maryland Sports Commission with the resources to attract major events such as the FIFA World Cup, Army - Navy Game, America's Cup racing, and Major League Baseball's All-Star Game sets us apart from other destinations. These marque events themselves turn into promotional assets showcasing Maryland to the rest of the country and the world.

This pair of bills allow Maryland to remain at the forefront of a highly competitive market. Allowing the Stadium Authority to make additional investments in our professional stadiums help showcase the State to the larger sports market. Providing funding for investment in the creation of new sports venue assets, improvements to existing assets, and attracting new events to the State will provide our communities across the State to continue the work they have already done to bring world class sporting events to Maryland.

Members of the Maryland General Assembly,

Thank you for your consideration of the legislation before you, House Bill 897, Sports Entertainment Facilities Act of 2022. As you know, the game of baseball is modernizing rapidly, and many local municipally owned stadiums are being forced to improve and upgrade their player development and fan-facing resources to meet the demands of the modern game. The Maryland Stadium Authority, acting on behalf of many facilities facing these challenges, has the support of the Aberdeen IronBirds, Advanced-A Baltimore Orioles affiliate, located in Harford County. As we celebrate our 20<sup>th</sup> anniversary of the field's first game this year, there are many ways in which it will need to adapt and change for our next two decades along with our municipal partner, the City of Aberdeen.

During our stadium's time in Aberdeen, it has been a source of player development for future stars in Camden Yards and across Major League Baseball, as well as a source of employment and tax revenue, but most importantly Ripken Stadium is a community gathering place for entertainment, celebration, public need, and making memories as a family right here in Harford County, Maryland. To continue contributing in these capacities as baseball changes, much about the facility can be improved for the public good and for the good of the game. The IronBirds are appreciative of the state's previous assistance with improving the facility, including safety railing, synthetic turf, and sports lighting, and hopeful for future improvements.

As the owners of the facility, the City of Aberdeen recently had an assessment conducted by engineering firm EwingCole. The assessment acted not only as a measurement of the condition of the stadium's systems and structures, but also of its compliance with Major League Baseball facility requirements. The assessment revealed many areas where the features of the facility do not meet the expectations laid out by Major League Baseball. A pool of financial resources as proposed in HB 897 would undoubtedly be a source of relief for a small municipality and us as their tenant in completing these necessary changes. The IronBirds are intent on continuing to support local professional minor league baseball in this public facility, in both entertainment and economic capacities, and appreciate the support afforded by the MSA, the General Assembly, and the people of Maryland.

On behalf of our team's ownership, the Ripken family, we ask that you make HB 897 a component of protecting Maryland's legacy in the game of baseball as well as the resources of its communities.

With the economic impact, prestige, and civic pride of being home to the Baltimore Orioles Single-A Affiliate, the Delmarva Shorebirds, players and personnel support numerous non-profits, schools, churches with service on local boards, donations, fundraisers, and appearances in the community throughout the year. Annually we raise funds and make monetary donations to area non-profits through our Fly Together Fund at the Community Foundation and donate thousands of tickets to families that may not otherwise be afforded the ability to attend a professional baseball game.

According to MLB Research Data Portal home game attendance numbers for the Delmarva Shorebirds, the team brought 3.2 million visitors to Salisbury, Md 2005 - 2019. In addition, our nongame day stadium usage draws tens of thousands of visitors annually for events such as Delmarva Bike and national youth sporting events in conjunction with Wicomico County Tourism.

The Baltimore Orioles MiLB affiliations stretch the team's influence across the state with Double-A Bowie Baysox, High-A Aberdeen IronBirds, and Low-A Delmarva Shorebirds. There have been 14.3 million visitors to Maryland communities through Orioles minor league operations since 2005 (FYI the 2020 season was canceled due to COVID). These MiLB teams create a robust pipeline of talent and promote synergies between the Baltimore Orioles and inspire future fans in the stands at Camden Yards.

Dear Chair Guzzone:

I am writing on behalf of the Southern Maryland Blue Crabs to voice our support for **HB 897** – **Sports Entertainment Facilities Act of 2022**. The Sports Entertainment Facilities Financing Fund proposed by the bill would provide tremendous aid to our ballpark. The Blue Crabs' stadium is now thirteen years old and in need of many repairs. Currently, the Blue Crabs have the only professional ballpark in Maryland that has not received any state grants or financial support since it was built in 2008. These matters have been further complicated by the global pandemic which saw a full year of lost revenue for the ballpark.

The Southern Maryland Blue Crabs are hopeful that the funds proposed in this bill will allow us to repair, renovate, and build out our stadium for the future. We look forward to supporting our team and our community to make our ballpark a centerpiece for Southern Maryland.

In addition to MiLB games, year-round usage of these facilities for other sports, concerts, festivals plus corporate events, non-profit fundraisers, social occasions, and family functions, further contribute to the value of the ballparks to their communities.

During the COVID-19 crisis, the Delmarva Shorebirds and Arthur W. Perdue Stadium were transformed into a community center that included, testing and vaccination sites to serve Marylanders in need. As allowed during the COVID-19 crisis, we served as a place of normalcy for the community. The team and facility hosted virtual community engagement events, and as allowed inperson events that included youth baseball tournaments, drive-in firework shows, socially distant outdoor movie nights, graduation ceremonies for Wicomico County High Schools, Wor-Wic Community College, and several other events to support and raise funds for our community non-profit organizations.

As the sole statewide trade association dedicated to advocacy for Maryland's lodging industry, with more than 700 hotels totaling 75,000+ rooms, we support HB896 and HB897.

In order to address the long-term future of the stadiums, HB896 was introduced to increase the debt cap from \$235 million to \$1.2 billion, with \$600 million allocated to each stadium. To service the debt, the amount allocated from lottery proceeds will be capped at \$90 million from the current \$20 million. These improvements are designed to increase the economic impact of the stadiums for the State, the City, and the teams.

Companion legislation, HB897, was also introduced to create a \$200 million fund to promote the development of sports entertainment facilities across the state, including minor league stadiums where renovations will be necessary to maintain affiliations with major league teams. These minor league teams provide economic benefits to communities and promote synergies between the Orioles and their Maryland-based affiliates.

HB 896 and HB 897 would elevate the state as a sports tourism destination. Camden Yards Sports Complex is a valuable year-round community asset that helps to generate hotel stays and support jobs in Baltimore City and the surrounding areas. The minor league ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf do the same in those six local communities.

It is the desire of our members for these stadiums to remain competitive as best-in-class facilities to keep baseball teams and fans here in Maryland. Hotel guests spend \$5B annually throughout the state and hotels generate \$602M in state and local tax. Our industry provides great economic benefit to local communities when hotels are full. In fact, every 10 occupied rooms per night supports nearly 25 local jobs.

Recent changes by Major League Baseball highlight the need to make capital improvements in Minor League Baseball ballparks. My name is Kristin Hanna and I am the legislative chair for the Maryland Tourism Coalition as well as the Senior Director of Marketing for Flying Dog Brewery. I am writing on behalf of Maryland Tourism Coalition today - an organization that represents tourism and hospitality businesses in Maryland. As we continue to battle the effects to COVID-19, we recognize that any support for Camden Yards will be a huge benefit to our entire eco-system. We urge you all to support increasing the debt cap listed in HB 896 as well as the joint legislation, HB897.

In order to address the long-term future of the stadiums, legislation was introduced to increase the debt cap from \$235 million to \$1.2 billion. Companion legislation was also introduced to create a \$200 million fund to promote the development of sports entertainment facilities across the state, including minor league stadiums where renovations will be necessary in order to maintain affiliations with major league teams. These minor league teams provide economic benefits to communities and promote synergies between the Orioles and their Maryland-based affiliates.

HB 897 Sports Entertainment Facilities Act of 2022, through the MSA, is an initiative to help fund the much needed capital improvements at the many Minor League Baseball ballparks across the state and other sports facilities. With the ballpark upgrades now required by the recent reorganization, Maryland's minor league teams will maintain their big league affiliations' and continue to play ball in our state. The minor leagues serve as a year-round training hub for professional baseball and creates a robust pipeline of talent for the majors. The ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf offer year-round budget-friendly family entertainment and generate economic impact in those six local communities in Maryland.

This new fund also could be utilized by other sports entertainment venues such as equestrian centers, multi-use sports complexes and now venues for youth and amateur sports tournaments. With an amendment to this bill, recreational facilities are eligible for funding if an economic and feasibility study demonstrates positive economic impact to the State of Maryland. The amendment also creates a one-time \$10 million Major Sports and Entertainment Grant funded from the state lottery to support Maryland's efforts to attractand retain world-class sporting events such as the Baltimore-Maryland FIFA World Cup 2026 bid, the CIAA tournament, BMW Championship, Army-Navy game and Ironman events. Of note, \$10 million is the initial deposit, thereafter an annual appropriation for the amount is needed to return it to that level.

As we compete with surrounding states to attract visitors, investing in our assets is critical. We know the resiliency of this amazing community and we look forward to your support moving forward.

Senators Guzzone and Rosapepe and Members of the Budget and Taxation Committee,

My name is Matt Libber, and I am the Executive Director of the Maryland SoccerPlex and Adventist HealthCare Fieldhouse in Montgomery County. I am also currently the Chair of TEAM Maryland, the sports marketing collective of the Destination Marketing Organizations (DMOs) within Maryland, as well as serve on the Board of Directors for the Sports Events and Tourism Association (SportsETA), the trade group for sports tourism organizations. Wearing all three of these hats provides great perspective on the impact that House Bills 896 and 897 would have on the economy of Maryland, and we urge you to support both House Bill 896 and 897, as amended.

Tourism is a major part of the Maryland Economy and affects every part of the State, from the mountains of Garrett County, to the I-95 Corridor, and to the communities on the Eastern Shore and Ocean City. Sports tourism is major component of the tourism industry. In the post-COVID recovery, sport tourism was the first industry to return, which, in turn, touches so many other businesses in the hospitality and retail sectors. Sports travelers, event organizers, and venues spent \$45.1 billion in 2019, which generated \$103.3 billion in business sales when including indirect and induced impacts, according to a 2020 report from Tourism Economics. In Maryland, youth and amateur sports generates over \$225 million in direct spending for our economy. Investments by the State in sports tourism pays itself through the economic impact and development around sports events. For every \$1.00 spent on tourism advertising \$31.00 flows back into the State Economy. The funding for major events in this bill is important for Maryland to stay on top of an extremely competitive market. Cities and states around the United States have seen the importance of sports tourism and the economic benefits that come with these types of events. Providing the Maryland Sports Commission with the resources to attract major events such as the FIFA World Cup, Army - Navy Game, America's Cup racing, and Major League Baseball's All-Star Game sets us apart from other destinations. These marque events themselves turn into promotional assets showcasing Maryland to the rest of the country and the world.

This pair of bills allow Maryland to remain at the forefront of a highly competitive market. Allowing the Stadium Authority to make additional investments in our professional stadiums help showcase the State to the larger sports market. Providing funding for investment in the creation of new sports venue assets, improvements to existing assets, and attracting new events to the State will provide our communities across the State to continue the work they have already done to bring world class sporting events to Maryland.

Good afternoon, Chair Guzzone and Vice Chair Rosapepe and honorable members of the Budget and Taxation Committee, I am Thomas Kelso, the Chairman with Michael J. Frenz, the Executive Director of the Maryland Stadium Authority (MSA) and we appreciate the opportunity to provide this written Letter of Support for HB 897 Economic Development – Sports Entertainment Facilities and Events, Prince George's County Blue Line Corridor Facilities, and Racing Facilities

To further establish Maryland as a premier destination for sports, HB 897, through the MSA, authorizes MSA to issue up to \$200 million to fund the development and /or renovations of sports entertainment facilities across the state including minor league ballparks where renovations will be necessary in order to maintain affiliations with major league teams and continue to play ball in our state. Proceeds allocated from the Maryland state lottery, up to \$25 million annually, would be used to pay debt service on the bonds issued to finance the various projects. This new fund also could be utilized by other sports entertainment venues such as equestrian centers, multi-use sports complexes and now venues for youth and amateur sports tournaments.

With the amendment to this bill, recreational facilities are eligible for funding if an economic and feasibility study demonstrates positive economic impact to the State of Maryland. The amendment also creates a one-time \$10 million Major Sports and Entertainment Grant funded from the state lottery to support Maryland's efforts to attract and retain world-class sporting events such as the Baltimore-Maryland FIFA World Cup 2026 bid, the CIAA tournament, BMW Championship, Army-Navy game and Ironman events. Of note, \$10 million is the initial deposit, thereafter an annual appropriation for the amount is needed to return it to that level.

Sports tourism is a major component of Maryland's tourism and travel industry. In the post-COVID recovery, sport tourism was amongst first in the travel industry to return, in particular youth and amateur sports that generates over \$225 million in direct spending annually for Maryland's economy.

The beloved minor league ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf offer year-round budget-friendly family entertainment and inspire economic development in those six counties in Maryland. These minor league teams provide benefits to their communities and promote synergies between the Orioles and their Maryland-based affiliates. According to the Major League Baseball Research Data Portal, since 2005, there have been 14.3 million visitors to Maryland communities through Orioles minor league operations. The minor league ballparks, and other sports and facilities across the state create jobs and generate visitor spending with the resulting tax revenues reinvested to fund essential citizen services and improve Marylander's quality of life.

In closing, HB 897 Economic Development – Sports Entertainment Facilities and Events, Prince George's County Blue Line Corridor Facilities, and Racing Facilities, further elevates Maryland as a sports and entertainment destination by investing in our facilities to maintain our professional teams, support Maryland's attraction and retention of major sports events, promote healthy lifestyles and create business opportunities across the state for years to come.

For the reasons expressed in this letter, we respectfully request a favorable report on HB 897.

Members of the Maryland General Assembly,

Thank you for your consideration of the legislation before you, House Bill 897, Sports Entertainment Facilities Act of 2022. As you know, the game of baseball is modernizing rapidly, and many local municipally owned stadiums are being forced to improve and upgrade their player development and fan-facing resources to meet the demands of the modern game. The Maryland Stadium Authority, acting on behalf of many facilities facing these challenges, has the support of the Aberdeen IronBirds, Advanced-A Baltimore Orioles affiliate, located in Harford County. A pool of financial resources as proposed in HB 897 would undoubtedly be a source of relief for a small municipality and us as their tenant in completing these necessary changes. The IronBirds are intent on continuing to support local professional minor league baseball in this public facility, in both entertainment and economic capacities, and appreciate the support afforded by the MSA, the General Assembly, and the people of Maryland.

On behalf of our team's ownership, the Ripken family, we ask that you make HB 897 a component of protecting Maryland's legacy in the game of baseball as well as the resources of its communities.

With the economic impact, prestige, and civic pride of being home to the Baltimore Orioles Single-A Affiliate, the Delmarva Shorebirds, players and personnel support numerous non-profits, schools, churches with service on local boards, donations, fundraisers, and appearances in the community throughout the year. Annually we raise funds and make monetary donations to area non-profits through our Fly Together Fund at the Community Foundation and donate thousands of tickets to families that may not otherwise be afforded the ability to attend a professional baseball game.

According to MLB Research Data Portal home game attendance numbers for the Delmarva Shorebirds, the team brought 3.2 million visitors to Salisbury, Md 2005 - 2019. In addition, our nongame day stadium usage draws tens of thousands of visitors annually for events such as Delmarva Bike and national youth sporting events in conjunction with Wicomico County Tourism.

I am writing on behalf of the Southern Maryland Blue Crabs to voice our support for **HB 897** – **Sports Entertainment Facilities Act of 2022**. The Sports Entertainment Facilities Financing Fund proposed by the bill would provide tremendous aid to our ballpark. The Blue Crabs' stadium is now thirteen years old and in need of many repairs. To service the debt, the amount allocated from lottery proceeds will be capped at \$90 million from the current \$20 million. These improvements are designed to increase the economic impact of the stadiums for the State, the City, and the teams.

Companion legislation, HB897, was also introduced to create a \$200 million fund to promote the development of sports entertainment facilities across the state, including minor league stadiums where renovations will be necessary to maintain affiliations with major league teams. These minor league teams provide economic benefits to communities and promote synergies between the Orioles and their Maryland-based affiliates.

HB 896 and HB 897 would elevate the state as a sports tourism destination. Camden Yards Sports Complex is a valuable year-round community asset that helps to generate hotel stays and support jobs in Baltimore City and the surrounding areas. The minor league ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf do the same in those six local communities.

It is the desire of our members for these stadiums to remain competitive as best-in-class facilities to keep baseball teams and fans here in Maryland. Hotel guests spend \$5B annually throughout the state and hotels generate \$602M in state and local tax. Our industry provides great economic benefit to local communities when hotels are full. In fact, every 10 occupied rooms per night supports nearly 25 local jobs.

For the reasons expressed in this letter, we request a favorable report on HB H96 & HB 897.

Recent changes by Major League Baseball highlight the need to make capital improvements in Minor League Baseball ballparks. My name is Kristin Hanna and I am the legislative chair for the Maryland Tourism Coalition as well as the Senior Director of Marketing for Flying Dog Brewery. I am writing on behalf of Maryland Tourism Coalition today - an organization that represents tourism and hospitality businesses in Maryland. As we continue to battle the effects to COVID-19, we recognize that any support for Camden Yards will be a huge benefit to our entire eco-system. We urge you all to support increasing the debt cap listed in HB 896 as well as the joint legislation, HB897.

In order to address the long-term future of the stadiums, legislation was introduced to increase the debt cap from \$235 million to \$1.2 billion. Companion legislation was also introduced to create a \$200 million fund to promote the development of sports entertainment facilities across the state, including minor league stadiums where renovations will be necessary in order to maintain affiliations with major league teams. These minor league teams provide economic benefits to communities and promote synergies between the Orioles and their Maryland-based affiliates.

HB 897 Sports Entertainment Facilities Act of 2022, through the MSA, is an initiative to help fund the much needed capital improvements at the many Minor League Baseball ballparks across the state and other sports facilities. With the ballpark upgrades now required by the recent reorganization, Maryland's minor league teams will maintain their big league affiliations' and continue to play ball in our state. The minor leagues serve as a year-round training hub for professional baseball and creates a robust pipeline of talent for the majors. The ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf offer year-round budget-friendly family entertainment and generate economic impact in those six local communities in Maryland.

This new fund also could be utilized by other sports entertainment venues such as equestrian centers, multi-use sports complexes and now venues for youth and amateur sports tournaments. With an amendment to this bill, recreational facilities are eligible for funding if an economic and feasibility study demonstrates positive economic impact to the State of Maryland. The amendment also creates a one-time \$10 million Major Sports and Entertainment Grant funded from the state lottery to support Maryland's efforts to attractand retain world-class sporting events such as the Baltimore-Maryland FIFA World Cup 2026 bid, the CIAA tournament, BMW Championship, Army-Navy game and Ironman events. Of note, \$10 million is the initial deposit, thereafter an annual appropriation for the amount is needed to return it to that level.

As we compete with surrounding states to attract visitors, investing in our assets is critical. We know the resiliency of this amazing community and we look forward to your support moving forward.

Good afternoon, Chair Guzzone and Vice Chair Rosapepe and honorable members of the Budget and Taxation Committee, I am Thomas Kelso, the Chairman with Michael J. Frenz, the Executive Director of the Maryland Stadium Authority (MSA) and we appreciate the opportunity to provide this written Letter of Support for HB 897 Economic Development – Sports Entertainment Facilities and Events, Prince George's County Blue Line Corridor Facilities, and Racing Facilities

To further establish Maryland as a premier destination for sports, HB 897, through the MSA, authorizes MSA to issue up to \$200 million to fund the development and /or renovations of sports entertainment facilities across the state including minor league ballparks where renovations will be necessary in order to maintain affiliations with major league teams and continue to play ball in our state. Proceeds allocated from the Maryland state lottery, up to \$25 million annually, would be used to pay debt service on the bonds issued to finance the various projects. This new fund also could be utilized by other sports entertainment venues such as equestrian centers, multi-use sports complexes and now venues for youth and amateur sports tournaments.

With the amendment to this bill, recreational facilities are eligible for funding if an economic and feasibility study demonstrates positive economic impact to the State of Maryland. The amendment also creates a one-time \$10 million Major Sports and Entertainment Grant funded from the state lottery to support Maryland's efforts to attract and retain world-class sporting events such as the Baltimore-Maryland FIFA World Cup 2026 bid, the CIAA tournament, BMW Championship, Army-Navy game and Ironman events. Of note, \$10 million is the initial deposit, thereafter an annual appropriation for the amount is needed to return it to that level.

Sports tourism is a major component of Maryland's tourism and travel industry. In the post-COVID recovery, sport tourism was amongst first in the travel industry to return, in particular youth and amateur sports that generates over \$225 million in direct spending annually for Maryland's economy.

The beloved minor league ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf offer year-round budget-friendly family entertainment and inspire economic development in those six counties in Maryland. These minor league teams provide benefits to their communities and promote synergies between the Orioles and their Maryland-based affiliates. According to the Major League Baseball Research Data Portal, since 2005, there have been 14.3 million visitors to Maryland communities through Orioles minor league operations. The minor league ballparks, and other sports and facilities across the state create jobs and generate visitor spending with the resulting tax revenues reinvested to fund essential citizen services and improve Marylander's quality of life.

In closing, HB 897 Economic Development – Sports Entertainment Facilities and Events, Prince George's County Blue Line Corridor Facilities, and Racing Facilities, further elevates Maryland as a sports and entertainment destination by investing in our facilities to maintain our professional teams, support Maryland's attraction and retention of major sports events, promote healthy lifestyles and create business opportunities across the state for years to come.

For the reasons expressed in this letter, we respectfully request a favorable report on HB 897.

My name is Terry Hasseltine and I am the President of the Sport and Entertainment Corporation of Maryland. I am writing on behalf of the Sport and Entertainment Corporation of Maryland today - an organization that represents and supports several major events in Maryland. As we continue to battle the effects to COVID-19, we recognize that any support for Camden Yards will be a huge benefit to our sports eco-system. We urge you all to support increasing the debt cap listed in HB 896 as well as the joint legislation, HB897 as amended.

In order to address the long-term future of the stadiums legislation was introduced to increase the debt cap from \$235 million to \$1.2 billion. Companion legislation was also introduced to create a \$200 million fund to promote the development of sports entertainment facilities across the state, including minor league stadiums and other critical sport tourism facility assets. These minor league teams and facilities provide economic benefits to communities and promote synergies with professional teams and major event opportunities.

My name is Matt Libber, and I am the Executive Director of the Maryland SoccerPlex and Adventist HealthCare Fieldhouse in Montgomery County. I am also currently the Chair of TEAM Maryland, the sports marketing collective of the Destination Marketing Organizations (DMOs) within Maryland, as well as serve on the Board of Directors for the Sports Events and Tourism Association (SportsETA), the trade group for sports tourism organizations. Wearing all three of these hats provides great perspective on the impact that House Bills 896 and 897 would have on the economy of Maryland, and we urge you to support both House Bill 896 and 897, as amended.

Tourism is a major part of the Maryland Economy and affects every part of the State, from the mountains of Garrett County, to the I-95 Corridor, and to the communities on the Eastern Shore and Ocean City. Sports tourism is major component of the tourism industry. In the post-COVID recovery, sport tourism was the first industry to return, which, in turn, touches so many other businesses in the hospitality and retail sectors. Sports travelers, event organizers, and venues spent \$45.1 billion in 2019, which generated \$103.3 billion in business sales when including indirect and induced impacts, according to a 2020 report from Tourism Economics. In Maryland, youth and amateur sports generates over \$225 million in direct spending for our economy. Investments by the State in sports tourism pays itself through the economic impact and development around sports events. For every \$1.00 spent on tourism advertising \$31.00 flows back into the State Economy. The funding for major events in this bill is important for Maryland to stay on top of an extremely competitive market. Cities and states around the United States have seen the importance of sports tourism and the economic benefits that come with these types of events. Providing the Maryland Sports Commission with the resources to attract major events such as the FIFA World Cup, Army - Navy Game, America's Cup racing, and Major League Baseball's All-Star Game sets us apart from other destinations. These marque events themselves turn into promotional assets showcasing Maryland to the rest of the country and the world.

This pair of bills allow Maryland to remain at the forefront of a highly competitive market. Allowing the Stadium Authority to make additional investments in our professional stadiums help showcase the State to the larger sports market. Providing funding for investment in the creation of new sports venue assets, improvements to existing assets, and attracting new events to the State will provide our communities across the State to continue the work they have already done to bring world class sporting events to Maryland.

On behalf of Visit Frederick (the Tourism Council of Frederick County), the designated destination marketing organization for Frederick County, MD, please accept this letter of support for the Sports Entertainment Facilities Act of 2022. This Act will provide much needed capital improvement support to our minor league baseball facilities across Maryland. All of these facilities are invaluable community assets that host countless other public, youth, school, non-profit, and municipal activities and events in addition to minor league baseball. They are pillars of our communities, drivers of our local economies, produce substantial tax dollars, and lead directly to dramatic increases in outside visitation along with the related and critical economic impact.

During the Ripken Stadium's time in Aberdeen, it has been a source of player development for future stars in Camden Yards and across Major League Baseball, as well as a community gathering place for entertainment, celebration, public need, employment, and tax revenue. Additionally, during the COVID-19 pandemic, Ripken Stadium stepped up to the plate to host a mass vaccination and testing site, partnering with the State of Maryland Health Department.

My name is Kristin Hanna and I am the legislative chair for the Maryland Tourism Coalition as well as the Senior Director of Marketing for Flying Dog Brewery. I am writing on behalf of Maryland Tourism Coalition today - an organization that represents tourism and hospitality businesses in Maryland. As we continue to battle the effects to COVID-19, we recognize that any support for Camden Yards will be a huge benefit to our entire eco-system. We urge you all to support increasing the debt cap listed in HB 896 as well as the joint legislation, HB897.

In order to address the long-term future of the stadiums, legislation was introduced to increase the debt cap from \$235 million to \$1.2 billion. Companion legislation was also introduced to create a \$200 million fund to promote the development of sports entertainment facilities across the state, including minor league stadiums where renovations will be necessary in order to maintain affiliations with major league teams. These minor league teams provide economic benefits to communities and promote synergies between the Orioles and their Maryland-based affiliates.

HB 897 Sports Entertainment Facilities Act of 2022, through the MSA, is an initiative to help fund the much needed capital improvements at the many Minor League Baseball ballparks across the state and other sports facilities. With the ballpark upgrades now required by the recent reorganization, Maryland's minor league teams will maintain their big league affiliations' and continue to play ball in our state. The minor leagues serve as a year-round training hub for professional baseball and creates a robust pipeline of talent for the majors. The ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf offer year-round budget-friendly family entertainment and generate economic impact in those six local communities in Maryland.

This new fund also could be utilized by other sports entertainment venues such as equestrian centers, multi-use sports complexes and now venues for youth and amateur sports tournaments. With an amendment to this bill, recreational facilities are eligible for funding if an economic and feasibility study demonstrates positive economic impact to the State of Maryland. The amendment also creates a one-time \$10 million Major Sports and Entertainment Grant funded from the state lottery to support Maryland's efforts to attractand retain world-class sporting events such as the Baltimore-Maryland FIFA World Cup 2026 bid, the CIAA tournament, BMW Championship, Army-Navy game and Ironman events. Of note, \$10 million is the initial deposit, thereafter an annual appropriation for the amount is needed to return it to that level.

As we compete with surrounding states to attract visitors, investing in our assets is critical. We know the resiliency of this amazing community and we look forward to your support moving forward.

Dear Delegate McIntosh and Appropriations Committee,

My name is Terry Hasseltine and I am the President of the Sport and Entertainment Corporation of Maryland. I am writing on behalf of the Sport and Entertainment Corporation of Maryland today - an organization that represents and supports several major events in Maryland. As we continue to battle the effects to COVID-19, we recognize that any support for Camden Yards will be a huge benefit to our sports eco-system. We urge you all to support increasing the debt cap listed in HB 896 as well as the joint legislation, HB897 as amended.

In order to address the long-term future of the stadiums legislation was introduced to increase the debt cap from \$235 million to \$1.2 billion. Companion legislation was also introduced to create a \$200 million fund to promote the development of sports entertainment facilities across the state, including minor league stadiums and other critical sport tourism facility assets. These minor league teams and facilities provide economic benefits to communities and promote synergies with professional teams and major event opportunities.

My name is Matt Libber, and I am the Executive Director of the Maryland SoccerPlex and Adventist HealthCare Fieldhouse in Montgomery County. I am also currently the Chair of TEAM Maryland, the sports marketing collective of the Destination Marketing Organizations (DMOs) within Maryland, as well as serve on the Board of Directors for the Sports Events and Tourism Association (SportsETA), the trade group for sports tourism organizations. Wearing all three of these hats provides great perspective on the impact that House Bills 896 and 897 would have on the economy of Maryland, and we urge you to support both House Bill 896 and 897, as amended.

Tourism is a major part of the Maryland Economy and affects every part of the State, from the mountains of Garrett County, to the I-95 Corridor, and to the communities on the Eastern Shore and Ocean City. Sports tourism is major component of the tourism industry. In the post-COVID recovery, sport tourism was the first industry to return, which, in turn, touches so many other businesses in the hospitality and retail sectors. Sports travelers, event organizers, and venues spent \$45.1 billion in 2019, which generated \$103.3 billion in business sales when including indirect and induced impacts, according to a 2020 report from Tourism Economics. In Maryland, youth and amateur sports generates over \$225 million in direct spending for our economy. Investments by the State in sports tourism pays itself through the economic impact and development around sports events. For every \$1.00 spent on tourism advertising \$31.00 flows back into the State Economy. The funding for major events in this bill is important for Maryland to stay on top of an extremely competitive market. Cities and states around the United States have seen the importance of sports tourism and the economic benefits that come with these types of events. Providing the Maryland Sports Commission with the resources to attract major events such as the FIFA World Cup, Army - Navy Game, America's Cup racing, and Major League Baseball's All-Star Game sets us apart from other destinations. These marque events themselves turn into promotional assets showcasing Maryland to the rest of the country and the world.

This pair of bills allow Maryland to remain at the forefront of a highly competitive market. Allowing the Stadium Authority to make additional investments in our professional stadiums help showcase the State to the larger sports market. Providing funding for investment in the creation of new sports venue assets, improvements to existing assets, and attracting new events to the State will provide our communities across the State to continue the work they have already done to bring world class sporting events to Maryland.

With the economic impact, prestige, and civic pride of being home to the Baltimore Orioles Single-A Affiliate, the Delmarva Shorebirds, players and personnel support numerous non-profits, schools, churches with service on local boards, donations, fundraisers, and appearances in the community throughout the year. Annually we raise funds and make monetary donations to area non-profits through our Fly Together Fund at the Community Foundation and donate thousands of tickets to families that may not otherwise be afforded the ability to attend a professional baseball game.

According to MLB Research Data Portal home game attendance numbers for the Delmarva Shorebirds, the team brought 3.2 million visitors to Salisbury, Md 2005 - 2019. In addition, our nongame day stadium usage draws tens of thousands of visitors annually for events such as Delmarva Bike and national youth sporting events in conjunction with Wicomico County Tourism.

The Baltimore Orioles MiLB affiliations stretch the team's influence across the state with Double-A Bowie Baysox, High-A Aberdeen IronBirds, and Low-A Delmarva Shorebirds. There have been 14.3 million visitors to Maryland communities through Orioles minor league operations since 2005 (FYI the 2020 season was canceled due to COVID). Dear Senator Guy Guzzone and Senator Rosapepe,

My name is Kristin Hanna and I am the legislative chair for the Maryland Tourism Coalition as well as the Senior Director of Marketing for Flying Dog Brewery. I am writing on behalf of Maryland Tourism Coalition today - an organization that represents tourism and hospitality businesses in Maryland. As we continue to battle the effects to COVID-19, we recognize that any support for Camden Yards will be a huge benefit to our entire eco-system. We urge you all to support increasing the debt cap listed in HB 896 as well as the joint legislation, HB897.

In order to address the long-term future of the stadiums, legislation was introduced to increase the debt cap from \$235 million to \$1.2 billion. Companion legislation was also introduced to create a \$200 million fund to promote the development of sports entertainment facilities across the state, including minor league stadiums where renovations will be necessary in order to maintain affiliations with major league teams. These minor league teams provide economic benefits to communities and promote synergies between the Orioles and their Maryland-based affiliates.

HB 897 Sports Entertainment Facilities Act of 2022, through the MSA, is an initiative to help fund the much needed capital improvements at the many Minor League Baseball ballparks across the state and other sports facilities. With the ballpark upgrades now required by the recent reorganization, Maryland's minor league teams will maintain their big league affiliations' and continue to play ball in our state. The minor leagues serve as a year-round training hub for professional baseball and creates a robust pipeline of talent for the majors. The ballparks located in Aberdeen, Bowie, Frederick, Hagerstown, Salisbury and Waldorf offer year-round budget-friendly family entertainment and generate economic impact in those six local communities in Maryland.

This new fund also could be utilized by other sports entertainment venues such as equestrian centers, multi-use sports complexes and now venues for youth and amateur sports tournaments. With an amendment to this bill, recreational facilities are eligible for funding if an economic and feasibility study demonstrates positive economic impact to the State of Maryland. The amendment also creates a one-time \$10 million Major Sports and Entertainment Grant funded from the state lottery to support Maryland's efforts to attractand retain world-class sporting events such as the Baltimore-Maryland FIFA World Cup 2026 bid, the CIAA tournament, BMW Championship, Army-Navy game and Ironman events. Of note, \$10 million is the initial deposit, thereafter an annual appropriation for the amount is needed to return it to that level.

As we compete with surrounding states to attract visitors, investing in our assets is critical. We know the resiliency of this amazing community and we look forward to your support moving forward.
