RE: HB0031 – Maryland Energy Administration – Resiliency Hub Grant Program and Fund

- Support

The Office of Attorney General urges this Committee to favorably report HB 31, Delegate Charkoudian's legislation to establish a Resiliency Hub Grant Program in the Maryland Energy Administration. If passed, this legislation will take effect on October 1, 2022.

House Bill 31 expands "Resilience Hub" funding that targets microgrid development in low-income neighborhoods, develops opportunities for community ownership of solar, coordinates efforts with emergency preparedness funding, and prepares the State to accept more federal funds for these efforts. It is a forward-looking policy prescription that will benefit low-income households by providing "emergency heating, cooling; refrigeration of temperature sensitive medications; plug power for charging of cell phone and computer batteries; ventilation and emergency lighting."
