AMENDMENT NO. 1

On page 1, in line 5, after "County;" insert "requiring the Howard County Board of License Commissioners to publish a certain notice on the Board's website for a certain period of time before a certain hearing; requiring the Board to provide a certain notice to the Howard County Office of Public Information to be posted with other public meeting notices;".

AMENDMENT NO. 2

On page 3, after line 16, insert:

- "(C) THE APPLICANT SHALL TAKE A PHOTO OF THE NOTICE POSTED IN ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION AND SEND IT TO THE BOARD BEFORE THE HEARING ON AN APPLICATION.
- (D) THE BOARD SHALL POST A HEARING NOTICE ON THE BOARD'S WEBSITE FOR AT LEAST 15 DAYS BEFORE THE HEARING ON AN APPLICATION WHICH SHALL INCLUDE:
 - (1) THE NAME OF THE APPLICANT;
- (2) THE TYPE OF LICENSE FOR WHICH THE APPLICATION IS MADE;
 - (3) THE LOCATION DESCRIBED IN THE APPLICATION; AND
- (4) THE DATE, TIME, AND PLACE SET BY THE BOARD FOR A HEARING ON THE APPLICATION.
- (E) AT LEAST 15 DAYS BEFORE THE HEARING ON AN APPLICATION, THE BOARD SHALL PROVIDE THE HEARING NOTICE TO THE HOWARD COUNTY
