Honorable Chair Pinsky and Members of the Education, Health, and Environmental Affairs Committee:

My name is Aishwarya Iyer, and I am the Student Body President and MD/PhD Candidate at the University of Maryland, Baltimore (UMB). The UMB University Student Government Association (USGA) represents the students of seven professional schools – the School of Medicine, Law, Nursing, Pharmacy, Social Work, Dentistry, and the Graduate School. Our institution confers the majority of healthcare, law, and health services professional degrees in Maryland, and our USGA supports students in their pursuit of serving the public good.

We, the UMB USGA, wholeheartedly support the MaryPIRG Student Climate Action Coalition (MSCAC) in their advocacy of the FUTURE Act. We recognize the dire need for curtailing fossil fuel emissions and other environmental pollutants. We feel that climate advocacy is not only as a moral imperative for future generations, but such advocacy is also required as a health imperative to protect the lives of the thousands of Marylanders that are affected by climate inaction.

In Baltimore, the patients we serve are often exposed to a plethora of toxic exposures – namely, air pollution from fossil fuel as well as from, combustion and extreme heat, exacerbated by "heat islands" created from the heat-trapping effects of air pollution byproducts. Fossil fuels exacerbate climate change and have profound effects on human health. They have been linked to increased health burdens on the cardiovascular, pulmonary, and neurological systems in the human body. Our most vulnerable neighbors are affected by the health impacts of our campus emissions, and have the least access to legal, financial, and social resources to defend themselves. The FUTURE Act presents a prime opportunity to mitigate our emissions, so that we may stop contributing to the health burden that we strive so desperately to address.

The students of our seven schools are forward-thinking and are willing to ask the difficult questions in order to identify the root cause of our patients' suffering. Structural barriers to wellness are often out of reach of a physician's prescription pad, but the FUTURE Act's Environmental Justice Scholarship Fund allows USM schools to use education as a tool to fight systematic inequality. With the act requiring institutions to study the feasibility of a sustainability general education requirement, we can ensure future students are knowledgeable about prioritizing the health of our environment and all those who share it. We look forward to welcoming a more diverse student body – a student body with diverse life experiences, that can relate to and stand up for the populations they serve. The FUTURE Act paves the way for recruiting a student body that truly represents the communities in which our campuses are located. By creating a mechanism to reduce USM emissions, prioritizing environmental justice, and ensuring USM students learn about sustainability, graduate and professional students will be better prepared to serve the communities which surround usphysically and mentally- as we pursue our upper-level degrees and enter our careers. Given the feedback that we have received from our student population here at UMB, we, the University of Maryland, Baltimore University Student Government Association (USGA), fully support the FUTURE Act and believe strongly
