Testimony of FreeState Justice

IN FAVOR OF

HB 1380: Restoration of Honor Act

To the Honorable Chair Paul Pinksy, Vice Chair Cheryl Kagan, and esteemed members of the Education, Health, and Environmental Affairs Committee:

FreeState Justice is Maryland's lesbian, gay, bisexual, transgender, and queer (LGBTQ) civil rights advocacy organization. Each year, we provide free legal services to hundreds of LGBTQ+ Marylanders who could not otherwise be able to afford an attorney, as well as advocate more broadly on behalf of the LGBTQ+ community, including efforts to improve the conditions of LGBTQ+ veterans.

Today, we write for a favorable report on House Bill 1380, which would establish honorable discharge and associated rights, benefits, and privileges for dishonorably discharged LGBTQ+ veterans based on their sexual orientation or gender identity. This bill also requires the Secretary of Veteran Affairs to adopt regulations that prohibit discrimination based on sexual orientation or gender identity when determining if an individual qualifies as honorably discharged or not.

There are an estimated 1 million LGBTQ+ veterans in the United States, and the US Armed Forces discharged an estimated 100,000

FreeState Justice, Inc. (formerly FreeState Legal Project, Inc., merging with Equality Maryland) is a social justice organization that works through direct legal services, legislative and policy advocacy, and community engagement to enable Marylanders across the spectrum of lesbian, gay, bisexual, transgender, and queer identities to be free to live authentically, with safety and dignity, in all communities throughout our state. military members due to their sexual orientation to date.¹² LGBTQ+ veterans who have dutifully served their country deserve the recognition and rights, benefits, and privileges of their non-LGBTQ+ counterparts. Dishonorable discharge based on an individual's sexual orientation or gender identity is discrimination based on sex and sexual orientation. This bill aims to prevent future discrimination and repair harm to LGBTQ+ veterans who have had to endure homophobic and transphobic military policies.

HB 1380 aligns with federal policies ensuring fair, equal treatment of LGBTQ service members and veterans. In 2011, the United States repealed the "Don't Ask, Don't Tell" policy, allowing openly gay people to serve in the military without punishment.³ Additionally, in 2021, the Department of Veterans Affairs (VA) announced that LGBTQ+ veterans dishonorably discharged due to their sexual orientation, gender identity, or HIV status are permitted full VA benefits, rights, and privileges of honorable discharge.⁴ As Kayla Williams, Assistant Secretary for Public Affairs for the VA, aptly stated, "LGBTQ+ Veterans are not any less worthy of the care and services that all Veterans earn through their service, and VA is committed to making sure that they have equal access to those services." = This bill affirms the VA's policies regarding the benefits, rights, and privileges of LGBTQ+ veterans.

Finally, instating honorable discharge for LGBTQ+ veterans dishonorably discharged due to their sexual orientation or gender identity restores the dignity and honor of LGBTQ+ veterans. This bill provides healing for LGTBQ+ veterans exposed to homophobic and transphobic policies of the past and fairly recognizes their service to their country. It also ensures that current and future LGBTQ+ service members will not face discrimination based on their sexual orientation and gender identity during the discharge processes, protecting the rights of all LGBTQ+ people who serve in the military – present, past, and future.
