### RE: **SUPPORT** – Senate Bill 171 – Environment – Public Participation Modernization Act

The Maryland Delaware Solid Waste Association (MDSWA), a chapter of the National Waste and Recycling Association, is a trade association representing the private solid waste industry in the State of Maryland. Its membership includes hauling and collection companies, processing and recycling facilities, transfer stations, and disposal facilities. MDSWA and its members **support** Senate Bill 171.

Senate Bill 171 proposes to amend general public participation and notice requirements for a number of permits that are issued by the Maryland Department of the Environment (MDE) including permits to install, materially alter, or materially extend landfill systems, incinerators for public use, or rubble landfills. Under current law, MDE must hold any required public informational meetings and hearings at a location near where the permit or license applies. Senate Bill 171 would authorize these public informational meetings and hearings to be held using teleconference or Internet-based conferencing technology unless federal law requires the meeting or hearing to be held in person or any person requests that the meeting or hearing be held in person.

MDSWA strongly supports the proposed changes to the public notice, public hearings, and informational meetings requirements. The changes are necessary given the changes in federal public notice rules and public health and safety concerns related to the COVID-19 pandemic. MDSWA not only believes that these changes will facilitate the ability for MDE to timely process permit applications even under the limitations of a pandemic, but that conducting hearings and meetings using teleconference or Internet-based conferencing technology will provide increased opportunities for the public to engage in the licensing and permitting process and will likely save time and money for both MDE and applicants. MDSWA urges a favorable report.

The bill authorizes public informational meetings and hearings to be held using teleconference or Internet-based conferencing technology unless federal law requires the meeting or hearing to be held in person or any person requests that the meeting or hearing be held in person and public notices to be posted on the MDE website and other means of electronic communication in addition to in print.

Given the changes in federal public notice rules and public health and safety concerns related to the COVID-19 pandemic, the proposed changes are essential for MDE to enable them to continue to timely process permits while ensuring public notice and participation. In fact, what has been learned during the pandemic is that conducting hearings and meetings using teleconference or Internet-based conferencing technology often provides increased opportunities for the public to engage in the licensing and permitting process and will likely save time and money for both MDE and applicants. The Chesapeake Bay Foundation (CBF) **SUPPORTS SB 171**. This bill seeks to modernize public participation in the Department of Environment's decision making by authorizing the Department to hold certain public meetings and hearings regarding licensing, permitting, and regulatory responsibilities using teleconference or Internet-based conferencing technology.

During Maryland's COVID-19 State of Emergency, the opportunity to participate in public hearings virtually has been a convenience for many, and in some cases, CBF has observed an increase in public participation likely because of the possibility to join meetings remotely. Virtual hearings also carry the additional benefit of decreasing greenhouse gas emissions that may have been associated with travel to a meeting location. CBF supports this legislative effort to continue the positive practice uncovered in response to the global pandemic.

This legislation also accommodates the possibility to continue to hold meetings in person. The Department only has the option to hold a meeting via teleconference or internet-based conferencing when federal law or regulation allows, and when a member of the public has not requested that the meeting be held in person. This safeguard will help protect the interests of concerned citizens who for reasons or access or influence, prefer an in-person public hearing or public information session.
