

### SB 545 Carroll County - Commissioners - Compensation and Benefits

Chairman Pinsky, Vice Chair Kagan, and members of the Education, Health, and Environmental Committee,

Senate Bill 545 makes several adjustments to the compensation for future Carroll County Commissioners.

- 1) Raises the annual salary of the commissioners from \$45,000 to \$50,000.
- 2) Replaces allowance now provided to Commissioners and instead entitles them to reimbursement incurred during official duties.
- 3) prohibits the Carroll County Board of County Commissioners from offering group insurance or pension benefits to the county commissioners that are different from similar benefits offered to full-time county employees.

The bill applies only prospectively, and provisions related to salary or compensation take effect at the beginning of the next term of office.

Approved 2-0 by Carroll County Senators.



Re: SB545 – Carroll County - Commissioners – Compensation and Benefits – Favorable with Amendment

Dear Chair Pinsky and Members of the Committee,

We respectfully oppose SB545 as written and suggest steps to make the bill acceptable. The bill prescribes County Commissioner compensation and benefits in the form of salary, expenses, and authorization to participate in health insurance and pension programs available to county employees. Carroll County has for many years offered health care and pension benefits to the Board of Commissioners that differ slightly from what is offered to other employees, having significantly reduced their scope in 2018. A deeper look at the laws surrounding the issues of commissioner salary and compensation raises a number of questions regarding ambiguities in language and a lack of clear direction.

This confusion begins with Article VII of the Maryland Constitution:

"Article VII – Sundry Officers, Subsection 2. Number, *salary* and responsibilities of County Commissioners

The number, *compensation*, and powers and duties of the County Commissioners of each county not governed by Article XI-A of this Constitution shall be such as now are or may be hereafter prescribed by law." (*Emphasis added*)

As you see, the commissioners are deemed to be officers. This is critical in determining their powers regarding health insurance and pension plans. In addition, the terms "salary" and "compensation" are used interchangeably, yet in other parts of the law we see these terms used independently.

Further, the Local Government Article, Division III, Title 12, Subsection 2 states:

- "(C) The governing body of a county may:
  - (1) Establish a pension plan or group insurance plan for the benefit of its officers and employees; and
  - (2) Establish classifications and eligibility criteria for each pension plan or group insurance program."

Clearly the Board of Commissioners is authorized as the governing body to establish the plans and programs referenced above and to establish classifications and criteria for said plans for its officers and employees. Since Article VII has deemed the commissioners to be officers, the Board is therefore authorized to establish classifications and criteria for each program and to qualify as officers, making them eligible for participation.

Finally, even the title of the bill lends to this confusion of language by referring to compensation and benefits as being separate matters. Given these ambiguities and confusion in language, we respectfully request that the portions of the bill regarding health insurance and pension plan programs be stricken, and that the issue be studied during the interim with the intent of further defining in Maryland law such terms as salary, compensation, and benefits; by making applicable language clear and consistent; and by providing a clear definition of officers.

For these reasons we respectfully request SB545 be amended as proposed.
