Senate Bill 0601: Baltimore City Soil Conservation District – Establishment – Requirements

DATE: March 8. 2022 POSITION: Favorable

The Farm Alliance of Baltimore SUPPORTS Senate Bill 0601, which establishes and sets forth funding and structural requirements for a Soil Conservation District in the city of Baltimore, to be administered by a governing body of five supervisors.

The Farm Alliance of Baltimore is a membership organization of urban farms, neighborhood growers, and friends. We use connection, resource sharing, and collective advocacy with respect to food, land and water to expand communities' self-determination and power.

The Farm Alliance of Baltimore represents 18 urban farms and 12 community gardens throughout the city, comprising over 90 people who are actively engaged in urban agriculture.

Our staff of six includes three trained and experienced urban farmers who collectively have over 25 years of experience in practicing sustainable agricultural methods to conserve and build healthy soils. We have been working closely with University of MD Extension Service and the Natural Resource Conservation Service of the USDA for more than three years to advance the cause of creating a Soil Conservation District in the city of Baltimore, which is the only jurisdiction in the entire state of Maryland that still lacks one. This District will support the growth of the ecosystem of sustainable urban agricultural operations in the city such as the ones in our membership network. Without a Soil Conservation District, our farms have faced additional barriers to financial viability such as lack of access to heavy equipment, lack of access to capital for the purpose of agricultural development, and a confusing regulatory landscape that sometimes results in unwarranted regulation of farming activities in the city simply because city agencies do not recognize the agricultural practices our farmers use. A Soil Conservation District staffed by experts in sustainable agriculture methods will be in a position to remove many of these barriers. Therefore, we are in support of this Senate Bill 0601 from Senator McCray, and we urge the committee to take a FAVORABLE position and advance this legislation.

Chesapeake Bay Foundation (CBF) **SUPPORTS** SB 601 which provides for the establishment of a Baltimore City Soil Conservation District through updates to the State Code to allow for the appointment of soil conservation district supervisors and clarify the roles of the Mayor of Baltimore City and the Secretary of State, and make other technical and procedural changes to allow the district to be formed.

A Baltimore City-based Soil Conservation District will provide technical assistance needed to further urban agriculture

Soil Conservation Districts (SCDs) provide technical assistance and facilitate conservation funding for farming practices nationwide. SCDs gather local, state and federal agency staff in one office to provide resources to farmers, including conservation practices that protect water quality and prevent pollution runoff. Maryland currently has twenty-four SCDs, one for each County except Frederick County which has two, the Frederick and Catoctin soil conservation district.¹

Farming in Baltimore City consists of primarily urban agriculture which comes with a unique set of technical assistance challenges and funding needs. Many urban farms grow vegetables in "hoop houses," which are greenhouses that extend the growing season. One of the limiting factors for Baltimore City farms is water, irrigation for their crops.

Funding for hoop houses, and technical assistance to overcome irrigation challenges could be provided by a Soil Conservation District office. For example, staff could assist urban farmers tap funding from the Federal USDA Natural Resources Conservation Service for hoop houses. The State NRCS Conservation team provides \$100,000 annually to each SCD in Maryland through the Environmental Quality Incentives Program to fund local farming projects.²

Urban agriculture creates green spaces and provide healthy produce to residents

The Chesapeake Bay Foundation has worked with Baltimore City in the greening of abandoned lots. CBF supports conservation programs including urban farming that can preserve a green print within a developed area. Green space can help mitigate stormwater runoff into local waterways and the Bay. With this

legislation, Baltimore City would have assistance through a District office to target urban farming practices to mitigate climate change, improve water quality, build healthy soils and reduce the amount of pollution in local waterways and the Chesapeake Bay.

The Chesapeake Bay Foundation also seeks to increase local food production and providing healthy food in food priority areas. The COVID pandemic highlighted disparities and health risks associated with lack of access to nutritious food. CBF supports local food purchases through its Buy Fresh Buy Local Chesapeake program which helps consumers, sustainable farms, and businesses find each other and support efforts to protect and restore the Chesapeake Bay.

On behalf of the Maryland Association of Soil Conservation Districts (MASCD) I am providing information regarding the establishment of a Baltimore City Soil Conservation District. MASCD, incorporated in 1956, promotes practical and effective soil, water, and natural resource related programs to all Marylanders. Through individual conservation districts MASCD provides leadership, education, cooperation, and local direction, on a voluntary basis, promoting these initiatives.

Agricultural operations are expanding within our urban landscapes in Maryland, doing everything from beekeeping to growing vegetables and flowers. Farming techniques such as vertical farming and hoop houses are implemented to contribute to a sustainable food network. These farmers work well within the urban environment, but at times face unique issues such as soil quality, water management on non-agricultural parcels, neighbor relations, and much more.
