On behalf of Maryland's independent colleges and universities and the 58,000 students we serve, thank you for the opportunity to provide written testimony to support *Senate Bill 654* (*Klausmeier*) *Veterans Affairs – Office of Communications and Public Affairs – Veterans Advocacy and Education Act.* The bill renames the Outreach and Advocacy Program within the Maryland Department of Veterans Affairs (MDVA) to be the Office of Communications and Public Affairs. MDVA, in partnership with the Maryland Higher Education Commission (MHEC), is required to actively assist veterans and their dependents to access education and training benefits.

The State of Maryland and Maryland Institutions of Higher Education established a collaboration with MDVA on January 31, 2011, to serve veterans and their families and help them become members of our campus communities. The inclusion of veterans contributes to the diverse student population at MICUA institutions. The Maryland College Collaboration for Student Veterans Commission was established in 2016 (Ch.413 of 2016), and MICUA is a designated representative on the Commission. The Commission's work consists of "ensuring the educational success of returning veterans, including their recruitment, successful transition into higher education, retention, and eventual graduation." SB 654 creates a central location within MDVA for veterans to learn more about the various educational opportunities in the State and improve access to obtain a college degree and training for the workforce. The bill continues the good work of previous efforts for veterans and their families.

There are several MICUA institutions with deeply rooted connections to military bases in close proximity and they have demonstrated a strong commitment to provide a supportive school environment for all students, including veterans and their families.

Dear Chairman Pinsky and Members of the Committee,

Thank you for the opportunity to present a letter of support today in reference to Senate Bill 654 (SB654). This bill clarifies the roles and responsibilities of the Outreach and Advocacy Program in the Maryland Department of Veterans Affairs. SB654 renames the Program in a manner that makes its purpose clear.

The Outreach and Advocacy Program was established in 2006 to inform veterans of the services, benefits, and assistance available to them by the state and federal government. Over the course of the last 15 years, the Program's communications role and program management responsibilities have increasingly expanded. This bill does three things: (1) as they exist in 2022, it crystallizes the roles and responsibilities of the Program, (2) related to the purpose of the Program it ensures transparency across federal, state, and local government as well as private sector, and (3) it establishes a foundation for future state leaders to clearly understand the breadth of responsibility assigned to the Program.

The amendment to SB654 only addresses the title of the bill and change to program name. In lieu of changing the title from a program to an office, the amendment clarifies in the title that we continue to provide outreach and advocacy but recognizes the transformation of the program and its evolving communications role. The amendment also ensures continuity of operations and consistency across MDVA programs. Every other arm of the Department is a 'program'. Therefore, the role of communications, outreach, and advocacy, should also be a program. Outreach and advocacy has been a cornerstone of this program. If the program title changes to the office of communications and public affairs our constituents will wonder if outreach and advocacy on behalf of veterans has ended, which it has not.

This is a commonsense bill with no fiscal impact. The bill explains how the program has evolved since 2006, it describes the added responsibilities placed on the program, and clarifies to all whom we serve, exactly what we do. I respectfully ask that this committee provide a favorable vote, with the amendment, to SB654.
