Sponsor Testimony in SUPPORT of House Bill 230

Traffic Control Signal Monitoring Systems – Exclusion of Vehicle Rental Companies – Repeal and Notification Requirement

February 3, 2022

Under current law, a person who endangers others by speeding is exempt from receiving a speed camera citation if they happen to be driving a rental car. According to Montgomery County Police, about 9% of potential violations fall into this category. House Bill 230 would improve safety by ending the exemption.

Of the states that allow automated speed enforcement, Maryland is the outlier that exempts rental cars.

HB230 follows the model used in Washington State. Under the bill, if a vehicle registered to a rental car company triggers a speed camera violation, a notice is sent and the company has 45 days to respond back with the name and mailing address of the renter. The citation can then be sent directly to the renter.

The Washington State approach is a successful one. Companies like Enterprise, Alamo and National are able to comply and are sending the renter information back to the jurisdiction in response to the notice.

I am offering a sponsor amendment to help rental car companies and agencies by automating the processing of notices and eliminating unnecessary paperwork.

I ask for your favorable report.
