Constitutional Amendment - Environmental Rights

Dear Chair Barve, Vice-Chair Stein, and Members of the Environment and Transportation Committee,

We depend on clean air, clean water, healthy soil, and a stable environment. Maryland residents face ongoing exposures to pollutants in the air, water, and land which have negatively impacted public health with increased rates of chronic obstructive pulmonary disease [DeVries R, Kriebel D, Sama S. In 1973 the Maryland General Assembly passed the Maryland Environmental Policy Act which recognized that “each person has the fundamental and inalienable right to a healthful environment.” Yet we have not officially established this as our right right in the state constitution. By enacting this amendment we create an enforceable right to a healthful environment. We strengthen state and local governments’ ability to protect natural resources via laws and regulations. We create a legal guardrail to prevent the most egregious forms of environmental harm.

Our environment depends on us, no supernatural agent will save us from ourselves. We either diminish our environment or we protect and enhance it by our inactions or actions. Secular Maryland supports this amendment.
