Throughout 2020 and 2021, Law Enforcement agencies have had a rise in complaints of street racing and exhibition driving. These departments have committed a large number of resources to combat these issues in an attempt to continue to keep the public safe. One hinderance that Law Enforcement has had is the fact that the wording of the laws concerning street racing and exhibition driving is vague and the penalties are nothing more than a 'slap on the wrist' and do not deter these activities. These events are at times spontaneous and other times are organized in advanced and have caused disruptions in traffic and endangered the lives of citizens who traverse within our state.

My testimony is in support of the proposed legislation with additions to serve as amendments to strengthen the laws.

There should be and inclusion of *Transportation Article 21-1132(a)(2) Exhibition Driving*, and *Transportation Article 21-1117 Skidding*, spinning of wheels, and excessive noise prohibited in this penalty. Race and speed contest describe straight line movements on the roadways and are only a part of the overall problem. There have been many examples of groups of vehicles stopping traffic to exhibit reckless behavior on roadways as well as in parking areas used by the public. One of the most notable was the vehicle who stopped traffic to do 'donuts' on the Chesapeake Bay Bridge in September of 2020. These actions are at times more dangerous than straight line races due to the erratic nature that vehicles have as the rotate around a central point.

Adding a minimum amount of time the vehicle may be impounded as well as the penalty of prolonged impoundment of the vehicle used in the violation if there is a conviction of subsequent violations of the same statute will serve as a more substantial deterrent of committing the violations.

I believe that I understand the goal of HB 102, so I think with these minor amendments the bill will reach its intended goal of preventing the reckless actions and keeping the public safe as they move across our great state. I encourage you to support HB 102.

The Office of the Prince George's County Executive SUPPORTS with AMENDMENTS, HB 102: Vehicle Laws - Race and Speed Contests - Penalties, which alters certain penalties and points assessments for motor vehicle violations related to participation in a race or speed contest; establishes that a person charged with violations related to participation in a race or speed contest must appear in court and may not prepay the fine; and authorizing the towing and impounding of a vehicle involved in certain motor vehicle violations related to participation in a race or speed contest.

The prevalence of driving exhibitions has been a scourge to the peaceful citizens of the entire region, and this bill provides a great step in establishing deterrents that can stop the behavior. These enhanced penalties can become a key preventive measure to exhibition driving and related offenses.

During recent months, these dangerous races have not only plagued roadways in Prince Georges County but communities from western Maryland to the Eastern Shore. While preventing these races provides our community with quiet streets and peaceable commutes, at the heart of this bill is public safety. We strongly support provisions in this bill to protect pedestrians and other drivers, by applying severe fines and penalties in the instances where the reckless behavior of some, endangers the lives of others and places them at risk for serious bodily harm.

However, we wish to offer a friendly amendment, which would establish a scaled point system for driving exhibitions, races, and speed contests that do not result in serious bodily harm, which increases with each offense to ensure violators are held accountable for repeated behavior.

For the reasons stated above, the Office of the Prince George's County Executive SUPPORTS HB 102 with AMENDMENTS and asks for a FAVORABLE report.
