Discrimination in Housing - Citizenship, Immigration Status, and National Origin

Position: Oppose

Dear Del. Carr & members of Environment and Transportation:

The Community Associations Institute's Maryland Legislative Action Committee (CAI-MD LAC) has reviewed HB928. It is our position that we oppose a law that forbids our members to reject a person from a housing application, either rental or cooperative ownership, who is in the United States illegally. We certainly have no problem with protecting those here legally or any person on the basis of citizenship or national origin. But, a person who is here illegally has broken Federal Law, is subject to arrest and deportation and may have other, unknown criminal associations. A deportation would result in an unexpected vacancy, premature turnover, re-rental costs and other financial hardship on the property owner.

Our members are community associations, board of directors members, homeowners/unit owners and those who manage and serve communities. Some of our community associations are actually owners of some of their units are do rent those units. Some are cooperatives and have historically engaged in an interview

Maryland Legislative Action Committee Post Office Box 6636 Annapolis, Maryland 21401 process before a person is allowed to rent or buy in the coop. Many are owners of rental property either in our communities or elsewhere, so this is not a topic irrelevant to common ownership communities.
