Dear Chair Barve, Vice Chair Stein, and Members of the Environment and Transportation Committee:

Thank you for the opportunity to provide testimony to the Committee. I am writing to express my **support for HB1333**, legislation introduced by Delegate Lehman which would increase penalties and strengthen the regulations on illegal vehicle exhaust modifications in Maryland.

Exhaust system modifications, often referred to as muffler modifications, occur when the exhaust system of a vehicle is illegally modified to increase the noise emitted from the car. This significantly increases the noise from vehicle exhaust systems, even when cars are driven at lower speeds. This practice of exhaust modifications has been illegal in Maryland for many years, yet the problem has persisted in neighborhoods and streets across the state.

Over the last four years, my office has heard countless complaints from Howard County residents and community associations pertaining to drag racing and extremely loud vehicles coming through neighborhoods. These cars have typically had their exhaust systems modified to increase the noise emitted from the vehicles. This noise pollution causes many residents a great deal of stress and anxiety, especially at night and when accompanied by drag racing and other dangerous driving behaviors.

Currently, the deterrents against these modifications are not strong enough to change the behavior of individuals who modify their cars. HB1333 aims to address that issue by increasing the fines on motorists and requiring police officers to issue a safety equipment repair order. This legislation will give local jurisdictions the tools we need to begin addressing this issue for the benefit of our community's health and wellbeing.

In 2021, the State of New York passed similar legislation to address exhaust modifications. New York significantly increased fines on both motorists and auto shops that violate the laws on illegal exhaust modifications. Lawmakers in New York recognized exactly what many residents and lawmakers in Maryland recognize today – we need stronger laws on the books to deter these illegal modifications.

HB1333 will aid our efforts to make our streets safer and more comfortable for our constituents. Thank you for your consideration of this legislation. I respectfully encourage a favorable report.

My name is Hector R Rodriguez and I live at 6960 Sunfleck Row in Columbia, Maryland. We have lived there over thirty-three years. In the last year or so our neighbors and we have experienced the plague of extremely loud cars using Cradlerock Way and Homespun Lane to drive the local residents crazy. These young drivers consider this activity their right and consider that they are exercising their "freedom" to assault the neighborhood with rude and violent shockwaves of excessive noise from their moving machines. Some of these young men have even stopped to remonstrate when one of our neighbors have looked with surprise and displeasure as they were so assaulted as they cut their grass while the offending motorists passed by. One of our neighbors is dealing with serious, if not terminal, cancer who seeks only the quiet time to recover from her serious illness. Another family whose property backs up to Homespun Lane recently invested in building themselves a deck, which they have not been able to enjoy given the constant barrage of shock waves from so many revving engines.

To whom it may concern,

Over the years the number of overly modified vehicles operating on the roadways of the state have increased. With the ease of accessing parts through online retailers and directions on how to modify the vehicles being easily accessible through online forms and Youtube, more vehicle owners are installing illegal modifications on their vehicles.

Many modifications made to vehicles are purely cosmetic and cause no danger or disturbances to other drivers on the roadway and the surrounding communities. Modification of the exhaust system is not one of those modifications. Vehicle manufactures undergo extensive testing and certification by regulatory bodies to ensure the exhaust system on vehicles operate in a way that reduces the emission of damaging greenhouse gasses. The testing also requires that the sound levels of the exhaust system does not rise above a generally acceptable level during normal operation. With modified exhaust that cause excessive noise, drivers will be unable to hear necessary sounds around them such as emergency vehicles responding to calls or other drivers honking their horn to warn of danger. The loud sound also distracts drivers and pedestrians potentially causing them to become inattentive to their surroundings. Failure to have full attention when on and around roadways may cause a danger for all citizens in the area.

A progressive increase in the penalty, as proposed in HB1333, for the violation of Transportation Article 22-609 will be a better deterrent to violators of the law and demonstrate that the State of Maryland will not allow unsafe vehicle to operate on the roadways. I encourage a favorable vote for HB1333.

Dear Members of the Environment and Transportation Committee of the Maryland House of Delegates:

I write in support of HB1333 and urge the Committee to approve its consideration in the full House of Delegates as soon as possible.

I am a resident of the Wheaton area of Silver Spring and live two blocks from Georgia Avenue. Since mid-2020, my neighbors and I, with few exceptions, have heard vehicles with modified exhaust systems drive down Georgia Avenue at all hours of the day, often hearing them pass within minutes of each other. The vehicle modifications that cause this are proliferating: previously, the modified vehicles could only be witnessed driving down Georgia Avenue. Since January 2022, however, I have seen increasing numbers of vehicles parked in my neighborhood sporting modified exhaust systems, and though their cruising speed is lower on our street, the noise they generate is impossible to miss once in operation. Failing to curb this behavior now will ensure that the problem continues to worsen.

Encountering these modified vehicles is a frequent occurrence in other parts of Maryland I have visited as well, but rather than share more anecdotes, I note here that this phenomenon has caught the attention of many others. *NBC 4 Washington* <u>reported</u> on the trend last summer and noted that police in Gaithersburg stopped over 100 vehicles with modified exhaust systems in *just one night* last year.

This is a nuisance to many Maryland residents, but I am particularly concerned for those who may be uniquely vulnerable to the effects of modified exhaust systems. For example, I have noticed that some systems produce sounds akin to gunshots when a driver accelerates and then lets off the gas – medical professionals <u>cite</u> backfiring cars as a trigger of post-traumatic stress syndrome symptoms among veterans.

The enforcement and penalties currently in place for illegal exhaust modifications are evidently insufficient to deter their growing use. I reiterate my support for HB1333 and urge a favorable Committee decision and its ultimate ratification.

My name is John Seng, volunteer director and founder of the Maryland Coalition For Highway Safety.

Our 175-member organization unequivocally supports the enactment of HB1333, "Motor Vehicles – Modified Vehicle Exhaust System – Penalties," as introduced by Delegates Lehman, Palakovich Carr, Pena–Melnyk, Solomon, and Watson.

Our founding organizations include the *American Automobile Association* (AAA) Mid-Atlantic, the *Greater Olney Civic Association, The Route 210 Traffic Safety Committee* in Prince George's County and a group of Maryland home owner associations.

#### The Problem

Throughout Maryland, homeowners and motorists complain about exceedingly loud motor vehicles, be they automobiles or motorcycles on our roadways. Invariably, these excessive and illegal levels of noise result from the illegal installation of aftermarket, illegal exhaust systems. Operators may order these illegal parts online from out-of-state providers, but also from merchants within Maryland who knowingly – and defiantly – market and sell aftermarket products that are illegally installed.

We also believe that operators who exhibit a propensity to willfully break the law in modifying their vehicles may likely be more inclined to behave illegally while traveling on public roads: Speeding as well as reckless, aggressive and/or distracted driving.

Furthermore, the disregard for excessive noise extends into harm to human hearing, especially in vulnerable children and people suffering from post-traumatic stress disorder (PTSD).

Please do not fall victim to the lobbying interests of the Specialty Equipment Market Association (SEMA) which seeks to "guarantee your right to modify street cars, trucks, and motorcycles into dedicated race vehicles" without any regard for the likelihood that most miles driven by their race car enthusiasts take place on public roads through otherwise peaceful communities.

Marylanders, those traveling through our State and especially all people living here – your constituents – deserve enhanced protection from disturbances to peaceful living.

#### **Towards A Solution**

HB1333 puts more teeth in current Maryland laws by requiring equipment repair orders for vehicle operators cited with exhaust system violations, in addition to a citation charging operators with an offense, with stepped-up increase in fines for subsequent offenses.

GOOD AFTERNOON CHAIR BARVE, MR. VICE CHAIR AND COLLEAGUES. I AM ASKING YOUR FAVORABLE REPORT FOR HB 1333. THIS BILL REPEALS AND AMENDS A CURRENT STATUTE THAT PROHIBITS THE MOFICATION OF MOTOR VEHICLE EXHAUST SYSTEMS OR OTHER NOISE ABATEMENT DEVICES THAT INCREASE THE NOISE ABOVE THE MANUFACTURED LEVEL. IN PARTICULAR, HB 1333 PENALIZES INDIVIDUALS DRIVING SUCH A VEHICLE ON ANY HIGHWAY AND PROVDES AN EXEMPTION FOR CERTAIN REGISTERED HISTORIC MOTOR VEHICLES.

NOISE POLLUTION HAS BECOME AN AREA OF GREATER CONCERN IN RECENT YEARS BECAUSE OF ITS HAZARDOUS EFFECT ON OUR HEALTH, ENVIRONMENT AND QUALITY OF LIFE. NOISE PRODUCED BY VEHICLE TRAFFIC IS ONE OF THE MAJOR CAUSES OF NOISE POLLUTION AND HAS RISEN SUBSTANTIALLY WITH THE INCREASED NUMBER OF MOTOR VEHICLES ON HIGHWAYS. ALTHOUGH HB1333 IS NOT INTENDED TO CREATE A SIGNIFICANT REDUCTION IN THE LEVEL OF NOISE POLLUTION IN THE STATE, WE BELIEVE THIS IS A STEP TOWARD REDUCING SOME OF ITS NEGATIVE IMPACT ON OUR HEALTH. I RECENTLY RECEIVED A LETTER FROM ONE OF OUR CONSTITUENTS WHO LIVES WITH HIS FAMILY ON FLORAL DRIVE IN ADELPHI. FLORAL DRIVE IS IN A LOVELY, WELL-ESTABLISHED COMMUNITY OFF RIGGS ROAD WHERE MANY OF THE NEIGHBORS HAVE OWNED THEIR HOMES FOR DECADES. RIGGS ROAD IS A COUNTY ROAD OFF NEW HAMPSHIRE AVENUE AND A CUT THROUGH TO ROUTE 495. HE STATED:

"I HAVE BEEN SHOCKED AWAKE IN THE MIDDLE OF THE NIGHT BY THESE UNREASONABLY LOUD CARS RIPPING UP AND DOWN FLORAL DRIVE.... IN ADDITION TO MY LOSS OF SLEEP, THE PETS MANY OF US HAVE ARE ALSO ADVERSELY AFFECTED BY THIS BLARING LOUD NOISE AND IN SOME CASES CAN REQUIRE HOURS TO REGAIN THEIR NORMAL BEHAVIOR.

I HAVE COMPLAINED AND ASKED FOR HELP HERE IN MY NEIGHBORHOOD AGAINST THESE LOUD SPEEDERS WITH NO RELIEF FOR FAR TOO LONG. IT IS HIGH TIME THAT THERE BE SUBSTANTIAL PENALTIES ASSESSED AGAINST THESE INCONSIDERATE DRIVERS AND THAT THEY BE REQUIRED BY LAW TO MEET BOTH STATE AND LOCAL NOISE ABATEMENT STANDARDS."

CURRENTLY, THE ANNOTATED CODE OF MARYLAND TRANSPORTATION SECTION 22-609 PROHIBITS MODIFYING MOTOR VEHICLE EXHAUST SYSTEMS AND DRIVING VEHICLES THAT HAVE BEEN SO MODIFIED. UNFORTUNATELY, BECAUSE THERE ARE NO PENALTIES ATTACHED TO VIOLATING THIS STATUTE, ENFORCEMENT IS DIFFICULT FORCING CONSTITUENTS LIKE MINE TO CONTINUE TO SUFFER. BY AUTHORIZING A POLICE OFFICER TO ISSUE A "SAFETY EQUIPMENT REPAIR ORDER" AND FINE OF UP TO \$400 TO THE DRIVER OF A VEHICLE THAT VIOLATES THIS LAW, WE WILL BE TAKING A SMALL STEP TOWARD REDUCING NOISE POLLUTION IN MARYLAND. MORE IMPORTANTLY, WE WILL HAVE TAKEN A MAJOR STEP TOWARD REDUCING THE HEALTH HAZARDS CONSTITUENTS EXPERIENCE WHEN AWAKENED BY THE LOUD NOISE OF CARS ROARING THROUGH THEIR NEIGHBORHOODS AT NIGHT. The Rockville Mayor and Council thank Chairman Barve and the members of the House Environment and Transportation Committee for the opportunity to comment on HB 1333. We are thankful to Delegate Lehman for sponsoring this important legislation.

The Rockville Mayor and Council strongly support this legislation. As you consider the merits of this legislation, we urge the Committee to provide HB 1333 with a favorable report and forward it to the House floor for a vote.

HB 1333 increases the fines for modified exhaust systems and any other noise abatement devices in a motor vehicle. The penalty for a first violation is a \$200 fine, \$300 for the second, and \$400 for the third and subsequent violations. HB 1333 also requires the issuance of a repair order from the police officer that observes the vehicle that is in violation.

Excessive loud noise emitted from cars with modified exhaust systems is a major problem in Rockville that emerged during the pandemic. Our residents are very concerned about these frequent loud noises, which disturb our neighborhoods. The excessive noise is often accompanied with dangerous driving habits. Our Police Department is forced to devote more resources for traffic enforcement, while balancing other essential public safety needs. We support the stronger penalties in HB 1333, which are necessary to protect the community from this public safety issue.

The Rockville City Police have diligently enforced excessive noise emitted from vehicles with illegally modified exhaust systems. Since the fall of 2020, they have issued hundreds of enforcement actions, including citations, warnings, and Safety and Equipment Repair Orders. Additionally, in concert with Gaithersburg, Montgomery County, the State of Maryland, and the Maryland Transportation Authority Police Departments, they are collaborating to find solutions and respond to this challenging issue, which crosses jurisdictional borders.

I reside on Route 212, Riggs Road in Prince George's County and we are plagued with a dozen or more daily passages of vehicles with intentionally modified exhaust systems which emit loud noise including some that emit a continuous stream of backfiring. This disturbing practice has grown steadily over the last three years. Some of these vehicles can be heard nearly a mile away as they approach and another mile beyond after they pass our home. Dear Chairman Barve and Members of the Committee,

I strongly urge you to give a favorable report to House Bill (HB) 1333 to alter the penalty for modifying a motor vehicle exhaust system or noise abatement device while establishing certain exceptions.

I represent the furthest northern district of Prince George's County with three different legislative districts: 21, 23A, and 47B. We are adjacent to Montgomery, Howard, and Anne Arundel Counties. The district includes the unincorporated areas Adelphi, Beltsville, Calverton, Montpelier, South Laurel, West Laurel, Vansville and the municipalities of Laurel and College Park.

HB 1333 will provide an additional set of enforcement tools in Section 22–609. Previously, there were no financial deterrents for operating a vehicle with a modified exhaust system. The new fees will disincentivize drivers from modifying their vehicle's exhaust system. In addition to the fines established in HB1333, the bill authorizes the enforcing officers to issue an equipment repair order to the individual in an effort to restore the vehicle to the original design. The issuance of the repair order is key to ensuring the effectiveness of HB1333.

I do implore the committee to be mindful of the potential subjectiveness of the bill regarding officers and the officers' consideration of those in violation of Section 22-609. The committee should look to clarify what an officer must see or hear in order to begin the enforcement. In addition to the concern of potential subjectiveness in HB1333, the committee should seek detailed reporting of the violations and fines distributed to avoid a disparate impact on already marginalized communities.

Altered exhaust systems and vehicle noise complaints have plagued District 1. This is the right thing to do and for the reasons stated above, I respectfully request a **favorable report** for HB 1333. Thank you for your time and consideration.



I am a motorcyclist, backyard car enthusiast (shade tree mechanic), a farmer, a registered voter, and a member of ABATE of Maryland, Inc., the largest motorcyclist rights organization in the state of Maryland. I personally own multiple vehicles of all types. At the farm, we have motorcycles, trucks, cars, tractors, trailers, etc. ABATE represents the approximately 114,000 on road motorcycles that are registered in Maryland. We have chapters throughout the state and our members include a diverse cross-section of motorcycle riders in Maryland. We **DO NOT SUPPORT HB1333** as it adds additional penalties to a violation of one of the "tools in our toolbox" to prevent accidents.

The best way to not be involved in an accident is to avoid them. ABATE of Maryland, Inc. is immensely proud of our involvement throughout the years with the Motorcycle Safety Program. Education and training are the primary tools for motorcycle safety. However, one of our last resorts is to make a lot of noise so that we can be seen. Countless riders can tell you how they feel invisible until they must "crack the throttle" to make the exhaust a bit louder. The phrase "Loud Pipes Save Lives" has a lot of meaning to a considerable number of riders on the road today. The sudden, loud noise can mean the difference between making it home and spending the night in the hospital. I have personally witnessed this more times than I care to remember throughout Maryland, and across this country, as a motorcyclist in the past 30+ years as a rider.

In addition, many of us are car/truck/motorcycle performance enthusiasts. We are "gear heads." We enjoy seeing just how much we can improve the performance beyond what the original factory configuration provides. Many new motorcycle purchases start at twenty thousand dollars and go up. Most people then spend thousands of additional dollars customizing their motorcycles to suit their taste and comfort. We spend countless dollars on aftermarket and manufacturer provided, parts, tuner kits, high performance cams, ported heads, exhausts, and electronic control module updates. We upgrade tires, seats, mufflers, complete exhausts, ECM's, handlebars, foot pegs, headlights, heated gear, etc. All to customize our rides to our taste and to make the riding experience more enjoyable and SAFER. A rider that has tweaked his motorcycle (or car or truck) to fit his individual body and his style is more comfortable, more relaxed, has a better handling vehicle, and an overall more enjoyable experience. I am a member of numerous other motorcycle related organizations and when we get together, our conversations always turn to what we have changed on our motorcycles (and cars/trucks) lately. This is true for Harleys, Hondas, BMWs,

Triumphs, Fords, Chevy's, Dodge, you name it. There are 2 million registered vehicles on the road in Maryland. If you conservatively assume that 20% of the registered vehicles have modified exhausts, this bill could be affecting 400,000 vehicles or more. It is safe to say that at least 50% of motorcycles have modified exhausts. That number alone would represent 57,000 registered vehicles.

All on-road vehicles could be affected by this penalty provision. The stock configuration of vehicles does not produce the optimum performance or configuration for all people. Some people seek performance enhancements for additional power for towing, long distance cruising/riding, comfort, better fuel economy, and some for plain personalization of their vehicle.

## **REVIEW AND ANALYSIS:**

This legislation seeks to mandate a tiered penalty for a person who modifies an exhaust system or other noise abatement device in such a way that the noise emitted by the motor vehicle exceeds the original manufactured standards. The legislation also requires a police officer, who stops a motor vehicle for this violation, to issue a citation and a Safety Equipment Repair Order (SERO).

Under current law, a police officer has the discretion to stop a motor vehicle for a traffic or equipment violation. The police officer has the ability to issue a warning, citation, or SERO based on the officer's observations. While an SERO can be issued for a modified exhaust system, an SERO cannot be issued for noise. Motor vehicles registered in another state are not subject to vehicle equipment laws of this state and cannot be issued an SERO.

HB 1333 mandates that a police officer shall issue both a citation and SERO to the driver of a vehicle stopped for a modified exhaust system. By requiring the officer to issue the citation, the legislation is requiring the officer to be able to appear in court and demonstrate automotive, model specific knowledge on the original manufacturers exhaust standards. Unfortunately, most police officers can tell you that an exhaust system is loud but very few will be able to demonstrate the knowledge required to support a conviction of this offense.

The legislative mandate puts the police officer in an untenable situation.
