Dear Chairwoman Kelley and Members of the Senate Finance Committee:

The Washington Suburban Sanitary Commission (WSSC Water) **SUPPORTS** HB 400 – Washington Suburban Sanitary Commission – Hiring and Promotion Preferences - Veterans and Their Spouses PG/MC 106-22.

HB 400 repeals the current statute pertaining to the WSSC Water competitive selection process for appointments of veterans and adopts the processes utilized by the State of Maryland.

Under current law, in order for a veteran to be eligible to receive preference in a competitive selection process for appointment, the individual must be an honorably discharged veteran of the United States armed forces who was a bona fide resident of the State of Maryland when the individual entered the armed forces.

HB 400 will remove the residency requirement for a veteran to be eligible to receive preference in hiring and promotions, and expand the eligibility to individuals who have received an honorable discharge or certificate of satisfactory completion of military service to include: The National Guard; the military reserves; the Commissioned Corps of Public Health Service; and the Commissioned Corps of the National Oceanic and Atmospheric Administration. In addition to eligible veterans, the bill also authorizes WSSC Water to grant a preference to the spouse of an eligible veteran who has a service connected disability or the surviving spouse of a deceased eligible veteran.

WSSC Water requests a **FAVORABLE** report for HB 400 to enhance our competitive hiring and promotion processes for individuals who served in the armed forces and their spouses.

Washington Suburban Sanitary Commission – Hiring and Promotion Preferences – Veterans and Their Spouses PG/MC 106-22

House Bill 400 repeals language in current law that creates a hiring preference at Washington Suburban Sanitary Commission (WSSC) for a veteran of the United States armed forces who was a bona fide resident of the State when the veteran entered the Unites States armed forces. The bill substitutes language that authorizes WSSC to grant a preference in hiring and promotion to: (1) an eligible veteran; (2) the spouse of an eligible veteran who has a service-connected disability; or (3) the surviving spouse of a deceased eligible veteran. The term "eligible veteran" is defined to mean a veteran of any branch of the armed forces of the United States who has received an honorable discharge or certificate of satisfactory completion of military service, including: (1) the National Guard; (2) the military reserves; (3) the Commissioned Corps of the Public Health Service; and (4) the Commissioned Corps of the National Oceanic and Atmospheric Administration. The bill is identical to § 3-714 of the Labor and Employment Article, which applies to State agencies.

The County supports this bill and respectfully requests that the Finance Committee give the bill a favorable report.
