Amendments to HB 969 State Board of Dental Examiners – Membership, Training, and Disciplinary Processes – Revisions

Requested by Daniel T. Doherty, Jr. on behalf of the Maryland State Dental Association

Amendment No. 1: On Page 1, line 2 strike “**Membership,**”; in line 4 strike beginning with “nominations” through “Examiners” in line 5; On Page 2 strike lines 4-11 in their entirety and in lines 12, 18, 24, and 26 strike the brackets; also in lines 12, 18, 24, and 26 strike “(5)”, “(6)”, “(7)” and “(8)” respectively; on page 2 in line 22, strike “**AT LEAST**”; on page 3 strike lines 4 and 5; in lines 6, 7, 8, 13, 18, 19, 20, 22, and 25, strike the brackets; in line 7 strike “**SUBMIT**” and in line 8 strike beginning with “**FOR**” through “**PARAGRAPH**” in line 9; strike lines 16 and 17; in line 19 strike “**SUBMIT**” and in line 20 strike beginning with “**FOR**” through “**PARAGRAPH**” in line 21.

Amendment No. 2: On page 4 in line 2 strike from “**FOR**” through “**YEAR**”, and insert “**AT LEAST 3 HOURS EACH TERM UNDER THE AUSPICES OF THE OFFICE OF THE MARYLAND ATTORNEY GENERAL**”; strike following “(I) in line 10 through “(II)” in 13; in line 16 strike “(III)” and insert “(II)”.

Amendment No. 3: On page 5 in line 20 after “**IF**”, and insert “**, WITHOUT GOOD CAUSE,**”; in line 22 after “**SUBSECTION,**” insert “**A COURT OF COMPETENT JURISDICTION MAY ENTER**” and after “**DECISION**” strike “**SHALL BE**”.

Amendment No. 4: On page 5 strike after “(B)” in line 28 through 29 on page 6 and insert: “**NOTICE SHALL BE PROVIDED THAT THE LICENSEE, UPON WRITTEN REQUEST, SHALL BE ENTITLED TO A SHOW CAUSE HEARING WITHIN 30 DAYS OF THE BOARD’S RECEIPT OF A REQUEST TO SHOW CAUSE WHY THE LICENSEE’S LICENSE SHOULD NOT BE SUSPENDED .**”

On Page 6 in line 31 strike beginning with “**AN**” through “**APPLICABLE**” in line 32 and insert “**THE EVIDENTIARY SHOW CAUSE HEARING.**”; and On page 6 strike from line 33 through Page 7 line 17.
