## FAVORABLE Testimony - HB 0701 – Governor's Health Emergency Powers - Repeal Nelda Fink, 8372 Norwood Dr, Millersville MD District 32

I completely support and am in favor of all the changes proposed in HB 0701 as they are currently proposed by Delegate Cox, so that our great state of Maryland (also known as the **Free State**!) can have have the freedom to live our lives here on the land and soil as God has intended and without government overrule.
