Problem:

- Vaccination requirements are burdensome and a violation of people's rights
- Unvaccinated people are currently unable to fully participate in society. Due to COVID-19 vaccine requirements, they may be barred from:
 - Employment
 - Continuing their education at educational institutions
 - Receiving proper medical care
 - Frequenting businesses
 - Attending events

About COVID-19 Antibody Tests:

- These tests have come into popular use as tools to determine a prior infection
- If the antibody test is positive, it indicates that antibodies have been produced in response to COVID-19
 - This indicates an immune response to the disease

What this bill does:

For COVID-19 and other influenza-like illnesses:

- An individual may show proof of a positive antibody test to satisfy any vaccination requirement established by:
 - State or Local Government
 - Employers
 - Educational Institutions
 - Medical Facilities
 - Business Establishments
 - Non-profit Organizations
 - Events

Natural Immunity:


- Antibodies created naturally to COVID-19 are better, more dependable, and equal to or more powerful than any industrially manufactured vaccine
 - A 2021 Denmark Study of unvaccinated individuals demonstrated that 99% of individuals that contracted COVID-19 had SARS-CoV-2 specific antibodies and had robust adaptive immune responses afterwards, regardless of disease severity
 - An 8 month study in Georgia determined that broad and effective immunity persists long-term following COVID-19 infection

Natural Immunity vs Vaccination Immunity

- A 2022 study in Sweden showed waning immunity from all vaccines considered
 - "The findings from this study show there was a progressive waning vaccine effectiveness of BNT162b2 against SARS-CoV-2 infection of any severity, with no vaccine effectiveness detected from 7 months onwards"




Natural Immunity vs Vaccination Immunity

- A 2020 Primate study showed Moderna's Vaccine was missing a CD8T cell response, which is critical for a complete immune response
- A 2021 Israeli study of the Pfizer vaccine determined that "natural immunity confers longer lasting and stronger protection against infection, symptomatic disease and hospitalization caused by the Delta variant of SARS-CoV-2, compared to the BNT162b2 two-dose vaccine-induced immunity."
 - "The advantageous protection afforded by natural immunity that this analysis demonstrates could be explained by the more extensive immune response to the SARS-CoV-2 proteins than that generated by the antispike protein immune activation conferred by the vaccine"

Natural Immunity vs Vaccination Immunity

- A 2021MMWR Report by the CDC showed a Delta variant outbreak in Massachusetts
 - 74% of cases occurred in previously vaccinated individuals
 - 79% of previously vaccinated individuals were symptomatic



Benefits of the Bill

- More individuals would be able to live and work without undue restrictions
- Natural immunity would be given the credit that it is due
- If vaccine requirements are implemented, the entity imposing the requirements should follow the science and allow for positive antibody tests to count as part of any requirement
