Senators Smith and Waldstreicher,

I am writing you today in support of Golf Cart legislation SB076 for Cobb Island, Maryland 20625.

Cobb Island is a unique community that lends itself to a more laid-back lifestyle. Many in our community promote this feeling by driving golf carts on the island, albeit not legally. With the cost of gas alone the practice has gained more traction than ever before. However, the law does not allow for driving golf carts on the county roads and citizens can be ticketed by the police for doing so. My goal is to seek legalization, to make legal, driving golf carts on Cobb Island as a mode of transportation on the island.

Due to Cobb Island's isolated nature at the end of a dead end road it is ideal for this consideration. The Island's speed limit is already set at 25 miles per hour which makes it perfect for the safe use of golf carts. This concept is not meant to eliminate automobile traffic on the island. It merely is meant to promote a "greener" less congested approach to on-island transportation. While the following list is not meant to be all inclusive I do believe some rules must apply. I offer the following as possible considerations as seen in other communities having obtained the "Golf Cart Community" status.

Golf Carts could be allowed to be driven on Cobb Island up to and including the County's
refuse site, Breeze Farm. The speed limit should be adjusted from that landmark
accordingly. We have a number of physically challenged individuals on the island that
would be helped considerably by extending the 30 MPH speed limit to Breeze Farm.

- 2. A sign could be posted at the entrance of Cobb Island or Breeze Farm advising drivers they are entering a Golf Cart community and caution should be used when driving on the island.
- 3. Speed limit signs should be posted prominently at the entrance of Cobb Island announcing the 25 mile per hour limit on the island.
- 4. All golf cart operators on Cobb island should be a minimum age and possess some level of driving training or acumen.
- 5. Before golf carts may be operated on Cobb Island roads and streets, the owners thereof should be required purchase and maintain liability insurance insuring against personal injury and damage to property of any nature relative to the operations of golf carts on Cobb Island roads and streets.

While this list is not meant to be all inclusive it is my attempt to provide possible solutions to provide a favorable outcome for your vote.

Dear Chairman Smith and Committee Members:

The Maryland Department of Transportation (MDOT) takes no position on House Bill 76 but offers the following information for the Committee's consideration.

Senate Bill 76 allows Charles County's County Council to designate that county highways on Cobb Island which have a posted speed limit of 30 miles per hour or lower may allow the operation of golf carts by licensed drivers during certain hours. The golf cart operation is subject to certain restrictions such as requiring lighting devices, operating it only between dawn and dusk, that the operator must hold a driver's license, and to keep the golf cart as far to the right as feasibly possible.

The Maryland Department of Transportation Motor Vehicle Administration (MDOT MVA) does not provide vehicle registration for golf carts in the State, including in the other local jurisdictions on Maryland's eastern shore that already have exemptions for the operation of golf carts on certain highways under certain conditions and meeting certain criteria. State highways crash data reports also do not have a categorization in accident reports that allow tracking of vehicle accidents in the State specifically involving golf carts.

The MDOT MVA thus does not find any impact to operations or to highway safety in the State under Senate Bill 76. As a result, the MDOT MVA wishes to convey that Senate Bill 76 represents a local policy change for a local jurisdiction that would match its peers of similar vehicle traffic levels and patterns if enacted by the Maryland General Assembly.

The Maryland Department of Transportation respectfully requests the Committee consider this information when deliberating Senate Bill 76.
