As a parent of a child currently enrolled in an outdoor nature program at Irvine Nature Center, I write to urge you to vote in favor of HB376 to establish an Outdoor Preschool Licensing pilot.

My husband and I were initially drawn to the outdoor preschool program at Irvine Nature Center because as nature lovers and environmentalists we wanted our son to have as much time in nature as possible. At the time, we did not realize how beneficial it would be for our son's unique challenges. He is 3.5 years old and was diagnosed with sensory processing disorder. He receives occupational therapy weekly to help him cope with his neurodivergent challenges. However, his time outdoors at the preschool program at Irvine Nature Center has become an important part of his therapy. The benefits of spending time in nature on brain processing are well-documented and I can personally attest that the outdoor preschool program has been invaluable to his growth.

Outdoor preschool should not be only accessible for those with financial means. Further, access to quality time in nature has been segregated along racial lines in Maryland for generations. HB 376 would help to shift this imbalance by paving the way for state scholarships for all students to experience outdoor preschool.

As Baba Dioum said, "in the end we will conserve only what we love; we will love only what we understand; and we will understand only what we are taught." Investing in teaching our children the value of nature at a young age will ensure the next generation of Marylanders grow up with an appreciation and love of our natural world.

HB376 is a critically important bill for a number of reasons, including:

The Nature Conservancy (TNC) supports HB 376 offered by Delegate Guyton. TNC is a global conservation organization working to conserve the lands and waters on which all life depends. In Maryland, our work focuses on delivering science-based, on-the-ground solutions that secure clean water and healthy living environments for our communities, reducing greenhouse gas emissions and increasing resilience in the face of a changing climate. We are dedicated to a future where people, of all generations, and nature thrive together.

Under current law, the Office of Child Care (OCC) cannot license outdoor preschool and childcare programs unless they have indoor classroom or building space. As such, the OCC has no path for licensing or regulating these teachers and the children they serve. This has cut off access to outdoor preschools for low-income families, as state vouchers can only be used in licensed, accredited preschool and childcare programs. Non-licensed programs can also only operate for certain amounts of time; these part-day programs often fail to meet working families' needs, which has resulted in outdoor preschool programs becoming predominantly children from middle-to-upper-income caucasian families. These programs also cannot access the services and funding needed to support children with special needs. Unlicensed teachers are not vetted for credentials that may impact children's health and safety while participating in the programs. Without licensing, Maryland State Department of Education professional development funding is not accessible to support professional training for nature-based early childhood educators. Through licensing outdoor preschool programs, HB 376 seeks to provide equitable, safe, and inclusive access to these high quality, beneficial early learning programs.

Outdoor preschools provide a fully immersive outdoor learning program using developmentally appropriate, nature-based curriculum and approaches to meet young children's educational, health, and safety needs. These programs document and assess learning, conduct parent/teacher conferences, and offer community-building events with families. Licensing will make certain that these high-quality programs can access the necessary funds, services, training, and oversight to meet families' needs as well as provide for participating children's unique health and safety needs in an outdoor learning environment.

TNC recognizes the value of accessible, nature-based educational opportunities for Maryland's youth. We commend Delegate Guyton for introducing this bill, which ensures that these opportunities are equitable, safe, and inclusive for all children and families.

Therefore, we urge a favorable report on HB 376.

Family League of Baltimore (Family League) supports House Bill 376 as it would establish the Outdoor Preschool License Pilot Program in the Maryland State Department of Education to license outdoor, nature-based early learning and childcare programs to expand access to affordable, high-quality early learning programs and to investigate the benefits of outdoor, nature-based classrooms.

As the early years of education are the time at which children are most impressionable, experiential learning during preschool can have positive long-term effects. For instance, outdoor learning can start healthy habits and lifestyles for young people. With advancements and increased reliance upon technology, children are spending less time engagement in daily outdoor activity. Youth are missing out the critical physical, mental, and social benefits these healthy pastimes can promote.

Additionally, outdoor learning can improve school performance by exposing child to handson experiences at a younger age. This is particularly important for families in Baltimore who experience a lack of exposure to enriched learning which can correspond to lowperformance rates. Younger students in the City of Baltimore could receive help from outdoor learning as it sets a tone for successfully performing in school.

Marginalized communities are not aware of the benefits of outdoor preschool learning. The number of early childhood learning centers that have closed since the pandemic have prevented children from receiving critical opportunities to learn. An outdoor preschool offers alternative forms of childcare that to support families in Baltimore. This benefit for inner-city kids would also promote environmental literacy.

As the designated Local Management Board for the City of Baltimore, Family League works collaboratively to support data-informed, community-driven solutions to align resources to dismantle systemic barriers that limit the possibilities for children, families, and communities. Our policy focus is also guided by and in support of the Governor's Office of Crime Prevention Youth and Victim Services' Results for Child Well-Being. Through our strategic planning process, we have prioritized three of these results areas, focusing on the success of Baltimore's children in school; the economic stability of families; and the safety of communities for children, youth, and families. We support HB376 in particular because of its alignment with the result areas that work to ensure "Children Are Successful in School."

Dear Chair Atterbeary, Vice Chair Washington, and Members of the Ways & Means Committee;

The Maryland Out of School Time Network (MOST) is a statewide organization dedicated to closing opportunity gaps by expanding both the quantity and quality of afterschool and summer learning opportunities for school-aged young people. MOST is one of the fifty statewide networks supported by the Charles Stewart Mott Foundation and serves as Maryland's affiliate to the National Afterschool Association.

MOST Network strongly endorses the creation of an Outdoor Preschool Licensing Pilot Program in Maryland. Beyond providing additional protection to students amid the ongoing pandemic, these outdoor learning environments present a unique opportunity to improve students' physical, social, and emotional well-being at a critical age in their psychological development.

Schools across the country have struggled to maintain covid-related health and safety measures in traditional learning environments. Social distancing is difficult in crowded classrooms and enforcing mask procedures for young children remains a difficult task for even the most diligent of teachers. An outdoor classroom mitigates these concerns by providing more airflow and space for students and faculty. Even without the pandemic, young children would stand to benefit substantially from the fresh air, sunlight, and exercise that these learning environments provide.

Yet the most promising aspects of outdoor preschool are its contributions to young students' social and emotional well-being. Early childhood is a time when kids are discovering the most fundamental lessons about themselves and their relationships with others. In contrast to a traditional learning environment, outdoor learning spaces allow students to interface with the world around them in a way that promotes autonomy, creativity, and problem solving. When allowed to do so with their peers, this experience can yield valuable lessons about collaboration and risk management.

Such experiences cannot be taken for granted in a time when virtual spaces now dominate students' time both in and out of the classroom. The pandemic illustrated the revolutionary implications of digital education tools, yet it also reminded us of the value that hands-on, face-to-face instruction will continue to have when educating young people. The General Assembly would be wise to support the creation of learning environments that makes use of children's natural inclination towards this kind of learning.

Dear Delegate Forbes and Senator West,

My name is Katie Rooney and I am the Director of Early Childhood Education at Irvine Nature Center in Owings Mills. I am also a resident of your districts.

I urge you to vote in favor of HB376 to establish an Outdoor Preschool Licensing pilot and thereby increase access to high quality child care and learning experiences that nurtures the whole child.

Over the last 13.5 years I have had the immense pleasure of working with young children, primarily 3 to 7yrs old, in either nature-based preschool programs or at a charter school in Baltimore city. For the last 4 years I have been the Director of Early Childhood Education at Irvine, directly overseeing our Nature Preschool. At Irvine, we are fortunate enough that we have two indoor classrooms and can therefore be licensed by the state. While we have these classrooms and do use them, we operate primarily outdoors, spending the majority of both the half and full day classes in the woods, meadows, and wetlands.

As a teacher, a director, and now as a parent of an outdoor preschooler, I have witnessed the incredible value and role of play and learning outdoors.

As a parent, nothing means more to me than my 4 yr old's lifelong health, happiness, and ability to thrive and grow into who she is. Without a doubt, the days she is the most in tune with her body, her soul, and with the world around her are her days at Nature Preschool. She is more inquisitive, calmer, more compassionate, and more likely to persevere in the face of challenge. All children deserve to feel that way, regardless of their race or socioeconomic status.

Taking childcare and learning outside...

- helps combat obesity and promotes physical health including improved eye sight.
- exposes children to sensory-rich experiences which offer endless opportunities for strengthening skills in all areas of development. Not just what they can see, feel, hear, and taste, but also their vestibular and proprioceptive senses. So much so that occupational therapists often create obstacle courses and interventions that often mimic the uneven terrain and opportunities to climb and hop outdoors.
- supports cognitive development, especially in regards to boosting creativity and problem-solving! Nature is constantly changing, providing an endless supply of new materials to explore and use, new play ideas, and new questions to think about. Constant change also means new problems arise naturally and children adapt and find solutions to regular meaningful problems regularly. All of this in turn leads to better executive functioning and increased confidence.
- allows children to experience first-hand STEM and environmental science concepts.
- encourages children to move and be in more developmentally appropriate ways. It's hard to be too loud outside or move around too much!





- enables children with developmental needs or learning differences to flourish! For some of these children, the open-ended nature of outdoor programs allows them to better develop skills, especially social emotional skills like interacting with peers and self-regulation.
- improves children's mental and psychological health.
- nurtures a child's sense of connection with the natural world, increasing the likelihood of future acts of stewardship

For all of these reasons and more, outdoor preschool and child care is clearly beneficial. But why do we need these types of programs to be licensed?

Expanding child care licensing to include exclusively outdoor programs also:

- increases the number of licensed child care programs, a desperate need for Maryland families. Just this past year we had a waitlist of over 30 families for our program.
- ensures that outdoor preschool programs are safe and of high quality through regulatory oversight and by instituting teaching and safety standards to mitigate risks and inform best practices unique to outdoor learning.
- Empowers nature-based early childhood educators to access quality professional development through state funds.
- Helps combat the current inequity in access to outdoor programming. The current limitation on number of hours an unlicensed program can operate combined with the ineligibility to participate in the Child Care Scholarship program, makes outdoor programs either too expensive or not feasible with their need for full time care.

When I think about what this bill is capable of doing, I think about the child who needs to move and whose voice is bombastic and pitched. Inside he would be labeled as challenging, disruptive, or worse. Outside he has space to be, he climbs freely, and that boisterous voice is a leading cry that organizes his peers in games or cooperative work.

I think of the child of the single mom, quiet and hesitant to try new things. She lives in a small apartment with no yard or green space. At Nature Preschool she gets regular access to all things alive. She builds her connection to the land and starts to see herself as part of it.

I think of the child learning English, their family recently immigrated. He is reserved and unsure how to communicate. Outside, the language of play is so universal he can jump right in and share.

I think of the child with a congenital muscular condition who has difficulty walking over curbs, up a step stool, or down a hill. Outside, her play and life activities are filled with therapy as she chases after friends in their inventive games over logs, rolls down hills, and scales mulch piles. She has ample opportunities to grow stronger and more confident each day.

I think of the child whose father suddenly and unexpectedly died. Outside he has space to grieve in both big and small ways. When it becomes too much he can run, push the hurt away as he rolls large stumps to help him climb, and splash in the mud to see he can still affect change, that he does indeed have some power and control. Seeking connection, he looks for frogs and salamanders, caring for them gently and teaching his classmates to do the same. Outside, he has space to breathe and can feel the cooling wind and rain. As the seasons and weather changes, he learns that no time of darkness lasts forever, that storms pass and the sun does eventually return.





I think of the preschool class I led on monthly nature learning and play trips at Irvine. Kids that already carried so much on their little backs: homelessness, food insecurity, trauma upon trauma. I think of how we ran out to play in trickling rain, capturing it on our tongues, filling buckets, making dams. The loudest most explosive child squealed with delight. And suddenly all the tenseness of the indoor lesson melted away. Their teacher whispered to me, "This is wonderful. They need this so much. They never get to really play and be kids."

For these children and all others, I support HB376.

If you're unsure, head outside, find a tree, and breath deep. Then vote for HB376.

My name is Amy Beam. I am a nature educator and passionate advocate for helping children and their caregivers to spend time in nature. I have been teaching preschool and school-aged children since 1977 in Maryland and Washington DC. I am the recipient of the 2015 Margaret O'Neill Early Childhood Nature Educator Award and my work has been featured in the PBS documentary Mother Nature's Child, The Washington Post, Montessori Life, The National Association for the Education of Young Children's publication The Great Outdoors, the cable television show Emerald Planet, and others.

Last summer my daughter spent 6 weeks attending an all outdoor nature camp in Baltimore City. It was a truly unique and exciting experience, not just for her but for me as well. She woke up every morning enthusiastic to return to the forest, her friends, and her teachers. Her time there spent learning, playing, and socializing perfectly preparing her to transition smoothly to preschool this past fall. The organizers of the Fox and Heron Summer Camp thought of everything! If there was a heat advisory that day, the campers would stay under the shade and cool of the woods. They partnered with a nearby licensed daycare provider to provide daily meals. Camp ended at 2:00 PM everyday to avoid both the hottest part of the day and the increased chance of lightning that occurs with afternoon summer showers. And best of all, they provided young learners with a remarkable curriculum replete with lesson blocks on caring for animals, gardening, and farming.

This type of outdoor learning experience should be abundantly available year-round in Maryland. Dear House Committee on Ways and Means:

My family moved to two acres in Columbia, Maryland to open a Forest Preschool after having spent a year holed up in our Baltimore City home. We were surprised to learn that we could not become licensed despite the many known benefits of a childhood spent mostly outdoors. We were able to open only by operating as a private faith-based club, outside the jurisdiction of state legislation but also without access to the resources and guidance that licensing would provide. Our program has been wildly popular, and we will hit full enrollment next month, having only been open since August 2021.

Despite our daily dog walks during the pandemic, my children first approached the two-acres of wild land in our new backyard with trepidation. They didn't want to play outside. They were reluctant to take their shoes off and let the sand in our small creek surround their toes. They tripped over branches and demanded screen time.

Months later, I can't get them to come inside. Every morning my daughter spends at least fifteen minutes crouched in the creek, quietly observing and interacting with water, sand, and water skippers. My son spends his mornings skillfully running through the forest, at five he is always in sight but loves the freedom of not being within arm's distance. They point out frog sounds and know the names of our local plants. They are physical and observant in ways that could not be cultivated when their days were spent indoors.

Outdoor preschool has made my children more confident, improved their gross motor skills, and taught them to love and appreciate our world. This hasn't been at the expense of typical preschool skills. My son learned his letters and has begun reading in Forest Preschool. They trace letters in the snow, paint letters on leaves, and read stories with their teachers and each other daily.

Math is also naturally integrated into their curriculum. They count leaves to identify plants. They count and collect their magnifying glasses, pots and pans each day – storing them for the next adventure. They learn about angles as they build kid-sized pulley systems with ropes and buckets, urging their treasures to travel from tree to tree by holding their ropes higher or lower as needed.

Outdoor preschool is especially timely in the context of COVID-19. I am worried about my vaccine-ineligible children spending their days in crowded, indoor preschools. How effective is a mask donned by a three-year-old for six to eight hours? Amplifying fears that young children cannot properly wear masks for extended periods of time are other mask-related concerns. My daughter has speech delays. I do not believe these delays are mask related as they run in my family, but I do worry that spending her preschool years unable to watch how sounds should be properly produced will exacerbate this delay. At Forest School, she is able to roam and learn unmasked while also staying safer from COVID than her masked, indoor-oriented peers.

Licensing outdoor preschool is an important step to connecting young children with the world around them while helping them to navigate shifting and variable terrains, temperatures and challenges.

I hope that you will support this important effort and vote in favor of HB376!

We experienced the benefits of forest-based learning firsthand during the pandemic. While public schools moved online, forcing young children into long hours of screen time, we did the opposite: we enrolled our children (then ages 9 and 7) in a forest-based program. It offered our children a safe, outdoor educational environment, the guidance of highly skilled professionals, and opportunities to learn, grow, and play alongside the same group of fellow students each week.

The program became the highlight of our kids' week. One memorable day, my daughter dredged out clay from a creek, crafted it into objects, dried them in the sun, set up a store, and sold them to her fellow students. Geology, history, art, math, and business all in one afternoon. She and her older brother imagined how native Marylanders might have used that clay, and it sparked conversations about how indigenous peoples used the same creek and lived in the same woods that my children now explore.

Being in the forest gives our kids confidence, a sense of adventure, and a willingness to try new things. The forest provides unique opportunities for children to foster resilience; take risks; develop stamina; build physical, mental and emotional strength; and discover who they are. I will never understand *exactly* what happens in the forest. But I do know this: my children emerge dirty, exhausted, and happy in all the ways that truly count. They've spent the day engaged in the important work of childhood.

My name is Katie Rooney and I am the Director of Early Childhood Education at Irvine Nature Center in Owings Mills. I am also a resident of your districts.

I urge you to vote in favor of HB376 to establish an Outdoor Preschool Licensing pilot and thereby increase access to high quality child care and learning experiences that nurtures the whole child.

Over the last 13.5 years I have had the immense pleasure of working with young children, primarily 3 to 7yrs old, in either nature-based preschool programs or at a charter school in Baltimore city. For the last 4 years I have been the Director of Early Childhood Education at Irvine, directly overseeing our Nature Preschool. At Irvine, we are fortunate enough that we have two indoor classrooms and can therefore be licensed by the state. While we have these classrooms and do use them, we operate primarily outdoors, spending the majority of both the half and full day classes in the woods, meadows, and wetlands.

As a teacher, a director, and now as a parent of an outdoor preschooler, I have witnessed the incredible value and role of play and learning outdoors.

As a parent, nothing means more to me than my 4 yr old's lifelong health, happiness, and ability to thrive and grow into who she is. Without a doubt, the days she is the most in tune with her body, her soul, and with the world around her are her days at Nature Preschool. She is more inquisitive, calmer, more compassionate, and more likely to persevere in the face of challenge. All children deserve to feel that way, regardless of their race or socioeconomic status.

Taking childcare and learning outside...

- helps combat obesity and promotes physical health including improved eye sight.
- exposes children to sensory-rich experiences which offer endless opportunities for strengthening skills in all areas of development. Not just what they can see, feel, hear, and taste, but also their vestibular and proprioceptive senses. So much so that occupational therapists often create obstacle courses and interventions that often mimic the uneven terrain and opportunities to climb and hop outdoors.
- supports cognitive development, especially in regards to boosting creativity and problem-solving! Nature is constantly changing, providing an endless supply of new materials to explore and use, new play ideas, and new questions to think about. Constant change also means new problems arise naturally and children adapt and find solutions to regular meaningful problems regularly. All of this in turn leads to better executive functioning and increased confidence.
- allows children to experience first-hand STEM and environmental science concepts.
- encourages children to move and be in more developmentally appropriate ways. It's hard to be too loud outside or move around too much!





- enables children with developmental needs or learning differences to flourish! For some of these children, the open-ended nature of outdoor programs allows them to better develop skills, especially social emotional skills like interacting with peers and self-regulation.
- improves children's mental and psychological health.
- nurtures a child's sense of connection with the natural world, increasing the likelihood of future acts of stewardship

For all of these reasons and more, outdoor preschool and child care is clearly beneficial. But why do we need these types of programs to be licensed?

Expanding child care licensing to include exclusively outdoor programs also:

- increases the number of licensed child care programs, a desperate need for Maryland families. Just this past year we had a waitlist of over 30 families for our program.
- ensures that outdoor preschool programs are safe and of high quality through regulatory oversight and by instituting teaching and safety standards to mitigate risks and inform best practices unique to outdoor learning.
- Empowers nature-based early childhood educators to access quality professional development through state funds.
- Helps combat the current inequity in access to outdoor programming. The current limitation on number of hours an unlicensed program can operate combined with the ineligibility to participate in the Child Care Scholarship program, makes outdoor programs either too expensive or not feasible with their need for full time care.

When I think about what this bill is capable of doing, I think about the child who needs to move and whose voice is bombastic and pitched. Inside he would be labeled as challenging, disruptive, or worse. Outside he has space to be, he climbs freely, and that boisterous voice is a leading cry that organizes his peers in games or cooperative work.

I think of the child of the single mom, quiet and hesitant to try new things. She lives in a small apartment with no yard or green space. At Nature Preschool she gets regular access to all things alive. She builds her connection to the land and starts to see herself as part of it.

I think of the child learning English, their family recently immigrated. He is reserved and unsure how to communicate. Outside, the language of play is so universal he can jump right in and share.

I think of the child with a congenital muscular condition who has difficulty walking over curbs, up a step stool, or down a hill. Outside, her play and life activities are filled with therapy as she chases after friends in their inventive games over logs, rolls down hills, and scales mulch piles. She has ample opportunities to grow stronger and more confident each day.

I think of the child whose father suddenly and unexpectedly died. Outside he has space to grieve in both big and small ways. When it becomes too much he can run, push the hurt away as he rolls large stumps to help him climb, and splash in the mud to see he can still affect change, that he does indeed have some power and control. Seeking connection, he looks for frogs and salamanders, caring for them gently and teaching his classmates to do the same. Outside, he has space to breathe and can feel the cooling wind and rain. As the seasons and weather changes, he learns that no time of darkness lasts forever, that storms pass and the sun does eventually return.

And suddenly all the tenseness of the indoor lesson melted away. Their teacher whispered to me, "This is wonderful. They need this so much. They never get to really play and be kids."

For these children and all others, I support HB376.

If you're unsure, head outside, find a tree, and breath deep. Then vote for HB376.

The North American Association for Environmental Education (NAAEE) is pleased to join with partners and colleagues throughout Maryland, and across the country, in expressing enthusiastic support for HB 376, which would establish a pilot program to license outdoor preschools in Maryland.

Maryland has long been a leader in providing outdoor learning opportunities to students across the state in its K-12 system, and this legislation would extend that commitment, and its benefits, to the state's youngest learners.

Research overwhelmingly confirms that nature and outdoor learning provide a wide range of benefits to children's healthy development, including:

- Promoting physical activity and physical development,
- Boosting children's mental health,
- Promoting the development of self-regulation skills,
- Improving academic performance, and
- Reducing stress.

Because of these benefits, nature-based, outdoor preschools in the United States have experienced dramatic growth across the US, growing 25-fold over the past decade according to NAAEE research. There are now nearly 700 such schools across the US, and they are available in nearly every state.

Unfortunately, the same research reveals that these benefits are not equally available to all children. Children of color, multiple language learners, and children with disabilities are all under-represented in nature-based programs today. Licensing outdoor preschools could provide greater, and more equitable, access to this innovative and effective approach to early childhood education.



NAAEE closely monitored and supported similar legislation in Washington State, which established a pilot program to license outdoor preschools in the state. The outcomes of that pilot were very positive, with the state expanding access to outdoor learning for young children while demonstrating that the pilot outdoor programs effectively ensured child safety and kindergarten readiness. As a result, in 2021 Washington adopted legislation to permanently authorize the state's Department of Children, Youth, and Families to license outdoor preschool programs. We believe Maryland can leverage the research and licensing standards developed in the Washington pilot to bolster and streamline an outdoor preschool pilot in Maryland.

The dramatic growth in popularity in outdoor learning for young children reflects the effectiveness of these programs. All families in Maryland should have the opportunity to choose outdoor learning for their children. We encourage you to support HB 376 to provide safe, effective, and inclusive outdoor education options to Maryland families with young children.

Dear Delegate Fisher and Ways and Means Committee Members,

Greetings. As a retired director of a large childcare center in Calvert County and a former MSDE grant appointed Early Childhood Liaison for Calvert County Public schools, I have learned that all children, including those with developmental delays and special needs learn best when they have an opportunity to be outside. Outdoor play, especially in the early preschool years, provides children with the opportunity to learn naturally with the freedom to run, jump and engage in co-operative play. Play is often talked about as if it is a relief from serious learning. However, with guided direction, children can engage in natural learning experiences that include math, science and the language arts with more ease while developing fundamental skills required for graduation from high school. Play is the serious business of learning, not a relief from learning.

In outdoor settings, there are fewer behavioral issues as children are not kept in a rigid learning environment. Each child can learn at his own pace. Although retired, I am an active community member currently overseeing a community based outdoor program. I have the joy of seeing the benefits that all children experience during outdoor play and learning.

Every child in Maryland has the need and desire to be outside. Required use of electronics during the school pandemic lockdowns has made outdoor play for children more crucial than ever. Many children are not given the opportunity to play outside due to provider obligations, parental concerns, unsafe conditions and time constraints for single and working parents. Since outdoor programs are not licensed by MSDE as full day programs, they are not eligible to receive state funded childcare scholarships. Therefore, children in low economic situations and children with developmental delays are at an even larger disadvantage.

As a resident of Calvert County and an advocate of outdoor play experiences, I am witness to the difference made when children can be outside. Studies have shown that children who experience time outside are more resilient, have fewer behavioral issues, develop a better sense of self and suffer fewer illnesses (Barefoot and Balanced). Children love to run through meadows, smell the outdoors in the changing seasons, listen to the birds and the different sounds in a natural setting.

Honorable Members of the Maryland House of Delegates,

I represent the Washington Nature Preschool Association (<u>WaNPA</u>) and I am writing in support of House Bill 376. We support this Bill, and encourage you to do the same, because of the incredible success we have experienced as the result of our own licensing pilot in Washington state, as well as the continued positive impacts we're seeing now that licensing of outdoor nature-based childcare is permanent here. We deeply admire the state of Maryland's strong commitment to stewardship in the Chesapeake Bay watershed. You were first in the nation to pass K-12 Environmental Literacy graduation requirements and you are clearly committed to growing future generations of citizens who will cherish and protect the natural world. HB 376 is a logical extension of that commitment; it has the potential to positively impact thousands of children and families, and offers a pathway to providing equitable access to safe, high-quality outdoor learning, which has never been more important.

In 2017, the WA state legislature established the outdoor preschool licensing pilot with overwhelming bi-partisan support. Over the following four years, many of us at WaNPA worked with the Washington state Department of Children Youth and Families (DCYF) to develop safety and quality standards for outdoor classrooms. Our pilot program was guided by the ever-growing research that speaks to the benefits of outdoor nature-based learning: it supports social and emotional growth, positive academic outcomes, and provides a multitude of physical and mental health benefits, all while enabling children to form a meaningful bond with the natural environment. We currently have 6 fully licensed outdoor preschool programs, with 4 more in process, and DCYF is regularly providing completely booked orientations to interested providers. One of the most exciting results of licensing outdoor nature-based learning in WA is how many new programs are seeking licensure. You see, licensing supports offering full-day programming and services for children with special needs (and their families) who lack equitable access to outdoor preschools, and these new programs are seeking DCYF's oversight and partnership so that they can better meet the needs of all families.

Equitable access to high quality early learning programs and the outdoors is central to the need for licensing. As you no doubt know, there is a disparity in the socio-economic and racial makeup of those who frequently occupy natural spaces. Sadly, children are the ones most often denied access to the benefits of spending time outdoors. Either families don't have safe natural spaces nearby or, if they do, those natural spaces do not feel welcoming. Meanwhile, many working families simply cannot find the time to spend outdoors. As a result, we do not see the diversity of our communities fully represented in our natural spaces, nor in our nature

preschools. Children from low-resourced communities are not able to reap the benefits of outdoor preschool if their parents cannot access subsidies and state funding to attend. Take, for example, the Saplings & Cedars program at the Squaxin Island Child Development Center here in WA, where they have 12 ECEAP families and 15 families utilizing Working Connections or other state, federal, or tribal subsidies. That's 27 out of 32 families that are provided care through subsidies. Squaxin Island provides an example of the clear demand for access to state subsidized outdoor learning - demand that is also present in Maryland. How exciting that you have an opportunity to expand access to high-quality early learning in safe, welcoming natural spaces through an outdoor preschool licensing pilot program.

Across the nation, the number of nature-based programs has risen significantly over the past decade (a 25 fold increase, which more than doubled from 2017 to 2020), and there has been another increase since the beginning of the pandemic, with many indoor programs moving to learning outdoors as well. There is much uncertainty in this time, and the health impacts of COVID-19, which disproportionately affect Black, Brown, Indigenous, Asian, Pacific Islanders, and other people of color, continue to be staggering. However, through a licensing pilot, you can bring opportunities to children, their families, and the schools that serve them, with the potential to not only improve their health and safety now, but truly alter the course of their lives for the better. We in Washington urge you to please pass HB 376, taking a critical step toward equitable access to high-quality education and access to the outdoors.

Dear Madame Chair and Members of the Ways and Means Committee,

I am writing to respectfully request a favorable report on HB376 – Outdoor Preschool Licensing Pilot Program – Establishment. This bill allows MSDE Office of Childcare to waive or adapt regulations to license forest and nature preschool programs. In addition the MSDE will collect data and report findings of this initial licensing phase to determine whether to expand the program. The purpose of this pilot program is to both increase access to affordable, high quality early learning programs and to extend the benefits of nature-based learning to families who prefer that choice.

Priority for participation in the Pilot will be given to existing programs in areas where there are limited early child care options and should include urban, suburban and rural areas.

The benefits of a nature-based educational model is well documented and these programs already exist in Maryland. There are close to 60 programs listed on the Natural Start Alliance website. These nature-based programs, however, are limited in their hours of operation and in the families that they can serve because they cannot be licensed under current MSDE regulations. I have 15 years of experience working a teacher, specialized teacher-trainer, and preschool director. My current role is with Baltimore City Recreation and Parks, as the Director of the Forest Preschool at Carrie Murray Nature Center. It is a honor to serve in the city's only nature center, located in the gorgeous Gwynns Falls Leakin Park in west Baltimore. I, along with my colleagues, and all of Baltimore City Recreation and Parks, support bill HB376. This very important legislation aligns with the City's mission to create a healthy and green Baltimore.

Half my career was working in traditional indoor preschool settings, the second half, was in nature-based outdoor school settings. I have witnessed the significant positive effects of outdoor preschool experiences in the children we serve everyday. When children are given the time, space and permission to learn and play outdoors, their confidence, social and communicative skills, motivation and concentration, and understanding of and connectedness to nature, strengthen. Even their immune systems are strengthened by contact with mud, soil, water and exposure to all weather!

Free unstructured, and natural play in nature is of high importance because it is a continuous process of learning. A study by the North American Association for Environmental Education shows that children in Forest Preschools are are well prepared for kindergarten, individual learning processes are enhanced, and gained abilities can be transferred to the classroom. Thank you for giving us this opportunity to share why outdoor preschool licensing is needed in our state. It is my great privilege to speak to you about House Bill 376 to establish an outdoor preschool licensing pilot here in Maryland.

My name is Monica Wiedel-Lubinski. I am the founding executive director of the Eastern Region Association of Forest and Nature Schools. I am also the founder/co-founder of three nature-based programs in Maryland including the nature preschool at Irvine Nature Center which was Maryland's second licensed, NAEYC-accredited nature preschool. I have written about nature-based education for various journals and books, and I frequently teach others on the topic as a keynote speaker, lecturer, and even on international podcasts. I am currently writing a book about nature-based early childhood education for the National Association for the Education of Young Children (NAEYC). My formal education was at Towson University where I earned a Master's Degree in early childhood education while working and raising two young children. I am also an Adjunct professor at Goucher College in their Environmental Studies certificate program.

I've been a member of Project Green Classrooms with their Nature Play Space working group for several years and was the co-chair of the Council for Nature and Forest Preschools with the Natural Start Alliance, a project of the North American Association for Environmental Education (NAAEE). I'm very pleased to say that they provided a letter of support in favor of this bill, alongside our colleagues at the National Wildlife Federation and local Sierra Club.

I am one of 10 authors who contributed to the *Nature-Based Preschool Professional Practices Guidebook* published by NAAEE in 2019 to professionalize standards in our growing field. I share my background to help provide context for the much larger considerations there are for outdoor preschools, which many of my contemporaries may not be aware of. The concept of outdoor preschool is not new. What we need is a path to make it licensed here in Maryland so that more children and families can reap its benefits. As it stands, only the privileged can afford to attend outdoor preschool.

Outdoor preschools are different from other early learning programs that can be licensed. Licensed programs have a building or facility with an indoor classroom. They may spend portions of their day outside, but they have an indoor location that qualifies for licensing purposes. There are many wonderful licensed nature preschools and childcare centers in Maryland! The distinction here is that there are also **immersive outdoor preschools** that spend 100% of their time engaged in outdoor learning. Outside! They do not have indoor classrooms - nor do they want or need them. Outdoor preschools have emergency shelter spaces, but the focus of their learning is with, in, and about nature.

Because outdoor preschools lack an indoor facility, there is a fundamental issue with being able to count the square footage or get a 'use and occupancy permit' for example as part of the licensing process. For an outdoor preschool, it makes no sense to pay overhead for an indoor facility that simply will not be used.

To be clear, outdoor preschools are not camp. They run year round, the way any other early learning programs do. They utilize curriculum, early learning standards, build community with families, assess student learning, implement health and safety protocols, document learning through evidence-based practices, and provide a deeply meaningful experience about what it means to learn and grow in the place you call home.

Outdoor preschools offer a very specific, place-based philosophy centered on nature pedagogy and environmental literacy. Not every family may want an immersive outdoor preschool for their child. But a growing number of families recognize that they want their children to be active, healthy, and engaged in sensory-rich, experiential, hands-on learning. Physical development is on full display in outdoor preschool programs. Social and emotional learning is also deep and rich in immersive outdoor preschools. Children work together in community as they have adventures in all kinds of weather. Outdoor learning provides stress relief and mental health benefits, especially for children who experience trauma. Empathy and respect for living things are common threads across these programs and that empathy is crucial for the much larger goals that we have here in Maryland for environmental literacy and the protection of our natural resources.

I should note that Maryland was the first in the nation to pass a graduation requirement for K through 12 environmental literacy standards. Even at the age of three, the children are keenly aware of their place and their impact in the natural world. These pro-environmental attitudes usher in the next generation of compassionate people who want to protect and conserve our incredible natural resources in Maryland.

Outdoor preschools provide soil for the seeds of all kinds of cognitive and intellectual development to blossom. Beyond the obvious science concepts, we address other development domains including language and literacy, math and creative arts, technology and engineering - even history that comes to life while reading the landscape and discovering the ways in which the land has been used for centuries if not millenia. Learning is active and alive outside. There is no sacrifice of foundation skills. In fact, according to a peer-reviewed 2019 study, researchers did a critical review of recent literature and found, "In academic contexts, nature-based instruction outperforms traditional instruction." (Kuo et al, 2019). See the journal Frontiers in Psychology for more information:

Given Maryland's leadership in environmental literacy including the Partnership for Children in Nature and Project Green Classrooms, and the abundant research about the value of nature-based, outdoor learning, it makes sense for us to extend the opportunity to younger children.

The most compelling reason we need to conduct a pilot program for outdoor preschool licensing is because of the barriers that exist for families who want to attend outdoor preschools but cannot.

Children that come from low-resourced backgrounds and rely on child care scholarships can only use them in licensed programs. This means that outdoor preschools cannot accept children who need to use child care scholarships to attend. As you might imagine, this disproportionately places a burden on low-income families and many of those families are in black and brown communities. This is not acceptable and it is not equitable. Further, outdoor preschool programs are then forced to choose between budgeting for scholarships and paying teachers less, or paying teachers a more fair and livable wage but with no additional funds for scholarships support to families in need. What a horrible position for any program to be put in! When outdoor preschools are able to be licensed, we will be able to accept child care subsidies so that we will never have to turn away any families who want this enriching opportunity for their children.

Currently, outdoor preschools can only operate for short periods of time before being required to be licensed. But as stated, there is no path to do so. This means that short, part-day outdoor preschools can only be accessed by families with the luxury of attending a 2- or 3-hour program once or twice per week. This denies equitable access for working families who need longer hours of care.

Safety is also a concern. Teachers in licensed programs are vetted to be sure they understand child development, health and safety considerations, developmentally appropriate practices, etc. Right now, anyone could offer an unlicensed program that could pose potential harm to children because the state does not allow for licensing. Additionally, licensed programs can access professional development funding to ensure teachers have, and can maintain, their credentials with financial help from the state.

Children with special needs (and their families) lack equitable access to outdoor preschools and experience disproportionate barriers to getting special services if they wish to attend. Far more supportive infrastructure is in place for children in licensed child care settings. There are a range of developmental benefits for children with special needs and diverse abilities, and the pilot program can further address how to include all children in outdoor preschools.

It is also baffling that another state department, the Maryland Dept. of Mental Health and Hygiene, licenses 100% outdoor programs in the summer - without indoor facilities - yet the Maryland State Dept. of Education's Office of Child Care does not acknowledge the same for year-round outdoor preschool. If health and safety standards are acceptable for hand washing and toileting, even amidst COVID protocol, and camps can obtain state licensure working with the same age of children - why are there additional barriers in place for outdoor preschools through the Office of Child Care? The pilot program through this bill would address these challenges and ensure a path licensure.

We also want to acknowledge the staggering number of childcare programs that have closed since the start of the pandemic (nearly 1,000). Outdoor preschools can provide another high-quality option and build capacity for high quality early learning opportunities. For existing child care programs, they would be able to take families off their waitlists with an expanded outdoor preschool option.

Fortunately, Washington state is the first in the nation to make a path for outdoor nature-based preschools to be licensed. Our Outdoor Preschool Licensing Advisory Team has been in close contact to learn more about their progress. Following a comprehensive 4-year pilot program, their final report concludes that children demonstrated 'kindergarten readiness' that exceeded the state's average for other licensed care programs and found gains that overwhelmingly support the value of outdoor preschools.

Outdoor Preschools demonstrate an ability to meet rising demand for high quality care, increase capacity to provide enriching early learning opportunities, and address issues of equitable, affordable access to outdoor learning for all children. WA's pilot provided an opportunity for experienced nature-based ECE providers to work alongside state department officials to collaborate on specific protocol that supports evidence-based standards and dually addresses the unique needs of outdoor preschools. We hope that Maryland will be the second state in the US to embark on an outdoor preschool licensing pilot program and ultimately forge a path for licensing.

I understand some of my colleagues in traditional early childhood education may not yet understand how and why outdoor learning is vital to early childhood education. At this stage, the benefits of nature-based early childhood education and outdoor preschool are well established and not up for debate. What we need to do is ensure that ALL families have equitable access to these programs. We have a trail map in WA and leaders and stakeholders here in Maryland guiding these efforts. House Bill 376 will provide the opportunity for us to work with the Office of Childcare to adapt existing regulations so there is a path for licensing. I urge you to vote in favor of HB376 to create a pilot program that will help provide more equitable access to outdoor preschool.

Written Testimony for House Bill 376 Rebecca Morris

My name is Rebecca Morris, and I am the mother of Peter, a student who attended the Notchcliff Forest Preschool one morning a week last school year. Peter has cerebral palsy. He uses leg braces and a walker for mobility, wears hearing aids, and has a variety of language and communication delays.

Peter is now six, and over the years he has experienced a variety of excellent educational and therapeutic settings. He requires the care and expertise of skilled special educators and therapists, and these providers work mostly in indoor settings with structured programs focused on goals and objectives.

When I learned of the outdoor preschool program at Notchcliff, I knew I wanted my son to have the opportunity to learn in a whole new way – to explore and play with peers in a classroom that was unlike any he'd ever experienced.

Because of his needs, he required a dedicated adult assistant for the program. We were fortunate that I could provide that assistance. My support enabled Peter to participate in parts of the program that would have otherwise been inaccessible. Throughout the year, I saw him grow to love the independence of using his walker to travel the forest trail on his own; to play modified games of hide and seek in the meadow; to sled down hills with his classmates; and to enjoy puppet shows and puzzles with outdoor themes.

The outdoor preschool experience gave my son a feeling of confidence and independence, and a sense of control over his learning that he has rarely ever felt. The program allowed him to explore, take risks, and experience natural consequences, all within a supportive and safe outdoor learning environment.

My son certainly benefited from attending an outdoor preschool program, but it was only possible because I could attend with him.

Licensing outdoor preschools is the way to make them accessible for all students, including those with special needs who require dedicated adult support. I have seen the power of outdoor early childhood education for my son, and I know it has the potential to provide enormous benefit for so many other students with special needs.

Chesapeake Bay Foundation (CBF) **SUPPORTS** HB 376, which establishing the Outdoor Preschool License Pilot Program in the Maryland State Department of Education to license outdoor, nature-based early learning and child care programs in order to expand access to affordable, high-quality early learning programs and to investigate the benefits of outdoor, nature-based classrooms.

Research shows that children benefit from outdoor learning at all ages.

Time outside benefits social, emotional and cognitive development in children, including the youngest learners – the preschool age group targeted by this legislation. A recent article on the Laurie M. Tisch Center for Food, Education & Policy blog of Columbia University's Teachers College states, "Research has shown that children who spend more time outdoors at school are often more physically active and perform higher intensity activities. Being outside can also improve students' mental and emotional health and overall wellbeing." The Chesapeake Bay Foundation's educational programs are founded in part on the value of outdoor learning. Each year, CBF's Maryland education program serves about 10,000 students and teachers at education sites in Annapolis, Baltimore, Washington D.C., Havre de Grace, and at island sites on the Chesapeake Bay.

This legislation will support additional and enhanced outdoor education opportunities for preschool students through supporting five to ten outdoor preschool programs over a three-year pilot period. An early introduction to nature-based learning will benefit these children, and hopefully spark an interest in future outdoor learning experiences.

Outdoor education has demonstrated health benefits and should be accessible to more children.

Outdoor education is not only a learning opportunity, it also has demonstrated health benefits for students, and there are ways to incorporate outdoor learning into many different curriculums. The Chesapeake Bay Foundation seeks to provide students from across Maryland with outdoor educational experiences, and to reach teachers with outdoor education training. With grant funding, CBF is able to reduce program fees which benefits economically disadvantaged students and schools. This legislation will promote additional access to outdoor education for preschool students by licensing new programs with the explicit intent to expand access to affordable, high-quality early learning programs.



The Maryland Chapter of the Sierra Club submits this testimony in support of HB 376. Access to early childhood education that is centered on nature-based exploration is critical to cultivating the next generation of environmental stewards. Licensing for Outdoor Preschools will help existing nature-based preschools reach children in low income areas and with special education needs. Additionally, we believe that in the future the expansion of this pilot licensing program will encourage the creation of more high quality nature-based outdoor education programs for preschool children and beyond.

Young children benefit from an early start to healthy lifelong habits. Numerous peer reviewed studies point to the improvements in mood and overall health and wellness outcomes. Recent studies show that interactions with nature boost mood in adolescents, support a strengthened immune system, and improve problem solving, critical thinking and self-discipline – all critical for today's youth.

Piloting a licensing program for Outdoor Preschools will support access to nature by underserved communities. Working families need access to high quality full-day education yet currently there are limits on the length of time Outdoor programs can be offered because they cannot be licensed without indoor building space. State vouchers can only be used by licensed providers. Providers cannot access professional development offered by the Maryland State Department of Education if they are not using the licensure program and conversely cannot be vetted for credentials. HB 376 would offer a pathway forward to improving family, student, and teacher experiences with outdoor preschool programs.

For these reasons, the Maryland Chapter of the Sierra Club strongly recommends a favorable report on HB 376.

Outdoor Preschool Licensing Pilot (HB0376)

Dear Chairperson Atterbeary and Members of the Ways and Means Committee,

Blue Water Baltimore is a nonprofit organization with a mission to restore the quality of Baltimore's rivers, streams, and Harbor to foster a healthy environment and thriving communities. As part of our work, we offer educational ecoliteracy programs for all age ranges. **We write today in support of Outdoor Preschool Licensing Pilot (HB0376).**

Here are some reasons why this pilot program is important:

- Children from low-income communities and those with special needs do not have equitable
 access to State scholarships or special education services and are cut off from the benefits of
 nature-based early childhood education because immersive outdoor preschools currently
 cannot be licensed;
- A staggering number of child care programs in Maryland have closed during the Covid-19
 pandemic leaving a shortage of options for families. Outdoor preschools offer an alternative
 form of child care at a time when many families seek the physical and mental health benefits of
 being outdoors; and
- Outdoor preschools promote the skills and values that lead to environmental literacy, which supports goals of the Maryland Partnership For Children In Nature and the K-12 Environmental Literacy Standards required for graduation in Maryland.

As Blue Water Baltimore's Ecoliteracy and Restoration Specialist, I have the privilege of teaching students about Baltimore's waterways and the urban water cycle. Last summer, I asked a class of students with the SummerLIT program (formerly SummerREADS) if anyone knew how the water cycle might be different in a city. One student responded by describing how Baltimore's three-pipe system works. He said he knew about the pipe system because "someone taught me this" the last time he participated in the program two years ago. I didn't care that he didn't remember me, just the fact that he retained the concept and was now sharing the information with his mostly younger classmates demonstrates how impactful ecoliteracy and environmental education can be.

We urge a favorable report on HB0376.

Dear Ways and Means Committee,

My name is Dr. Rose Brusaferro and I am an environmental educator and research scientist residing in your district of Baltimore City since 2019. I am writing to express my support and ask that you vote in favor of HB376 to establish an Outdoor Preschool Licensing pilot in Maryland. The most pertinent reasons I support this legislation include:

- Its potential to widen access to these programs for children from low-income communities and those with special needs. Without State-sponsored licensing, these programs do not receive State-funded scholarships or special education service benefits which excludes families from marginalized communities from enrolling.
- Its potential to alleviate the shortage of safe childcare options in the wake of a global health pandemic. Outdoor preschool programs offer an alternative form of child care at a time when many families seek the physical and mental health benefits of being outdoors.
- Its potential to promote the skills and values that lead to environmental literacy, which supports goals of the Maryland Partnership For Children In Nature and the K-12 Environmental Literacy Standards required for graduation in Maryland.

For over a decade I've studied the research and added original data to the literature that supports the benefits of connecting children to nature. My most prominent study was conducted at Wild Haven Forest Preschool, a licensed outdoor program operating out of Carrie Murray Nature Center in Baltimore City. There is an overwhelming, evidence-based consensus in the scientific community that regular contact with nature improves the mental and physical wellness of children as well as adults. The approval of HB376 would be the first step in positioning Maryland as a champion of progressive education for early childhood.

Thank you for your time and consideration of HB376. We hope that you will support this important effort and vote in favor of HB376!

Testimony Concerning HB 376 "Outdoor Preschool License Pilot Program - Establishment" Submitted to the House Ways & Means Committee February 10, 2022

Position: Favorable with Amendment

Maryland Family Network (MFN) respectfully requests an amendment to HB 376, which would require the Maryland State Department of Education by August of this year to establish a three-year pilot program for up to 10 newly defined "outdoor, nature-based early learning and child care program[s]."

MFN has worked since 1945 to improve the availability and quality of child care and early childhood education, as well as other supports for children and families in Maryland. We have been active in state and federal debates on child care policy and are strongly committed to ensuring that children, along with their parents, have access to high-quality, affordable programs and educational opportunities.

The concept of outdoor preschools, which operate without indoor space, is intriguing but has not been sufficiently vetted in Maryland. Indeed, only one other state has enacted legislation permitting outdoor preschools. Left unanswered here are fundamental questions: under whose authority and under what recognized standards do outdoor preschools currently operate in Maryland? How are children's basic health and safety needs ensured? What evidence exists to guide best practices and document children's outcomes?

MFN would support and happily participate in a more deliberate process to explore the outdoor preschool concept thoroughly, arrive at answers agreed upon by multiple stakeholders, and report back to the General Assembly. MFN strongly believes such an examination should precede the establishment of up to 10 pilot programs. HB 376 regrettably circumvents this necessary step.

In materials they have distributed, the proponents of the legislation acknowledge "the need to conduct a careful review of COMAR 13.A regulations to address these points of concern." MFN concurs. Therefore, prior to such careful review, MFN urges the Committee to adopt the following amendment: On page 3, in line 11, strike "MAY" and insert "SHALL NOT."

On behalf of the Maryland State Child Care Association (MSCCA), thank you to Delegate Guyton for recognizing the importance of nature-based play, the importance of licensing and regulation for health and safety and the innovation to explore and expand the benefits of outdoor classrooms in Maryland as a collaborative pilot program over three years.

MSCCA has over 5,000 members who are adhering to close to fifty pages of rigorous COMAR regulations as the foundation of health and safety which children and families deserve and expect when choosing legal, licensed child care/early childhood education programs. MSCCA respectfully requests an amendment to Section 9.5-1103(C) that would prohibit the Maryland State Department of Education (MSDE) from waiving existing child care licensing requirements to meet the needs of the pilot (see amendment following the testimony. This amendment would preserve the Department's ability to modify regulations to supports the safe and authentic participation in the pilot.

Current childcare-center licensing standards are primarily designed for indoor settings. Without a license, outdoor preschools cannot offer full-day options or access state scholarships that assist low-income families with child care costs.

MSCCA fully supports the convening of an advisory group of practicing nature-based learning programs to inform and implement this pilot program as well as consider the ways to measure outcomes and success.

Our priorities agenda includes the expansion and access of affordable, quality child care/early learning programs for families and aligns with the intent of HB 376.

MSCCA believes children are our most important natural resource. The focus of this pilot is to investigate the benefits of outdoor, nature-based classrooms for children. Some of the numerous, important benefits of outdoor preschools include, improved gross motor skills, lower rates of obesity, more resilience and confidence, milder ADHD symptoms and less likely to get sick. These are outcomes that have far reaching health benefits and should be explored fully.

Maryland has lost approximately 15% of child care programs since the pandemic. Mental health issues continue to increase. We must rebuild and reimagine early childhood programs for a stronger and innovative future for children.

MSCCA urges a favorable report only with amendment.
