AMENDMENT TO HOUSE BILL 522

(First Reading File Bill)

On page 3, in line 3, after "(6)" insert "(I)"; after line 5, insert:

"(II) "NONJUDICIAL COLLECTION" INCLUDES COLLECTIONS
THROUGH THE STATE TAX REFUND INTERCEPT PROGRAM UNDER §§ 13–912
THROUGH 13–919 OF THE TAX – GENERAL ARTICLE.";

in lines 10 and 14, in each instance, strike "2024" and substitute "2023"; in line 14, after "(2)" insert "(II)"; after line 18, insert:

"(II) THE COMMISSION SHALL MAKE THE REPORT SUBMITTED UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH PUBLICLY AVAILABLE ON THE COMMISSION'S WEBSITE.";

in line 20, strike "FROM THE PREVIOUS FISCAL YEAR" and substitute "AS OF THE LAST DAY OF THE PREVIOUS FISCAL YEAR UNLESS OTHERWISE SPECIFIED"; in line 26, strike "HOLD" and substitute "OWE"; and in line 28, after "OWED" insert ", IN UNITS OF YEARS".

On page 4, in line 1, strike "PERCENTAGE AND TOTAL" and substitute "TOTAL"; in line 4, strike "PERCENTAGE" and substitute "NUMBER OF STUDENT ACCOUNTS"; in line 8, strike "PERCENTAGE OF" and substitute "NUMBER OF STUDENT ACCOUNTS WHOSE DEBT WAS CHARGED OFF"; in lines 12 and 15, in each instance, strike "PERCENTAGE" and substitute "TOTAL DOLLAR AMOUNT"; strike beginning with "PERCENTAGE" in line 17 down through "PAYMENTS" in line 19 and substitute "TOTAL DOLLAR AMOUNT AND NUMBER OF STUDENT ACCOUNTS SUBJECT TO

PAYMENT PLANS TO REPAY INSTITUTIONAL DEBT"; in line 20, strike "PERCENTAGE" and substitute "TOTAL DOLLAR AMOUNT"; in line 22, after "ACTIONS" insert "TAKEN"; and in the same line, after "INSTITUTION" insert "DUE TO A STUDENT OWING AN INSTITUTIONAL DEBT".

On page 5, in line 2, after "INSTITUTION" insert "<u>DURING THE PREVIOUS</u> <u>FISCAL YEAR</u>"; and in line 3, strike the first "AN" and substitute "<u>A NEW</u>".

On page 6, in line 12, strike "SHALL" and substitute "MAY".
