Dear Chairman Feldman and Members of the Committee,

Thank you for the opportunity to submit testimony **in support of SB470** on behalf of ShoreRivers. ShoreRivers is a river protection group on Maryland's Eastern Shore with more than 2,000 members. Our mission is to protect and restore our Eastern Shore waterways through science-based advocacy, restoration, and education.

Maryland's Eastern Shore is defined by its open space and rural character. Preserving these open spaces to protect them from development and impervious infrastructure will be an important step in reducing nutrient pollution in our local waterways and buffering our low-lying communities from rising tides and storm surge resulting from climate change. **The Maryland the Beautiful Act** sets state conservation goals to protect 30% of Maryland's land by 2030, and 40% of Maryland's land by 2040. It also creates a \$10M Rapid Response Revolving Loan Fund to help small- and medium-sized land trusts preserve critical lands quickly and allocates more than \$250K in grant funding toward land trusts and community nonprofits for improving the stewardship and health of land.

As Chester Riverkeeper, I work with counties, towns, and land conservation organizations within my watershed to create and preserve open spaces. Protected lands have the ability to connect more residents with our waterways, as well as provide opportunities for reforestation or increased tree canopy, both of which are valuable green infrastructure practices that improve water quality. **Increased funding for land acquisition and stewardship will help organizations like ShoreRivers and our partners achieve local public access goals, connect residents to nature, and implement conservation and restoration practices that improve water quality on the Eastern Shore.** 

Preserving land across the Eastern Shore will increase open space for public access and recreation, which in turn fosters respect and stewardship for natural resources like our waterways. In turn, it also helps to protect woodlands, grasslands, and marsh lands, which filter nutrients, slow runoff, and buffer our communities from the growing impacts of climate change such as storm surges, rising sea levels, and nuisance flooding. For these reasons, we urge the committee **to adopt a favorable report for SB470**.

The Nature Conservancy (TNC) supports SB 470 offered by Senator Elfreth. TNC is a global conservation organization working to conserve the lands and waters on which all life depends. In Maryland, our work focuses on delivering science-based, on-the-ground solutions that secure clean water and healthy living environments for our communities, reducing greenhouse gas emissions and increasing resilience in the face of a changing climate. We are dedicated to a future where people and nature thrive together.

TNC is part of a global effort to preserve the world's remaining wild and near-natural habitats, with the goal of protecting 30 percent of the planet by 2030. SB 470 sets state-wide land conservation goals for Maryland, aiming to protect 30% of lands by 2030 and 40% of lands by 2040. These goals will ensure that open space will be accessible and available for current and future generations of Marylanders.

SB 470 will create funding mechanisms for private land trusts to better compete in real estate markets. TNC uses a similar process as an organization - the Land Protection Fund – to prioritize and fund land acquisitions across our North America program. Creating a Revolving Loan Fund through SB 470 would enable small and medium sized private land trusts, which may not be able to purchase lands without financial assistance, to preserve critical lands quickly in Maryland. Allocating grant funding towards land trusts and community nonprofits will support these organizations in enhancing stewardship opportunities and improving the land health. SB 470 will preserve lands that will benefit people and nature for years to come.

Each year, the United States loses an area the size of Delaware to development and unsustainable use. This land and biodiversity loss can often be irreversible. Here in Maryland, the lands and waters that surround us are precious resources. They are an invaluable part of our heritage, our economy, and our identity. The Appalachians are one of the most resilient, diverse, and productive ecosystems on Earth. TNC has prioritized conservation across this ancient chain of forested mountains, valleys, wetlands and rivers as a global imperative due to the high biological diversity of species, the carbon stored in the forests and the rich history and culture of this landscape, beginning with the original Indigenous stewards. The section of the Appalachians running through West Virginia, Maryland and Pennsylvania are a critical corridor for species migrating in response to climate change. This section, known as the Allegheny Front, is a priority landscape to preserve the rich biodiversity of the larger Appalachian range as climate change drives species to move and adapt. Serving as a habitat bridge between vast conservation lands in the southern and northern Appalachians, the Allegheny Front plays a critical role in keeping this continental ecosystem connected. Climate change and a wide range of human activities are impacting habitats at an unprecedented and unsustainable rate. The precipitous decline in biodiversity is one of our global greatest challenges; it is jeopardizing food and water supplies and undermining global, social and economic stability. Economists have estimated that nature contributes trillions of dollars to the global economy each year, in the form of ecosystem services such as pollination and water filtration and storage. By passing the Maryland the Beautiful Act, we can take marked steps to reverse biodiversity loss in our state in order to create a future where natural places can support the most vulnerable species and can continue to provide valuable ecosystem services on which state residents depend.

TNC commends Senator Elfreth for advancing legislation aimed at protecting habitats to maintain Maryland's biodiversity and preserving treasured ecosystem services as well as nature's intrinsic cultural and physical values.

#### Therefore, we urge a favorable report on SB 470.

I am submitting this testimony in strong support of SB0470 on behalf of the Maryland Legislative Coalition. The Maryland Legislative Coalition is an association of activists - individuals and grassroots groups in every district in the state. We are unpaid citizen lobbyists and our Coalition supports well over 30,000 members.

The Keep Maryland Beautiful Program and Land Conservation Implementation Grant Program will serve to maintain 40% of Maryland's land in its natural state and save the habitats of countless species. This bill will not only preserve our environment, it will also dramatically improve funding available to urban land trusts, and invest in stewardship of lands impacted by climate change and invasive species.

Currently, Maryland has conserved 28.7% of its lands and critical habitats (23% of total land mass) and only annually monitors ~11% of land under easement. Land preservation is critical to the protection of species and the habitats they depend on. The United Nations recently reported that 150 - 170 species permanently go extinct every day. In North America alone, since 1970, bird populations have dropped by more than 30%.

We strongly support this bill and recommend a **FAVORABLE** report in committee.

Indivisible Howard County is an active member of the Maryland Legislative Coalition (with 30,000+ members). We are providing written testimony today in <u>support of SB470</u> Natural Resources - Land Conservation - Establishment of Goals and Programs (Maryland the Beautiful Act). We appreciate the leadership of Senator Elfreth for sponsoring this important legislation.

The bill establishes the Local Land Trust Revolving Loan Program to provide loans to land trusts to purchase land for conservation purposes, establishes a Land Trust Revolving Loan Fund, contributes money to the Maryland Environmental Trust to be used to provide grants through the Keep Maryland Beautiful Program, and establishes the 40 x 40 Land Conservation Implementation Grant Program to support implementation of land conservation goals.

Nature Forward (formerly Audubon Naturalist Society) is the oldest independent environmental organization in the DC metropolitan region. For 126 years, Nature Forward has inspired residents of the greater Washington, DC, area to appreciate, understand, and protect their natural environment through environmental education, advocacy, and outdoor experiences. We strongly support passage of SB470, and we appreciate the opportunity to testify on this bill.

If enacted, SB470 will have a threefold impact by 1) setting a new state conservation of protecting 30% of Maryland's lands by 2030 and 40% by 2040; 2) Create a \$10M Rapid response revolving loan fund to help small and medium land trusts to preserve lands quickly; 3) Allocate more than \$250K in grant funding towards land trusts and community non-profits. SB470 is a strong well-rounded legislation that will facilitate more land conservation and stewardship, provide funding to land trusts for such activities, and increase nature access, protect biodiversity and habitat, and help combat the climate crisis.

#### New 30 x 30 and 40 x 40 State Land Conservation Goals

SB470 states "the intent of the General Assembly" that "by 2030, 30% of lands in the state be conserved, and by 2040, 40% of lands in the state be conserved." This bill's "30 x 30" land conservation goals mirrors those in President Biden's 2021 Executive Order 14008.<sup>2</sup> Notably, SB470 goes further by including an additional goal of protecting 40% of Maryland lands by 2040. To help meet these challenging conservation goals, the bill provides for a Smart Growth Subcabinet to work with state and local partners to track progress and implementation. Also impressive is the broad array of activities that will be undertaken to accomplish these land conservation goals. Additionally, the Maryland Environmental Trust will administer a "40 x 40 land conservation implementation grant program;" the program grant will be competitively awarded each year to a statewide nonprofit organization focusing on supporting "permanent conservation of the lands of the state." For FY 2025 and thereafter, the bill also mandates an annual budget appropriation of \$250,000 for this effort.

#### Local Land Trust Revolving Loan Program and Revolving Loan Fund

We fully support SB470 is the creation of a revolving loan program to make loans to certain land trusts on a rolling basis, to assist them in purchasing property for purposes of conservation. The loan program is specifically intended to support the efforts of local trusts that have trouble accessing these programs to partner up with a local government entity. A special, non-lapsing revolving loan fund, administered by the Maryland Environmental Trust, is also created to provide revolving loans to land trusts on a rolling basis to assist the trusts purchase property. A land trust that receives a program loan to purchase property must repay the loan only after the property is placed under an easement or transferred to a state or local

government entity. Notably, the bill directs that in FY 2025, the governor includes in the annual budget bill an appropriation of \$10 M to the Fund, to be used solely for the loan program.

#### **Grants to Land Trusts & Community Non-Profits**

Nature Forward also supports the provisions in SB470 for land stewardship grants. In FY 2025 and thereafter, the governor shall include an annual budget appropriation of \$235,000 to the Maryland Environmental Trust for several types of grants. This includes grants to land trusts to support land monitoring and stewardship of agricultural lands, forests lands, and lands facing a threat from invasive species or climate change. Citizen stewardship grants to nonprofits, community organizations, schools, and municipal corporations also are included.

SB470 merits support because it establishes valuable land conservation goals and programs for Maryland as well as the mechanisms and the money to achieve these goals by creating partnerships between government and local communities. The permanent protection of Maryland lands from development is a laudable goal and one which can help combat climate change. On behalf of Nature Forward and our 28,000 members and supporters, we recommend that the Committee passes and approves SB470. Thank you for your time and consideration.

The Maryland Association of Counties (MACo) **SUPPORTS** SB 470. The bill seeks to establish sustainable long-term programs to accelerate and improve park land acquisition and encourage the development of community green spaces.

The State of Maryland and its counties have been immensely successful at expanding parks lands and developing those spaces into world-class recreation venues. Maryland's prioritization of public recreational spaces has advanced numerous health and economic benefits, a central element in Maryland's "quality of life" proposition.

The proposed Local Land Trust Revolving Loan Program (LLTRLP) will provide local governments with new resources to make their communities more sustainable, livable, and healthy. The LLTRLP is designed to provide low-interest financing to local land trusts that are working with county governments to acquire new green space. In the wake of the COVID-19 pandemic, both state and local greenspaces were filled, often to capacity, as residents sought some form of healthy and safe recreation - it has become abundantly clear that these spaces offer immense value to neighborhoods across the state.

The pandemic has highlighted how critical these spaces can be to a healthy and vibrant community. SB 470 would provide county governments and partners with additional resources to expand park sizes and greenspaces. Accordingly, MACo urges the Committee to give SB 470 a **FAVORABLE** report.

Thank you for the opportunity to submit testimony in **SUPPORT OF SB470**, on behalf of Arundel Rivers Federation. Arundel Rivers is a non-profit organization dedicated to the protection, preservation, and restoration of the South, West and Rhode Rivers with over 3,500 supporters. Our mission is to work with local communities to achieve clean, fishable, and swimmable waterways for present and future generations.

**Preserving natural lands is one of the best tools we have in protecting our local water quality.** According to the Environmental Protection Agency, the conservation of natural lands maintains the water cycle, minimizes pollutant runoff, and prevents the loss of natural lands to more environmentally damaging development or land use practices.<sup>1</sup> Maryland the Beautiful Act, also known as the 40x40 Act, would mandate a conservation goal of 40% of Maryland lands by 2040. Additionally, it will create a \$10 million Rapid Response Revolving Loan Fund to help small and medium sized land trusts preserve critical lands, which will allocate grant funding towards land trusts and community nonprofits. This directly supports our mission of achieving clean, fishable, and swimmable waterways.

We have witnessed multiple instances in Anne Arundel County where local non-profits and land trusts have expressed interest in purchasing largely forested, agricultural, or open space lands for sale. Often, these small organizations have not had the financial support to competitively act, resulting in natural filter lands being lost to development. Anne Arundel County has experienced some of the largest extent of intact forest converted to developed land between 2013-2018, with over 2,500 acres of forest lost.<sup>2</sup> **Our waterways are polluted with excess nutrient and sediment pollution. Making the commitment to preserve 40% of Maryland lands by 2040 and supporting our local land trust to meet this goal will make a direct impact on our home waterways, which ultimately support our economy, ecosystems, and way of life in Maryland.** 

Arundel Rivers Federation encourages the conservation of our natural lands to benefit our local habitats and water quality when possible, and respectfully requests a **FAVORABLE REPORT on SB470**.

Good afternoon. My name is Jim Brown. I am the policy director for Audubon Mid-Atlantic, here in Maryland. Audubon Mid-Atlantic is the regional office of National Audubon Society, representing over 35,000 Marylanders who advocate for the protection of birds, bird habitat, and policies aiming to protect both birds and human communities in the face of increasing environmental challenges, habitat loss, pollution, and climate change.

Audubon Mid-Atlantic enthusiastically supports the Maryland the Beautiful Act. Specifically, this bill protects birds and it protects our unique landscapes for future generations of Marylanders to benefit from. This bill is good for birds. It is good for people. And it is good for the dynamic ecosystems that make Maryland a special place.

The science tells us birds are in decline due to habitat loss and habitat fragmentation. 1/3 of eastern forest bird species experienced significant population declines in the past 50 years. Grassland and shrubland birds such as eastern towhee and brown thrasher are disappearing even faster. On the Eastern Shore the endangered salt marsh sparrow is losing critical habitat each year. SB470 will slow this habitat loss by ensuring the protection of at least 30% of Maryland's land by 2030.

Iconic birds such as – the Wood Thrush, American Kestrel, Brown Thrasher, Prairie Warbler, Eastern Meadowlark and Baltimore Oriole which are in decline across Maryland will benefit from this bill. But SB470 is not just for the birds. Protected lands in the form of parks and preserves provide people with respite, recreation, and public health benefits. These protected lands also support local economies throughout the state through ecosystem services, hospitality, tourism and associated industries. Protecting more land in Maryland is also an investment in a future defined by climate change. We know that protected forests, grasslands, wetlands, and coastal marshes sequester carbon, slow flooding, filter water, and buffer vulnerable communities from increasing risks of climate change related storm events and sea level rise.

The Science tells us:

Habitat in Maryland is becoming increasingly fragmented and lost

- Habitat loss and fragmentation leads to lower productivity in bird populations and increases the impacts of climate change
- Protecting and conserving land in Maryland will protect vulnerable bird populations, mitigate the impacts of a changing climate, and make Maryland's landscapes more accessible to people across the state

SB470 will strengthen Maryland's economy, create a more resilient environment, and deliver better public health outcomes to our residents and visitors. It will also continue to hold Maryland up as a leader in habitat conservation, ecosystem preservation, and the protection of birds now and into the future.

Audubon Mid-Atlantic respectfully urges a favorable review of this legislation.

We, along with the attached list of 225 people of faith who live or worship in Maryland, the Earth and the web of life, and strive to be good stewards of the Earth's land and waters. We are grateful for the ways th6e Maryland Assembly has worked to protect our environment, but more needs to be done to create a healthier Bay for future generations.

Greenspaces benefit humans' physical, mental, and spiritual health. However, not all Marylanders have easy access to greenspaces. Likewise, many greenspaces are and will continue to be subject to threat of development that could diminish biodiversity. At present, Maryland has permanently conserved just under 30% of its total lands and critical habitats (~24% of land and water) and only annually monitors ~11% of land under easement. This bill sets a conservation goal of 40% of Maryland lands permanently protected by 2040, while also developing a plan for implementation, stewardship, and improved the health of the land.

These measures also strengthen Maryland's strategies for fighting climate change, something we are woefully underprepared for and are called upon to act now for future generations' health and well being. Preserving land in perpetuity is a key strategy for fighting climate change, because when land is preserved it sinks carbon and creates resilient ecosystems that are otherwise lost if the land is developed. Bolstered funds in the Citizen Stewardship Grant, also included in the Maryland the Beautiful Act, will increase funding to school programs that help develop the next generation of conservation leaders. The Maryland the Beautiful Act is an

investment in our lands and Maryland youth, ensuring that future Marylanders will be able to enjoy the bountiful beauty of Maryland.

Importantly, this bill increases the capacity of small and medium under-resourced land trusts to engage in conservation. The Maryland the Beautiful Act would create a one-time funded \$9.5M Land Trust Rapid Response Revolving Loan Fund Program that will enable land trusts to compete for land acquisition for conservation purposes in an ever-competitive real estate market. This Fund would tip the scale in David-and-Goliath situations where these land trusts may otherwise be unable to secure and protect land from development. Uplifting these land trusts rebalances power in the face of climate change and keeps Maryland focused on a future where all people can thrive.

We are all called to continually renew ourselves and improve our behaviors to be more mindful of future generations. This is important legislation that will enhance and protect Maryland's biodiversity, invest in future generations of Marylanders, empower more Maryland land trusts to conserve land, and remind our state leaders for years to come that nothing is more important than preserving greenspace in perpetuity so that all may thrive here. As the Dalai Lama says, "Since climate change and the global economy now affect us all, we have to develop a sense of the oneness of humanity." As people of faith, we hope that you will take this step to conserve Maryland's land and invest in Maryland's youth, for it is one small step in uniting humanity to preserve the dignity and health of us all.

#### SB470 Natural Resources - Land Conservation - Establishment of Goals and Programs (Maryland the Beautiful Act) FAVORABLE

Dear Chair Guzzone, Vice-Chair Rosapeppe and Honorable Members of the Budget and Taxation Committee,

The Green Towson Alliance writes in support of SB470, Maryland the Beautiful Act which sets new state conservation goals of 30% of Maryland lands permanently protected by 2030 and 40% of land by 2040. This goal aligns with and exceeds the nationwide land and water conservation goals of President Biden's Conserving and Restoring America the Beautiful Report. The Green Towson Alliance advocates for a greener, healthier, more beautiful community at the local level monitoring development proposals and restoring habitat, among other work. We believe that development must be balanced with smart and strategic land conservation. We see pockets of green disappearing that could otherwise connect wildlife corridors, stabilize temperatures in urban heat islands, provide recreation and open space, and absorb stormwater - all problems our neighborhoods in Towson are increasingly experiencing.

This bill equips local land trusts to act quickly and balance development pressure when land becomes available. Our work in restoring habitat by removing invasive species on public and private land has taught us that conservation land must be managed to protect local biodiversity. This legislation will bolster and create new funding programs to help drive both acquisition and stewardship of new publicly owned greenspace.

As you know, species extinction is occurring at an alarming rate: current reports from the United Nations estimate that we are losing more than 150 - 170 unique species per day across the planet; the highest rate since the extinction of the dinosaurs! We must protect the unique biodiversity of Maryland and the Chesapeake Bay. The Chesapeake alone is home to more than 3,000 species of plants and animals, including 348 species of finfish, 173 species of shellfish, and roughly 30 species of waterfowl.

Conservation lands provide vital carbon sinks and create spaces that are resilient to the harmful effects of climate change. Additionally, these spaces contribute towards improved soil stabilization, temperature stability, and preservation of wildlife through expanded habitat. This conservation goal will contribute to protecting our water and air quality while providing outdoor places for Marylanders to connect with nature and the many associated mental and physical health benefits.

We ask for a favorable report on SB470 so that Maryland's rich plant and animal diversity can be better preserved and stewarded.

Thank you for allowing our testimony today in support of SB470. The Maryland Legislative Coalition (MLC) Climate Justice Wing, a statewide coalition of over 50 grassroots and professional organizations, urges you to vote favorably on SB470.

SB470 will create the Local Land Trust Revolving Loan Program to provide loans to land trusts to purchase land for conservation purposes; require the Governor to include in the annual budget funding for the Maryland Environmental Trust for grants through the Keep Maryland Beautiful Program; and establish the 40 x 40 Land Conservation Implementation Grant Program to support a goal of 40% of Maryland land preserved by 2040.

Currently, Maryland has conserved 28.7% of its lands and critical habitats (23% of total land mass) and only annually monitors ~11% of land under easement. Land preservation is critical to the protection of species and the habitats they depend on. The United Nations recently reported that 150 – 170 species permanently go extinct every day. In North America alone, since 1970, bird populations have dropped by more than 30%.

SB470 will set a goal of 40% of Maryland land preserved by 2040; dramatically improve funding available to urban land trusts; and invest in stewardship of lands impacted by climate change and invasive species. For these reasons, we recommend a **FAVORABLE** report for SB470 in committee.

Our community addressed concern for a safe, healthy, flourishing environment that can sustain life in "Caring for Creation" (ELCA, 1993. A healthy environment is also a stated concern of our "Caring for Health," 2003.) Stewardship of natural gifts and processes, through conservation and preservation policies, is wise and just because it protects what is for the benefit of all things now living.

And "all things now living" illustrates the need to defend and conserve a web of life. Undeveloped contexts are also habitat; they sequester carbon; they purify air and water; they buffer watersheds. So, we support preservation and conservation in the natural world for the sake of all things now living. For example, forest integrity and extent in Maryland was a stated interest of our community in 2008 (See LOPP/MD testimony before *EHEA*, Feb. 28, 2008 on *SB431*).

We previously identified two critical concerns: the constellation of issues from the greenhouse effect, and health- and life-sustaining air quality. Those have arisen as critical issues in international policy discourse, as well. An additional, bellwether issue is the confluence of habitat, species, and the eco- of "all things now living." (As one interested advocate, I have taken to reporting that we're living through a Devonian die-off.) Life is disappearing at a catastrophic rate everywhere on the planet. And as of now, the only place the human species has to live is the planet.

**Senate Bill 470** will support the preservation of more undeveloped Maryland geography as beautiful, life-supporting, necessary, naturally occurring space. We urge such a policy initiative. We urge the care and preservation of created (not owned) gifts within the target goals of **Senate Bill 470**. We ask a favorable report.

The Maryland Chapter of the Sierra Club strongly supports SB470, the Maryland the Beautiful Act. This bill establishes a state goal of 30% of Maryland lands conserved by 2030 and 40% of lands conserved by 2040. To accomplish this goal the bill authorizes the existing state Smart Growth Subcabinet to develop and update every five years a plan to meet these goals. Within the Department of Natural Resources (DNR), it creates several categories of funding to conserve agricultural, forested, cultural, and historical lands. These programs will be administered by the Maryland Environmental Trust (MET).

The programs include: 1) a \$10 million Local Land Trust Revolving Loan Fund, a one-time 2025 expense, to enable land trusts to quickly secure funds for newly available land and conservation easements and repay the loan at no lower than 1 point below the prime interest rate; additionally, \$235,000 shall be allocated to the MET each year for 2) Land Trust Capacity grants in support of monitoring and stewardship scholarships, equipment, and organizational trainings (\$50,000); 3) Stewardship Grants to land trusts to improve monitoring and stewardship of Maryland's most important eased agricultural lands, forested lands, or lands facing a high degree of invasive species and/or climate change related threats and damage (\$50,000); and 4) Citizen Stewardship Awards to help community organizations develop innovative solutions to local environmental challenges (\$135,000).

The Maryland the Beautiful bill this year is not completely the same as last year's bill. The ten-million-dollar Local Land Trust Revolving Loan Fund was a component of last year's bill. However, the tree stewardship funding in the 2022 bill passed last year as part of another bill, and this year a different bill (HB503/SB523, which we also strongly support) addresses creating urban greenspaces, which was part of the 2022 bill. New in this year's bill are the small grants to citizen community groups and land trusts to help these types of organizations maintain and steward these new lands.

The Sierra Club strongly supports this investment in the conservation of lands that help protect our communities from the ongoing effects of climate change. Maryland's forests and farms provide valuable ecosystem services such as clean water, clean air, timber, pollination of agricultural plants, habitat for fisheries, and flood control.<sup>1</sup> Historically, the ecosystem service benefits of farms and forests did not have clearly established monetary values.<sup>2</sup> If a forest was logged, the monetary value of the timber was the primary consideration; only recently have the

goods and services provided by the forests been given a monetary value. There is now greater recognition of the value of forests in absorbing air pollutants such as carbon monoxide, ozone, and particulate matter; reducing stormwater runoff; and offsetting carbon dioxide emissions. Maryland's Department of the Environment reported in the Maryland Forest Carbon inventory, for example, that forests offset 14.8% of state emissions.<sup>3</sup>

A recent statewide study of changes in forest cover and tree canopy in Maryland found that "protected lands experienced a significantly lower rate of forest loss and a much higher rate of total tree canopy increase compared with statewide rates. We conclude that protection benefits [land] conservation in Maryland."<sup>4</sup>

In addition to these concrete benefits, this bill will move Maryland closer to the federal government's national goal of 30% of U.S. lands and waters conserved, and wildlife corridors connected by 2030.<sup>5</sup>

A related benefit of conserving more Maryland lands is the beneficial effect on the declining indicators of the state of nature. The first global-scale study of the links between people and nature found that global ecosystems have declined by 47%, 25% of species are threatened with extinction, the biomass of wild mammals has fallen by 82%, and 72% of indicators of nature that are important for quality of life for humans showed declines.<sup>6</sup> This study found that strengthening environmental laws and their implementation was one of the five most effective levers for stopping these declines. Here in Maryland, according to the DNR's 2015-2025 Maryland State Wildlife Action Plan, "there is clear consensus that the loss and degradation of habitats across the state from unplanned growth and unsustainable consumption remain the primary overarching threat to Species of Greatest Conservation Need, as is true nationwide." <sup>7</sup> Given the number and size of the threats, this bill will help address this urgent need in a fiscally responsible manner.

Given the massive challenges of climate change, air and water quality, and species preservation, conserving lands is an excellent value. The Maryland Chapter of the Sierra Club strongly urges a favorable report for Maryland the Beautiful.

### SUPPORT: SB 470 - Natural Resources - Land Conservation - Establishment of Goals and Programs (Maryland the Beautiful Act)

Chairman Guzzone and Members of the Committee:

Maryland LCV supports SB 470, the Maryland the Beautiful Act. This legislation makes important progress on land conservation in Maryland and is a priority bill of the environmental community. We thank Senator Elfreth for leadership supporting environmental conservation in Maryland.

This bill advances Maryland's land conservation efforts with the establishment of the Local Land Trust Revolving Loan Program. It also affirms Maryland's commitment to conserve 40% of land in our state by 2040 and provides much needed support to land trusts and others maintaining these lands and making the connections between the land and Marylanders through grant-supported programs.

In January of 2021, President Biden announced plans to conserve 30% of America's land and waters by 2030. Since then, many states have taken initiative to follow this path by creating their own state-led plans for land conservation. We are urging Maryland to join this important goal, but to commit to go even further by looking to have 40% of land conserved by the year 2040.

To achieve this, the Maryland the Beautiful Act would:

- Allocate a one-time expenditure of \$10 million to create a revolving loan, rapid-response fund land trusts would be able to borrow from to to quickly act when important properties for conservation become available. Revolving loans are sustainable and fiscally-prudent investments to provide financial support while ensuring the opportunity to use that support remains viable for multiple instances and in perpetuity.
- 2. Increase popular grant programs to ensure greater success in habitat conservation, through funds for land stewardship capacity building and improvement, and the promotion of citizen stewardship through the popular Keep Maryland Beautiful grant program. This grant program has been well utilized throughout the state, extending opportunities to connect communities with land stewardship behavior.
- Ensure considerations for land conservation include coordination with local communities and private landowners; improved access to nature for all people in Maryland; sequestering greenhouse gas emissions; and landscape scale conservation that promotes the continuance of important native species and/or stabilizes ecosystems.

Maryland LCV recognizes the importance of planning for and establishing bold conservation goals to protect biodiversity, supporting goals to mitigate the effects of climate change, and increasing access to natural spaces in Maryland. Investing in conservation is a prudent use of state financial resources, supporting the sustainability and livability of our state for future generations. For these reasons we support the enactment of the Maryland the Beautiful Act and urge a favorable report on SB 470.

### TESTIMONY OF DR. MARK SOUTHERLAND – SUPPORT

I am a professional ecologist who has served on the boards of Maryland Science Council, Maryland Water Monitoring Council, Safe Skies Maryland, Howard County Environmental Sustainability Board, Patapsco Heritage Greenway, and Howard County Conservancy. I am speaking on behalf of the Howard County Conservancy, a nonprofit land trust that has been preserving land in Howard County since 1990 (howardnature.org).

### The Science is Clear

Earth's foundational, billion-year-old environmental support system cannot be replaced. **Once species are gone, they are gone forever**. Today, as many as 1 million species of an estimated total 8 million species that exist on planet earth are threatened with extinction. Of all the plants and animals with whom we share the planet, only we have the power to choose the path our collective futures will take.

Over the past 50 years, more than 1 million acres of forestland and farmland in Maryland have been developed, imperiling native species, ecosystem services, and the economy and recreation that relies on our cherished lands. In May 2022, the Biden administration issued Conserving and Restoring *America the Beautiful*, detailing steps that the United States should take, working with State, local, Tribal, and territorial governments, agricultural and forest landowners, fishermen, and other key stakeholders to achieve the goal of conserving at least 30 percent of our lands and waters by 2030. Maryland should do the same to provide adequate space for nature and bolster our state's strategy to mitigate the impacts of climate change.

### This is the Right Bill:

The *Maryland the Beautiful* Act responds to this nature crisis by setting a statewide conservation goal and providing the tools to advance conservation progress and ensure that all Maryland communities can benefit:

- Establishing a goal to protect open space through Smart Growth Subcabinet
- Making greenspace more equitable through Greenspace Equity Program
- Empowering conservation efforts through Revolving Loan Fund
- Improving the health of forestland through Mel Noland Woodland Incentives Program
- Contributing to climate resiliency by offsetting greenhouse gas emissions

### The Howard County Conservancy is a Case Study in What Can Be Accomplished:

Acting as a land trust since 1990, the Conservancy:

- Will reach the milestone of 2,000 acres preserved in Howard County through our easement programs
- These conservation easements provide preservation options for private property owners, providing important tax incentives to individuals
- Through a new grant funded program, we are now able to purchase conservation easements from nonprofits like churches, who otherwise would not benefit from the tax benefits of a donated easement
- Our easements come with long-term stewardship responsibilities for our organization and this legislation will assist the many land trusts like the Conservancy to ensure the health of these important ecosystems.

### Maryland has the chance to do our part to conserve nature and reap its economic, climate, and quality-of-life benefits for the generations to come.

Chesapeake Bay Foundation (CBF) **SUPPORTS** SB 470 which sets a new state land conservation goal of 30% of Maryland land protected by 2030, and an additional goal of 40% of land conserved by 2040. The bill furthers this goal through the creation of a Rapid Response Revolving Loan Fund that will assist small and medium-sized land trusts in preserving critical lands right away.

The Chesapeake Bay's land-to-water ratio is 15:1—larger than any other coastal estuary in the world. When the land suffers from pollution and poor management the Bay's water quality also worsens. A profound relationship exists between the water of the Chesapeake Bay and the 64,000 square miles of land comprising the Bay's watershed. Approximately 100,000 rivers and streams run into the Bay. This tributary system directly connects farms, forests, and developed communities in six states and the District of Columbia with the Chesapeake.

Today, there are 18 million residents in the watershed, and the number is expected to grow to 19.4 million by 2025. By the late 1800s, 40 to 50 percent of the watershed's forest had been cleared of trees, according to the Chesapeake Bay Program. Between 1982 and 1997, the Bay watershed lost more than 750,000 acres of forestland to development, about 100 acres per day. Wetlands were equally decimated. These natural filters are critical to protecting the Bay from challenges like climate change, sea-level rise, and species loss.

CBF firmly believes it is possible to restore the Bay. But the continuing loss of natural filters and vital landbased ecosystems makes restoration of the Bay, and the achievement of the goals of the <u>Chesapeake Clean</u> <u>Water Blueprint</u>, much more difficult to achieve. Land conservation is an essential part of the Bay's recovery.

### Testimony in Favor of SB470 Natural Resources – Land Conservation – Establishment of Goals and Programs (Maryland the Beautiful Act)

Chairman Guzzone, Vice-Chair Rosapepe, & members of the Budget and Taxation Committee,

I respectfully request a favorable report of Senate Bill 470 to provide the necessary programs and resources for Maryland to conserve 30% of State land by 2030 (30 x 30) and 40% of State land by 2040 (40 x 40).

Considering the current threats to wildlife habitats and the frequent emission of greenhouse gasses, Maryland should waste no time in stepping up our conservation efforts. According to the United Nations, humans have "significantly altered" three-fourths of the Earth's land, threatening one million plants and animals and causing between 150 and 170 species to become extinct per day. Likewise, the burning of fossil fuels is polluting our air and increasing the risk of climate change, making the conservation of greenhouse gas absorbing plants essential. As a defense against these threats, the preservation of land and green infrastructure will be our first line of defense in mitigating the impacts of more severe storms and rising temperatures.

The dangers that our environment is currently facing has prompted leaders across the world to call for conservation of 50% of the Earth's landmass. In the early months of his presidency, the Biden Administration enacted the "America the Beautiful" initiative, a proposal to preserve and restore 30% of the country's land and water by the year 2030.

With programs like the Maryland Agriculture Land Preservation Foundation (MALPF) and Program Open Space, Maryland has been able to preserve 23% of its land and water and 28.7%

of its land and critical habitats. We should build on our current progress by providing tools, strategy, and resources to protect Maryland habitats from further degradation.

### In order to support the process of reaching our 30 x 30 and 40 x 40 goals, this legislation:

- 1. Sets in law that it is the intent of the General Assembly to conserve 30% of our lands by 2030 and 40% by 2040.
- 2. Creates a \$10 million Land Trust Rapid Response Revolving Loan Fund Program to expedite the process of securing land for smaller and medium-sized trusts that is operated by the Maryland Environmental Trust.
- 3. Creates an advisory committee to make recommendations on the use of the loan fund.
- 4. Empowers the Smart Growth Subcabinet to coordinate actions of governments and nongovernmental partners to meet our conservation goals – but also develop a plan by 2024 on how we are going to meet the goals outlined in the bill, and submit annual reports to the General Assembly on our progress.

### To support the nonprofit actors that will help us reach our conservation goals, this legislation will:

- 1. Create the 40 x 40 Land Conservation Grant Program to provide support to organizations dedicated to implementation of the conservation goals established by the Bill and that provide support and education opportunities to our conservation community.
- 2. Create citizen stewardship grants to be awarded to nonprofits, community organizations, schools, and municipalities to expand environmental education and stewardship opportunities.
- 3. Create small but meaningful grants to be awarded to land trusts to support further stewardship and technology support for their critical monitoring efforts.

With the funding opportunities, goals, and strategy created by SB470, this legislation will establish Maryland as a nation-wide leader in further conservation of our State's lands. Once again, I respectfully request a favorable report of Senate Bill 470 to provide the necessary funding and expertise to conserve these critical state lands.

Scenic Rivers Land Trust supports the Maryland the Beautiful Act (SB 470).

SB 470 would set a goal for Maryland to have 30% of its lands conserved by 2030 and 40% by 2040. Keeping a significant portion of our land wild and open allows nature and our communities to be resilient towards severe weather, helps our food systems to survive, and gives Maryland residents places of beauty, solace, and recreation.

Not only does it set a goal to measure our progress by, but it also increases the pace at which land trusts can save vulnerable parcels. A \$10,000,000 revolving loan program will allow land trusts to access funds in the nick of time to save an imperiled and important property. This is critical to these nonprofits (Scenic Rivers Land Trust being one of them) that witness precious properties slip through their fingers because they couldn't get grant funding fast enough. Often grant funding takes two to four years to obtain, which far too long when a property is already on the open market.

For example, in 2020 a 45-acre property became available for sale that was on our "Top 100" list of most important properties to conserve in Anne Arundel County. The landowners were only willing to wait a year for us to raise funds and purchase the property. Unfortunately, \$2.7 million is difficult for a small nonprofit to raise in that short amount of time. The landowners now have a contract with a developer, and they have recently submitted a subdivision application to build 40 homes.

I am delighted to see that in light of setting goals to increase the pace of conservation, this bill also provides annual funding to land trusts for stewardship, which is vital funding in ensuring that the land we protect stays protected in perpetuity. Our portfolios of conserved land are ever growing, and therefore we need ever increasing funding to keep a watchful eye and provide a helpful hand on the 93,000+ acres of land protected by local land trusts.

By passing the Maryland the Beautiful Act, we can help ensure that nature and people will continue to thrive in Maryland today and long into the future. We appreciate your service and respectfully request a favorable report.

The Maryland Building Industry Association, representing 100,000 employees statewide, appreciates the opportunity to participate in the discussion surrounding **SB 470 Natural Resources - Land Conservation - Establishment of Goals and Programs (Maryland the Beautiful Act)**. MBIA **Opposes** the Act in its current version.

This bill would establish a trust fund and incentive program for the state to spend money buying land for the purposes of preventing development and incentivizing landowners to forgo development. MBIA opposes this measure. While maintaining natural resources are important, it is reckless to create a committee specifically designated to preventing any state development and handing them 10 million dollars to make land purchases for no functional purpose. The representatives on the board require no academic or professional expertise in land development, forest conservation, project management, environmental impact analysis or any other relevant field required to make this proposal tenable.

Additionally, this committee would be targeted at lands that are currently eligible to be developed under Maryland Law, which is already a small portion of the state's landmass. This bill takes no regard for human habitation and needs. According to Freddie Mac and the National Realtors Association, Maryland currently has a 120,000 housing unit deficit. This number is growing under current state policies having risen there from an estimated 82,000 unit deficit in 2021. It is reckless and irresponsible to create a new entity for the sole purpose of diminishing the already desperately needed developable land in order to meet the massive housing shortfall that is only growing a regulations new initiative make it more expensive and more difficult to find places to build these needed homes.


#### Unfavorable: SB 470 – Land Conservation Establishment of Goals and Programs

Dear, Chair Guzzone and Committee Members:

The NAIOP Maryland Chapters representing more than 700 companies involved in all aspects of commercial, industrial, and mixed-use real estate, recommends an unfavorable report on Senate Bill 470 and, instead, including the purposes of the bill into a more wholistic systems approach that can build a framework to set goals for Maryland's designated growth areas, local green spaces and rural conservation areas that will serve Maryland's needs for the next generation.

According to Chesapeake Bay Program data, by 2018 30% of Maryland's land area was protected by conservation and other easements. Senate Bill 470 sets a goal of permanently preserving 40% of the state's land area which would increase the land under preservation by an additional 565,000 acres to a total of 2.3 million acres. The goals of the bill emphasize the need to increase open spaces within urban areas as a part of that conservation goal.

Maryland's Priority Funding Areas were first designated 25 years ago. At that time they were zoned and sized to accomodate



population growth over a 20-year period. Today the growth areas of the state have diminished development capacity and are not in position to serve as the future housing and employment centers they are supposed to be.

Senate Bill 470 sets up a planning process that is focused only on meeting preservation goals. We believe a more comprehensive approach that balances future growth and land conservation goals woud produce better overall results. Also, the costs of the program could potentially be reduced by counting land in certain conservation zoning categories toward the goals.

### **SHORT TITLE: Maryland the Beautiful Act**

#### DEPARTMENT'S POSITION: LETTER OF INFORMATION WITH AMENDMENTS

#### **EXPLANATION OF DEPARTMENT'S POSITION:**

#### Local Land Trust Revolving Loan Program

SB 470 would establish a significant new program, the "Local Land Trust Revolving Loan Program," to be administered by the Maryland Environmental Trust (MET), a unit of the Department, for providing revolving loans to land trusts in Maryland to assist them in their purchase of conservation land or easements. The loans would be made on a rolling basis, and a land trust that receives a loan from the program would repay the loan after the property has been placed under easement or transferred to a state or local government entity. The bill proposes that in fiscal year 2025 the Governor shall include in the annual budget bill an appropriation of \$10,000,000 to establish the revolving loan fund.

MET proposes amendments to Sections 3-214, 3-215, and 3-216 of SB 470 that will provide necessary clarification and guidance to MET's staff and Board of Trustees in effectively administering this new program. These include provisions for MET to establish program processes and procedures, loan terms, and a timeframe for loan repayment, as well as language stating a state or local government entity is not obligated to accept an easement or transfer of land acquired through the loan fund. This would be to account for if or when a property may not be consistent with the goals and/or mission of the state or local government.

#### Other grants established by SB 470

SB 470 would also establish the new "40 x 40 Land Conservation Implementation Grant Program" to be administered by MET in support of the land conservation goals set forth in the bill. This grant of \$250,000 would be awarded annually on a competitive basis to a statewide nonprofit supporting conservation of land in Maryland for presenting educational conferences and training for land trusts, as well as providing resources for land trust organizational support and capacity building. SB 470 also calls for an increase in state funding, \$235,000 annually, for the Keep Maryland Beautiful (KMB) suite of grant programs that MET administers per Nat. Res. Art. Sec 3-210.

MET would request consideration of additional staff to implement the bill's proposed new programs and funding.

The amendments also delete what would be a duplicative setting and reporting of land conservation, recognizing the existing Managing for Results budget process, as well as the Land Preservation Dashboard from the Maryland Department of Planning website.

#### **BACKGROUND INFORMATION:**

SB 470 establishes two new grant programs to be administered by MET, and increases the funding for the existing Keep Maryland Beautiful (KMB) grants program, which MET administers since 1967 in accordance with Nat. Res. Art. Sec 3-210. KMB provides grants on an annual basis to help volunteer-based nonprofit groups, communities, schools, and land trusts in Maryland support environmental education projects, litter removal, and citizen stewardship, and to protect natural resources in urban and rural areas. In 2022, KMB awarded 85 grants totaling \$320,000, both of which were record figures. The increase of funds proposed by SB 470 would be a much welcomed addition of funds to the program.

#### **BILL EXPLANATION:**

SB 470 establishes goals and programs related to land conservation in Maryland. It establishes a goal that 30% of the lands in the state will be conserved by 2030, and a goal that 40% of the lands will be conserved by 2040. The bill establishes the new Local Land Trust Revolving Loan Program to be administered by MET for providing loans to land trusts in the State to purchase land for conservation purposes, and it creates a \$10 million revolving loan fund as a special, nonlapsing fund starting in FY 2025. SB 470 provides annual funding starting in FY 2025 to MET to be used for providing grants through MET's Keep Maryland Beautiful Program. The bill establishes a new 40 x 40 Land Conservation Implementation Grant Program to be administered by MET to support implementation of land conservation partners' efforts in meeting and reporting the State's conservation goals.
