On behalf of our member families, I submit this written testimony in support of SB 866. This bill requires the Governor to include in the annual budget bill beginning in fiscal year 2025 an appropriation for the Chesapeake Bay Trust and Maryland Agricultural Education Foundation, Inc. that is calculated based on the amount of revenue lost if/when special vehicle registration plates are created.

Maryland Agriculture Education Foundation (MAEF) receives funding from the sale and registration of the Ag tags. The Chesapeake Bay Trust also receives funding from the Bay tag. Currently, these are the only two special vehicle registration plates. If there were to be more plates created, the fund source would go down because of the added type of plates. This bill seeks to make sure MAEF and CBT receive level funding if their revenue from the plate sales go down. Even though our policy opposes any new commemorative license plates, we see this solution being one that we can support if new plates were approved and created.

MDFB Policy: We support the Maryland Ag Tag, and we believe that all fees derived from sales should continue to be used to support MAEF.

We oppose increasing the number of commemorative license plates beyond the Maryland Ag Tag and Chesapeake Bay Tag.

Good afternoon. My name is Jim Brown. I am the policy director for Audubon Mid-Atlantic, here in Maryland. Audubon Mid-Atlantic is the regional office of National Audubon Society, representing over 35,000 Marylanders who advocate for the protection of birds, bird habitat, and policies aiming to protect both birds and human communities in the face of increasing environmental challenges, habitat loss, pollution, and climate change.

Audubon Mid-Atlantic enthusiastically supports the SB866. Funding environmental education, habitat restoration, stormwater projects, tree plantings, and community greening is critical to protecting the ecosystems of the Chesapeake Bay watershed and to sustaining a movement of climate stewards in all of our diverse communities and landscapes here in Maryland and across the bay watershed. Chesapeake Bay Trust (the Trust) and Maryland Agricultural Education Foundation (MAEF) fund invaluable projects and conduct meaningful engagement in every county and legislative jurisdiction in the state. These programs connect people to nature and plant the seeds for Maryland's future generations of conservationists and sustainability practitioners.

For more than a decade, the Trust has supported Patterson Park Audubon Center's community-centered conservation programs that seek to improve Baltimore City for migratory birds, the Bay, and our communities. Because of investment from the Trust, Audubon has fostered youth leadership on environmental issues, elevating their voices for healthier waterways, habitats, schoolyards, and neighborhoods. The National Wildlife Federation respectfully requests a favorable report for SB 866 – Special Vehicle Registration Plates – Chesapeake Bay Trust and Maryland Agricultural Education Foundation – Appropriation, with a revenue calculation amendment, which will ensure that state funding for the Chesapeake Bay Trust (the Trust) and the Maryland Agricultural Education Foundation (MAEF) remains stable as additional background scene/commemorative vehicle license plates become available to vehicle owners in Maryland in coming years.

Founded in 1936, National Wildlife Federation (NWF) is one of the country's oldest and largest conservation organizations. NWF's Mid-Atlantic Regional Center, based in Annapolis, Maryland, works closely with state and local partners to protect and restore wildlife habitat and to support resilient, healthy communities across the state, and throughout the Chesapeake Bay watershed. Over the years, funding from the Chesapeake Bay Trust has allowed NWF to work directly with communities in Baltimore City, Prince George's County, Howard County and others to install green stormwater infrastructure and coastal resilience projects, plant native pollinator habitat, increase equitable access to nearby nature, and educate and engage K-12 students, teachers, and the broader community.

The grant programs administered by the Chesapeake Bay Trust help to support the critical work of nearly 350 community-based groups to reduce pollution and clean up our rivers and streams, restore thriving natural habitats, improve access to local green spaces, and foster the next generation of conservation leaders. In the past year alone, the Trust's grantmaking resulted in the installation of almost 300,000 native trees, pollinator plants, marsh grasses, and other native plants; the release of over 4 million oysters; the creation of almost 48,000 square feet of rain gardens; and the engagement of close to 27,000 students and 1,800 teachers.

Providing stable funding for the Trust, augmenting any "Bay Plate" revenue declines as new license plates become available in the future, will help ensure the ongoing success of these grant programs and the direct benefits they provide to communities throughout the state. We appreciate the opportunity to submit this written testimony and respectfully urge the committee to issue a favorable report on SB 866.

Summary

Maryland has had only two commemorative vehicle license plates for 23 years: the "bay plate" and "ag tag." Should additional commemorative plates be introduced, bay plate and ag tag revenues would likely decline (Figs 1-3 below). SB 866, if amended with a new formula, would keep the revenue managed by the Chesapeake Bay Trust (Trust) and Maryland Agricultural Education Foundation (MAEF) "whole" using general fund appropriations, benchmarked to current levels. The Trust does not keep the bay plate revenue: It distributes the funds to 350-400 grantees per year throughout Maryland (Youghiogheny, Chesapeake, and Coastal Bays watersheds). The amended bill would therefore predominantly help these hundreds of grantees.

Background on the Chesapeake Bay Trust

The Trust, a nonprofit grant-maker, was established by the General Assembly in 1985 to complement the work of larger state agencies by reaching community-based groups directly on the ground. The Trust's method is to empower groups by providing them the ability to lead and own their own work to co-benefit their communities and natural resources, mainly through grants.




Figure 2: Examples of decreases in specialty license plate revenue with increasing #s of additional plates over time

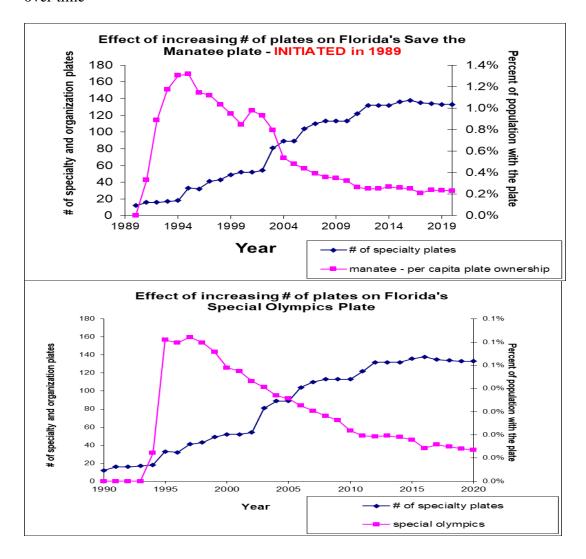



Figure 3: Florida license plate picture in 2005 (fewer plate options) vs. 2015 (more plate options): As there are more plate options, each individual one has a smaller piece of the revenue pie

When the Trust was created, the General Assembly <u>did not provide a general appropriation</u>, but instead created two revenue streams: <u>The Chesapeake Bay Commemorative License Plate program</u> and the <u>Chesapeake and Endangered Species Tax Check Off</u> that raise private dollars. Bay plate revenue has remained stable since 2010, generating ~\$3.5 million per year. This stability is because the number of commemorative license plate options has not changed for 23 years. <u>Should more license plate designs become available</u>, because there is a fixed number of vehicles, bay plate (and ag tag) revenue will likely <u>drop</u>, as has happened in other states (Figures 2, 3). <u>Should revenues drop</u>, <u>Trust grant-making would also drop</u>, and the Trust will be able to support fewer grantee organizations.

The nature of license plate revenue

Data from other states show that only about 8-10% of the population will spend an additional amount (~\$20) for a colorful license plate (Fig 1 below). Considering bay plates, ag tags, and the 900+ organizational tags (https://mva.maryland.gov/Pages/licenseplates-Organizational.aspx, mainly designed for awareness/pride rather than revenue), Maryland is at about the 10% saturation level now. Public opinion polling shows that about 70% of people buy the bay plate for aesthetic value. Currently the demographics of bay and ag tags owners are close to the demographics of Maryland by geography,

gender, and ethnicity/race. For example, 29-37% and 37-44% of people who have bay plates and ag tags, respectively, on their vehicles or on those of household members are of color.

Because there is a finite number of registered vehicles and 10% of the population already has a special license plate, the larger the number of license plate options, the less revenue each will generate (Figure 2 below). SB 866 would compensate for the drop in bay plate and ag tag revenue, as new plates become available to vehicle owners, with a general appropriation, with an amendment proposed that it be benchmarked to FY17-FY22 levels.

Chesapeake Bay Trust grant-making

The Trust has made grants in every Maryland district, \$150 million through 12,000+ grants and projects since 1985, providing support for 100,000 K-12 students and adults annually to learn and accomplish measurable environmental improvement. The Trust makes 350-400 awards per year and has ~1,000 active awardees at any one time. (see https://cbtrust.org/annual-report/).

Demand far exceeds availability of even current level of funds by about 3:1. Trust grantees are of two types: environmental organizations and non-environmental organizations that pursue green projects. Examples of the latter are schools, faith-based entities, homeowners and civic associations, and nonprofits focusing on other causes (health, jobs, housing, etc.) who see an intersection between environment and their cause (e.g., Veterans Engagement program (https://cbtrust.org/grants/veterans-engagement/). The Trust has long worked to bring new audiences to the table, as indicated by a 15+-year old Diversity, Equity, and Inclusion initiative (https://cbtrust.org/diversity-inclusion/).





The Trust is known for its efficiency, putting on average 90 cents of every dollar into programs. Due to this uncommonly high efficiency, the Trust has been rated with the maximum four-star rating by the nation's leading charity evaluator, Charity Navigator, for more than two decades, putting it in the top 1% of non-profits in the nation.





Value of Bay Plate Revenue in Leveraging More Money for Maryland The Trust leverages the \$4 million in unrestricted bay plate and tax checkoff dollars into \$20 million+ annually by attracting other partners with resources. An example is the Trust's partnership with the U.S. Environmental Protection Agency, in which the Trust offers \$300,000, and the EPA matches it annually with ~\$1,000,000 for a Green Streets, Green Jobs, Green Towns grant program. https://cbtrust.org/grants/green-streets-green-jobs-green-towns/.

In addition, in 2021 and 2022, the General Assembly tapped the Trust to create and administer the Urban Trees Grant Program (2021) https://cbtrust.org/grants/urban-trees/ and the Chesapeake Conservation Corps (2020) www.cbtrust.org/corps, which is partly staffed and supported with unrestricted Bay Plate dollars. The bay plate and other unrestricted revenue also fund the Trust's K-12 environmental education, on-the-ground restoration, and community engagement grant programs.

Figure 1: Market saturation of background scene plates, with an example from Florida. (Florida posts their data in the clearest, most accessible format. Partial data are available from other states.)

Chairman Guzzone and Members of the Committee on Budget and Taxation,

The organizations listed below respectfully urge a favorable report on SB 866 with a revenue calculation amendment to benchmark the annual revenue managed by the Chesapeake Bay Trust (the Trust) and Maryland Agricultural Education Foundation (MAEF) to FY17-FY22 levels. In the unamended bill version, the revenues decline over time. SB866, with the amendment, ensures that the revenues managed by the Trust and MAEF remain stable as additional background scene/commemorative vehicle license plates become available to vehicle owners in Maryland in coming years.

Both the Trust and MAEF were established via government initiative, either statutorily by the General Assembly (the Trust, SB 583/ Chapter 789 of 1985) or as a result of a Governor's task force (MAEF). Neither were designed on a general fund appropriation model; rather, their important missions have been supported by private revenues generated by commemorative vehicle license plates now ubiquitous and a source of pride in Maryland (the "bay plate" and the "ag tag"). These two plates have been the only two commemorative plates in Maryland for 23 years, which has kept their revenues stable, unlike other states in which hundreds have developed over time (Florida, Virginia, Texas). As more background scene plates become available in any state, revenues generated by existing plates decline, because there is a finite number of vehicles. The same is expected to occur in Maryland.

If revenue managed by the Trust or MAEF were to decline, our organizations, along with many others in your districts, will be directly affected. Both the Trust and MAEF offer grant resources (and programming, for MAEF) to support groups like us.

The Trust distributes the bay plate revenue through 400 grants per year to engage Marylanders in the restoration of our natural resources (from mountains to Coastal Bays, in every legislative district). Over 100,000 students and adults every year have experiences that connect them to nature as a result of these grants (along with real, measurable environmental improvement). Some grantee organizations' project budgets are more than 50% derived from the Trust.

MAEF provides grants, scholarships, and/or science-based programming to approximately 50,000 elementary students per year; professional development for teachers; and important support for agricultural education at secondary and post-secondary levels. Agriculture is the state's largest commercial industry, and without the services provided by MAEF, we will not have the next generation of individuals to support the agricultural industry.

For these reasons, we request a Favorable with Amendment report on SB 866.

The Rural Maryland Council supports with amendment Senate Bill 866 – Special Vehicle Registration Plates – Chesapeake Bay Trust and Maryland Agricultural Education Foundation – Appropriation. This bill requires the Governor to include in the annual budget bill for certain fiscal years an appropriation for the Chesapeake Bay Trust and Maryland Agricultural Education Foundation, Inc. that is calculated based on the amount of revenue collected from certain special vehicle registration plates in certain fiscal years; and, generally relating to the funding for the Chesapeake Bay Trust (the "Trust) and the Maryland Agricultural Education Foundation (MAEF).

The Trust's mission is to engage and empower diverse groups to take actions that enrich natural resources and local communities of the Chesapeake Bay region. This is accomplished by annually awarding more than \$10 million in grant funding each year to hundreds of nonprofits and community organizations throughout the region for hands-on projects that are ensuring a cleaner, greener, healthier Chesapeake, Coastal Bays and Youghiogheny watershed for years to come. MAEF's mission is to promote the importance of agriculture in everyone's daily lives by increasing agricultural literacy and agricultural education. MAEF provides grants, scholarships, and/or science-based programming to approximately 50,000 elementary students per year; professional development for teachers; and important support for agricultural education at secondary and post-secondary levels.

For the past 23 years, both the Trust and MAEF have been supported by private revenues generated by commemorative vehicle license plates now ubiquitous and a source of pride in Maryland (the "bay plate" and the "ag tag"). With an increase in interest in additional plates being offered by other organizations, the revenue generated by the Trust and MAEF plates will decline. If revenue managed by the Trust or MAEF were to decline, grant funded projects related to their work will be directly affected. Senate Bill 866 will provide an annual appropriation for the Trust and MAEF to make these two organizations whole.

The Rural Maryland Council respectfully requests your favorable support with amendments to ensure the revenues managed by MAEF and the Trust remain stable.

The Rural Maryland Council (RMC) is an independent state agency governed by a nonpartisan, 40-member board that consists of inclusive representation from the federal, state, regional, county and municipal governments, as well as the for-profit and nonprofit sectors. I respectfully urge a favorable report on SB 866 with a revenue calculation amendment to benchmark the annual revenue managed by the Chesapeake Bay Trust (the "CBT") and Maryland Agricultural Education Foundation ("MAEF") to FY17-FY22 levels. In the unamended bill version, the revenues will undoubtedly decline over time. Senate Bill 866, with the amendment, ensures that the revenues managed by CBT and MAEF remain stable as additional background scene/commemorative vehicle license plates become available to vehicle owners in Maryland.

Both CBT and MAEF were established via government initiative, either statutorily by the General Assembly (CBT through SB 583/ Chapter 789 of 1985) or as a result of a Governor's task force (MAEF). Neither entities were designed on a general fund appropriation model; rather, their important missions have been supported through private revenues generated by the now ubiquitous commemorative vehicle license plates and a source of pride in Maryland (the "Bay Plate" and the "Ag Tag"). These two license plates have been the only two commemorative plates in Maryland for 23 years, which has helped to keep these entities' revenues stable. In States in which multiple specialty license plates have developed (like Florida, Virginia, Texas) the revenue shared by such entities is unstable and declining As more background scene plates become available in any State, revenues generated by existing plates naturally decline, because there is a finite number of vehicles utilizing the license plates. The same is expected to occur in Maryland. If revenue managed by the Trust or MAEF were to decline, these nonprofit entities, along with many others in your Districts, will be negatively and directly affected.

Both CBT and MAEF offer grant resources (and programming within MAEF) to support those on the front line in environmental stewardship and education efforts. CBT distributes the Bay Plate revenue through 400+ grants per year to engage Marylanders in the restoration of our State's natural resources (from mountains to Coastal Bays, in every legislative District). Over 100,000 students and adults every year have experiences that connect them to nature as a result of these grants (along with real, measurable environmental improvement). Some grantee organizations' project budgets are more than 50% derived from the distribution of CBT grant funding. MAEF provides grants, scholarships, and science-based programming to approximately 50,000 elementary students per year; professional development for teachers; and important support for agricultural education at secondary and post-secondary levels. Agriculture is the state's largest commercial industry, and without the services provided by MAEF, our State will not have the next generation of individuals and leaders to support the agricultural industry.

For these reasons and more, I request a Favorable with the referenced Amendment reported on SB 866.

Good afternoon, Chair Guzzone, Vice Chair Rosapepe, and distinguished members of the committee. It is my pleasure to testify today in **support** of **Senate Bill 866 - Special Vehicle Registration Plates - Chesapeake Bay Trust and Maryland Agricultural Education Foundation - Appropriation.**

Senate Bill 866 is a companion bill to Senate Bill 867 – The Maryland Heroes Plate legislation - which almost every member of this committee cosponsored. Senate Bill 866 would ensure that the Chesapeake Bay Trust and Maryland Agricultural Education Foundation (MAEF) would not lose revenue due to declining license plate sales.

The Chesapeake Bay Trust and MAEF's operations are almost entirely dependent on the revenue generated from the sale and renewal of their current special license plates. This bill is intended to create a more sustainable funding source for these two entities in case of declining sales, providing more longevity for their existence and grant programs.

The amendments being offered are a calculation based on the average revenue generated from the FY17-FY22 levels and tied to the Consumer Price Index (CPI). Should the revenue from a fiscal year be less than the average from before the new plate is introduced, the Governor shall include an appropriation in their annual budget to make up the lost monies.

Summary

Maryland's two colorful commemorative license plates, the "Ag Tag" and the "Bay Plate," have benefitted Maryland for more than two decades by providing revenue to support the Maryland Agricultural Education Foundation (MAEF) and the Chesapeake Bay Trust (CBT). Revenues have remained stable for these organizations and their important work because only two commemorative plates have been available. In other states, when additional plates have been added, revenues for each plate have declined. SB866, with the amendments offered, would benchmark a minimum revenue level using general fund appropriations. If there is no loss in revenue, no appropriations would be required.

Background

The Maryland Agricultural Education Foundation was formed in 1989 at the recommendation of a Governor's Task Force to support agricultural education and promote agricultural literacy. At the time, budget cuts had required elimination of positions and services in support of Agriculture Education at the Maryland State Department of Education (MSDE). A group of private citizens and the agricultural industry fostered the foundation through its early years.

Maryland's "Ag Tag" debuted in 2001, and the revenues from the tag greatly increased MAEF's ability to grow its services to Maryland education. (In addition to the "Ag Tag" license plate revenues, MAEF is supported by private gifts, grants and program fees.)

Over the ensuing decades, MAEF has picked up roles and responsibilities which had traditionally been part of MSDE's Office of Agriculture Education, including professional development training for Agriculture Teachers, management of the Career Student Technical Organization, Maryland FFA, and day-to-day duties within the Environment, Agriculture and Natural Resources cluster.

In addition, MAEF operates a statewide Agricultural Literacy program, providing Mobile Science Lab programs to 50,000 elementary students annually and Mobile Agriculture Showcase exhibits to public events; offers professional development opportunities for all teachers to master using agriculture as a relevant context for teaching core subjects at any level; provides important connections, support and direction for Agriculture Education and Literacy programs statewide; offers two scholarship programs annually and provides grants for school and community gardens.

Upcoming changes to Maryland's educational system as a result of the Blueprint for Maryland's Future will greatly impact Agriculture Education. This pathway provides an important pipeline for individuals to prepare for careers in <u>Maryland's largest commercial industry</u>, which is responsible for 350,000 jobs and more than \$8.25 billion to Maryland's economy annually, generating more than \$755.2 million in state and local taxes.

Testimony in <u>SUPPORT WITH AMENDMENT</u> of SB866 – Special Vehicle Registration Plates - Chesapeake Bay Trust and Maryland Agricultural Education Foundation – Appropriation

Dear Chairman Guzzone and Members of the Committee,

Thank you for this opportunity to submit testimony in **SUPPORT WITH AMENDMENT** of **SB866** on behalf of ShoreRivers. ShoreRivers is a river protection group on Maryland's Eastern Shore with more than 2,000 members. Our mission is to protect and restore our Eastern Shore waterways through science-based advocacy, restoration, and education.

This bill will ensure that funding remains stable for the Chesapeake Bay Trust and Maryland Agricultural Education Foundation so that they can continue to provide grants and support to organizations throughout the Chesapeake Bay watershed. Organizations like ShoreRivers depend on these grants to carry out our work every year. Since 2017, ShoreRivers has received more than 53 grants totaling \$2.7 million from the Chesapeake Bay Trust, accounting for about a quarter of the grant funding received from state and federal sources. If this funding stream were to be decreased it would have a major detrimental impact on our work and would disproportionately impact the Eastern Shore, where funding resources are already limited.

This grant funding from the Chesapeake Bay Trust has allowed ShoreRivers to install ground-breaking wetlands restoration technology, provide Meaningful Environmental Educational Experiences to thousands of schoolchildren, plant hundreds of trees, engage hundreds of thousands of people on critical environmental topics like harmful algal blooms and climate change, and support community events that showcase our water monitoring programs, among many other things. These grants, combined with the federal funding received by leveraging these grants, have enabled ShoreRivers to install more than 260 major restoration projects across our territory that are annually preventing more than 160,000 pounds of nitrogen, 17,000 pounds of phosphorus, and 5,500 tons of sediment from entering our rivers. By using this funding and our expertise, we are able reduce nitrogen at a rate of about \$121 per pound, compared to the \$5,000 per pound that it costs in urban stormwater retrofits. These grants from the Chesapeake Bay Trust are incredibly cost effective and provide tremendous benefit for our local waterways and communities.

We support this bill because it will ensure a steady stream of funding for the Chesapeake Bay Trust that organizations like ShoreRivers, and hundreds of others throughout the Bay watershed, depend on to continue doing on-the-ground work to protect and restore Chesapeake Bay. We urge the Committee to adopt a **FAVORABLE** report on **SB866** with the proposed revenue calculation amendment.
