ACT's philosophy is that economic development for low income residents must empower without displacement or dispossession. ACT's initiatives include serving as master developer for the Baltimore Pumphouse, an adaptive reuse strategy designed to bring jobs and investment to the working-class north-of-the-tracks neighborhoods of Baltimore, Maryland.

ACT is also working to convert the last mile along the rail line entering Baltimore City into a beautiful linear park and pedestrian walkway, called Last Mile Park. The goal is to unite the neighborhoods north and south of the tracks, creating a safe place to live and work.

### There is a critical need for Senate Bill 874 in East Baltimore.

There is a critical need to deter crime and promote community safety in Broadway East and surrounding communities. According to the Baltimore Police Crime Map, there have been a total of 252 crimes within the past year. Given the size of its footprint, .440 square miles, this represents a high concentration of crime. Among all crimes, the most prevalent is aggravated assault, with 64. This is followed by larceny 40, burglary 31, auto larceny 30, auto theft 26, street robbery 20, shootings 19, homicide 7, carjacking 7, residential robbery 5, arson 2 and commercial robbery 2. Since 2016, there have been a total of 189 homicides in zip code 21213; 42% were in Broadway East.

### Senate Bill 874 would support ACT's ongoing work to build a safer community.

ACT works to promote positive resident and officer engagement in north-of- the-tracks neighborhoods by supporting officer wellness and building on community initiatives that

support strong relationships and mutual trust between public safety officers and the communities they serve. Research demonstrates that the wellness and safety of officers is critical to public safety and effective crime prevention (Source: 21st Century Policing, 2015). Equally critical are strong relationships and mutual trust between law enforcement agencies and the communities they serve. Supported officers are less stressed officers; less stress increases wellness, which in turn, increases competency and community relations.

Because public safety officers rely on the cooperation of community members to provide information about crime in their neighborhoods, residents are a critical partner in working with the police to devise solutions to crime and disorder. (Source: Importance of Police-Community Relationships, 2016). ACT focuses its public safety efforts on helping to build that community trust.

Senate Bill 874 is an invaluable, strategic tool for helping to support the delicate work building trust with local law enforcement and making communities safer. By supporting the permanency of this program, the General Assembly would also help build expertise among DHCD personnel and partnering agencies about what works to make communities safer and how public safety approaches can be effectively layered with community revitalization techniques.

As Baltimore City prioritizes, as it should, solving and reducing gun violence and murders, programs like this helps to establish a mechanism for victims of all crimes to feel supported and work to prevent lower level crimes from taking hold in neighborhoods

I write to express the support of the Hamilton-Lauraville Main Street organization (HLMS) for SBo874, which would establish Community Safety Works as an ongoing program within the Maryland Department of Housing and Community Development (DHCD).

By way of background, HLMS is a not-for-profit program that has worked for over a decade to assist existing businesses, bring in new businesses, facilitate facade grants for business and commercial property owners, improve streetscaping, and support the communities and neighborhoods surrounding our Main Street, which includes approximately 1.5 miles of Harford Road (MD 147) in Northeast Baltimore City. Our mission is to help Main Street businesses and our community thrive by creating opportunities for local businesses and providing quality of life experiences that retain residents and attract new neighbors.

The budget initiative within DHCD that established Community Safety Works has already provided valuable assistance to HLMS and other nonprofit organizations, as well as businesses and local governments, through targeted investments in crime prevention that impact community safety.

The two separate target areas within our community whose safety and crime issues are now being addressed by projects that are possible thanks to Community Safety Works grants illustrate the importance of this program to communities like the seven wonderful,

diverse, and eclectic middle neighborhoods within HLMS's catchment and the additional connected neighborhoods nearby; specifically:

- Community Safety Works funds are helping us complete a vibrant community gathering space with equipment that will encourage daily use by all members of our community of a formerly-vacant property on our Main Street in the 4500 block of Harford Road, thereby adding "eyes on the street" and other crime prevention measures to the area and allowing this property to act as a bridge between two established retail areas in the 4300-4400 and 4600-4800 blocks. Prior to HLMS's project, this block had not seen the development that the other two areas have seen due to a number of factors, but largely related to various safety factors that include loitering, large-scale vacant buildings, and activities that include drug dealing at a corner in the center of the block; as a result, this block has been discouraging foot traffic between the other areas, hampering further development in those areas while the 4500 block itself continued to suffer. After the project began, (1) two local business owners from another area of the City began development of a new business in a vacant property that they purchased almost across the street from the HLMS property, and (2) a major developer purchased several parcels on the block and is already in the process of designing and obtaining permits for a gamechanging residential project that will provide a much-needed influx of students and young professionals from nearby Morgan State University and, with HLMS acting as a partner/co-developer, a commercial space that will have street-facing retail and other uses that we are currently planning with the assistance of a team of MSU graduate students in the City & Regional Planning Program.
- A separate Community Safety Works project has created a new Community & Public Safety Facilitator position within our organization and empowered this position with funds to install lighting and cameras based on business owner and resident input in the Hamilton and Hamilton Hills portions of our Main Street, which have disproportionately suffered from the City/Nation-wide uptick in crime, particularly in the area's core at the intersection of Harford Road (5400-5500 blocks) and Hamilton Ave (2900-3000 blocks), exacerbating the challenges at this entire end of our Main Street and hampering our efforts to assist the business community in their growth and recovery from the pandemic; for example, in the 2 quarters preceding HLMS's application under the Community Safety Works initiative alone (4/1-9/30), crimes in this community center included a quadruple shooting that lead to at least one death, a daytime armed robbery, a carjacking, and multiple burglaries, larcenies, and auto thefts. Importantly, this position and the solutions to be created by it will be grounded in community input, including input at a meeting scheduled next week in which business owners and residents will assist HLMS in creating the position description and hiring process plans.

HLMS continues to work with residents, business and property owners, and community partners to identify additional areas of concern and potential solutions that can equitably address these concerns in a way that helps our community as a whole, and we are prepared to begin more specific planning on additional projects as soon as we know that the program can continue; indeed, I recently met with one potential nonprofit partner and, because of our discussion about a possible community safety and intervention project and HLMS's progress under the existing Community Safety Works initiatives, began reaching out to DHCD to ask if they could give me an indication of when we might anticipate additional rounds of applications for this and other grants.

Over 80 of our rebuilt homes are in a one-block area of Broadway East just north of Johns Hopkins Hospital. This area has been reborn as a growing community of opportunity, but its newfound stability and growth hinges on whether its new homeowners and renters—and its legacy residents—feel safe. Thanks to Community Safety Works, we are adding street lighting to this area to increase community connectivity and further deter any threats of criminal activity that could cause residents to want to leave the community again.

The Community Safety Works program has also provided critical funding to our partners at Rebuild Johnston Square Neighborhood Organization (RJSNO) for security and public safety investments in Johnston Square. ## Testimony of Elizabeth Morrison, M.D. Support for SB 845 and HB 933 The End-of-Life Option Act

(The Honorable Elijah E. Cummings and the Honorable Shane E. Pendergrass Act)

I am Elizabeth Morrison, a psychiatrist for 40 years, first in the U.S. Army and then in private practice in Maryland. I have been active in local and national medical organizations, including leadership positions with the Washington Psychiatric Society — which includes Montgomery and Prince George's counties - and with the American Psychiatric Association (APA). I speak for myself and I support the End-of-Life Option Act.

I have 3 points:

1. From a psychiatric perspective, aid-in-dying patients and suicidal patients should be viewed as fundamentally different.

Suicide in the context of some mental illnesses occurs because of intolerable suffering, distorted and irrational thinking, and impaired judgment. In contrast, individuals eligible for aid-in-dying have terminal, treatment-refractive illnesses. These are people who, if not for their terminal illnesses, want to live.

2. Most patients with psychiatric conditions do maintain capacity and can continue to make medical and other end-of-life decisions.

Patients nearing death may be sad and grieving, but <u>still have capacity</u>. They should be allowed to participate in medical aid in dying. Those who have significant depressive or other concerning symptoms should be referred for evaluation by a mental health professional.

3. The American Medical Association (AMA) has modified its position to accommodate aidin-dying:

In 2019 the AMA remained opposed to medical aid in-dying <u>but</u> simultaneously concluded that physicians who participate in it are not violating The Code of Medical Ethics, and that morally admirable physicians can hold divergent views on this issue. Here is the <u>exact language that appears in the Code</u>.

Thus, any attempt to say that the AMA opposes medical aid-in-dying is telling only half the story.



The Bel Air Downtown Alliance would like to express our strong support for Senate Bill 874, which would establish Community Safety Works as an ongoing program within the Maryland Department of Housing and Community Development. Established as a budget initiative within the Department, Community Safety Works has already provided valuable assistance to nonprofit organizations, businesses, and local governments through targeted investments in crime prevention that impact community safety.

Downtown Bel Air has greatly benefited from funding provided by the Community Safety Works grant program. Pedestrian safety is a concern in the Town of Bel Air. Within the last five years two pedestrians were killed in Downtown Bel Air. Bel Air's signature events attract thousands of individuals throughout the region. The increase in population and traffic causes a rise in criminal and negligible incidents affecting the lives of our community members. In 2020, the Town of Bel Air had a total of 159 violent crime and property crime incidents. In the same vein of public safety, Bel Air's six-story parking garage (privately co-owned by TOBA and Harford County) is utilized by residents and visitors who attend Bel Air's events but the lack of security cameras on the five lower levels of the garage was concerning because there has been an increasing rate of criminal and suspicious activity in the garage. In 2021 there was a total of 121 suspicious behavior incidents, five vandalism incidents, two incidents involving controlled substances, and 11 check the welfare incidents. Due to the rise in crime, many members of the community did not feel safe utilizing the parking garage.

The Bel Air Downtown Alliance is a non-profit community development organization whose mission is to mobilize stakeholders to invest in Bel Air's neighborhoods, economy, and quality of life.


The Bel Air Downtown Alliance received funding to purchase 100 8 ½ feet steel barricades. The barricades have been utilized to better control the flow of traffic and block vehicle access to restricted areas during Bel Air's outdoor festivities. Pedestrians are now able to enjoy outdoor activities in Downtown Bel Air knowing that they are in a safe environment protected from vehicular traffic. We also received funding for the purchase and installation of twelve surveillance cameras through the Community Safety Works grant program. The security cameras are now being monitored 24 hours a day by the Bel Air Police Department. The installation of the surveillance cameras in the parking garage have improved community safety. Residents and visitors who utilize the parking garage have reported feeling safer knowing criminal activity in the garage has declined and that the surveillance cameras are being monitored.



The funding we received from the Community Safety Grant in 2022 was appreciated far more than any words will convene. We were able to address 14 safety concerns at our location that serves over 20,000 patrons annually. Some highlights of upgrades include:

- a locked door security system with camera monitoring access for our child care center,
- sight-line enhancements at a cross-walk area, and
- removal of large trees and thick brush to install clean ground cover on over 3,000 square feet around the playground, pavilion, and community member access areas.

Future funding would make additional upgrades to enhance camera security to meet specifics of HR 5515. Our other location is situated in an area prone to crime where we are able to assist the City of Cumberland Police Department, however sometimes our footage is not adequate to capture everything that is needed. Funding from Community Safety Works would also allow for additional lighting in areas that are dark helping to prevent future crime and allowing for quality images to be captured via security cameras. All Maryland communities should have adequate safety and security measures in place to be safe in the place we call home.

On behalf of Downtown Frederick Partnership, I would like to express our strong support for Senate Bill 874, which would establish Community Safety Works as an ongoing program within the Maryland Department of Housing and Community Development. Established as a budget initiative within the Department, Community Safety Works has already provided valuable assistance to nonprofit organizations, businesses and local governments through targeted investments in crime prevention that impact community safety.

The Partnership has utilized Community Safety Works funding to support two initiatives that currently are underway and a third initiative that will be implemented later this year. These projects include the Downtown Frederick Ambassador Program, a security camera grant program and a new effort to purchase speed boxes.

The Downtown Frederick Ambassador Program was launched in response to a local initiative that worked for several months to discuss the community's concerns related to changes in the transient population, the use of drugs and other inappropriate activity in Carroll Creek Park and the desire for improved cleanliness throughout downtown. The findings of this work were instrumental in undertaking the Ambassador Program. Launched in late November 2021, the Ambassador Program improves cleanliness, provides a stronger safety presence and ensures a robust welcome to visitors. In the first full year of implementation, the following statistics give a sense of the program's significant impact in Downtown Frederick: 9,396 block faces cleaned, 655 biohazards removed, 1009 stickers/posters removed, 902 business contacts and 1,168 people utilized hospitality services.

While the statistics are impressive, some of the stories behind the numbers show the full impact of this program:

- the older woman downtown who couldn't make it back to her friend's car and the ambassador who found her a chair and water and waited with her till her friend could pick her up
- the young woman who found that her car battery was dead early one morning and was assisted to get back on the road
- the middle aged man who had too much to drink and was persuaded to have his daughter drive him home

The Partnership and the community are convinced of the power of the Ambassador Program. That said, it is expensive to implement at a cost of nearly \$350,000 per year. Staffing costs are the most significant expense. The starting wage currently is \$16 per hour. The Community Safety Works Grant has been a key part of the Partnership's efforts to fully fund this important program.

The Partnership also has utilized this funding to support the implementation of security cameras on the first floor of commercial buildings in Downtown Frederick. Thirty two downtown businesses received grants of up to \$500, resulting in a total of 142 new security cameras. Each business is required to have at least one camera facing the street. Businesses who receive a grant give permission for their cameras to be registered with the City of Frederick Police Department for at least two years (until January 31, 2025). Businesses also are agreeing that, if asked, they will share their footage with the City of Frederick Police Department. Registering cameras helps businesses and law enforcement address crime-related issues collaboratively. Already, the cameras have helped to return a stolen laptop and assist with identifying suspects in a robbery.

Finally, the Partnership has worked closely with the City Police Department to respond to community concerns and the Partnership will be utilizing new Community Safety Works funding to purchase speed boxes. The Police Department will utilize these boxes to monitor problem spots within Downtown Frederick. The data will be helpful in learning how and when to effectively deploy resources to best resolve community concerns.

The University of Maryland, Baltimore would like to express our strong support for Senate Bill 874, which would establish Community Safety Works as an ongoing program within the Maryland Department of Housing and Community Development. Established as a budget initiative within the Department, Community Safety Works has already provided valuable assistance to nonprofit organizations, businesses and local governments through targeted investments in crime prevention that impact community safety.

In the past 365 days, the Upton community has experienced 145 violent crimes. That means that families living in Upton are threated with violent crimes every other day of the week. Just three weeks ago there were five people who were shot and/or killed in one day. We desperately need violence prevention and intervention.

The University of Maryland, Baltimore has developed a Community Violence Intervention and Prevention Program (CVIPP) which places credible messengers (previously incarcerated or those with lived experience of violent crime) on the streets every day to message around violence prevention, mediate conflicts, and provide case management. The CVIPP team is made up of social workers and credible messengers. Through this partnership we are able to decrease violent

crime and increase employment, enrollment in drug treatment, and access to mental

health services.

The University received funding from the Department of Housing and Community

Development this past January to implement the CVIPP model. Due to this funding,

in the past three weeks we have been able to share violence prevention messages

1097 times and mediated 150 conflicts. Highly respected credible messengers who

used to lead gangs in Baltimore have mediated high risk conflicts five times since

the program began three weeks ago. Those mediations saved lives. Prior to the

CVIPP, Upton was experiencing approximately 2.8 violent crimes per week. Since

this program began, there has been an average of 1.7 violent crimes per week. There

have been no murders in the Upton Community since the CVIPP program started.

We are already seeing great success, but we know this is not an issue that will be

resolved quickly. Violence crime has been an issue for decades in this community

and it will take years for us to stop the violence. If this bill is passed, funding will

allow this type of work to continue. To be most effective in violence prevention we

need multi-year funding which will allow for deeper relationships with those who

are at risk of engaging in violent crime, increased number of violence

interventionists on the street, and increased number of case managers to address

the needs of the community. In the end, this funding will save lives.

Dear Chairman Guzzone and Members of the Senate Budget and Taxation Committee:

Habitat for Humanity of the Chesapeake brings people together to build homes, communities and hope. Our vision is a world in which everyone has a decent place to live. We have carried out this mission by actively building new homes and rehabilitating vacant housing stock for 40 years.

With the founding of Chesapeake Habitat for Humanity in 1982, the Habitat mission was introduced to Baltimore with staff and volunteers working to rehabilitate the iconic row homes in Baltimore City and County neighborhoods. In 1986, the Arundel Habitat for Humanity affiliate was established.

On July 1, 2009, the Arundel and Chesapeake affiliates merged to form Habitat for Humanity of the Chesapeake—a leading provider of affordable housing in the Anne Arundel County and Greater Baltimore region. In 2011, our reach expanded once again when we merged with Habitat for Humanity of Howard County. In 2014, Habitat Chesapeake joined forces with Sandtown Habitat for Humanity, building one united affiliate to better serve Central Maryland.

These mergers have allowed what is now Habitat for Humanity of the Chesapeake to serve even more communities and family partners in Maryland. By combining efforts, Habitat Chesapeake now has the capacity to renovate vacant and dilapidated inner city housing while also focusing on more rural single-family dwellings.

Today, we serve more families in Central Maryland than ever before. We have settled more than 789 families into energy-efficient, affordable homes with zero-interest mortgages.

Our homebuilding in communities is a part of helping bring one of the most crucial elements of physical development in a community: bringing in new homeownership into a community immediately adds to community strength and economic development. There are often other plans, goals, and needs that communities identify which would build greater strength and safety within their physical environment. These are plans that we support, but for which communities can often encounter obstacles in attempting to access.





Lighting plans in Baltimore City's Pigtown, on Ward Street, come to mind. Several years ago, there was a community-led effort to review public safety through design criteria in that neighborhood. The number one intervention they arrived at was that additional and adequate lighting would improve public safety, but also the look and feel of the neighborhood. It would lead to greater feelings of safety by the residents.

Greening plans for lots that formerly housed dangerously decrepit vacant houses in Woodbourne-McCabe is another example. For years, community leadership has identified greening efforts on lots that came into use after strategic demolition paved the path for that. As Habitat, we have aided in lot greening in that neighborhood, knowing how critical it is to the safety, and well-being of the neighborhood. However, our resources for engaging in projects other than homebuilding are limited.

The Community Health and Safety Works Grant Program and Fund could be an excellent resource for a community such as Woodbourne-McCabe, where residents are highly mobilized to see new and better investment in their neighborhood, and to help preserve the same.

SB 874 The Community Health and Safety Works Grant Program and Fund would provide a critical resource for communities seeking to address and improve the areas of need, and dreams they have for greater revitalization. In our own work, we have been the grateful recipient of funding toward security system upgrades for one of our ReStores. The support from this fund goes an incredibly long way for a non-profit like ours to strengthen our security systems.

We urge your support for this important new grant program and fund.

Speeding and vandalism have been, and continue to be, a main concern for the Town of Emmitsburg, its businesses and residents. The 2015 Comprehensive Plan for Emmitsburg, which addresses future needs and sets Town goals for 10-years, lists speeding as a main concern in Emmitsburg. Because of its location on the Pennsylvania, Maryland, and D.C. commuting corridors, Emmitsburg has seen an increase in commuter traffic. Since Main Street is the sole east-west through street, it tends to be congested at peak traffic hours increasing tendency for motorists to utilize other streets to circumvent the gridlock. SHA traffic number's reports approximately 7,375 vehicles traveling the road per day. A total of 501 traffic stops occurred in 2021 and 1,111 in 2022 to try and combat the issue. As recent as the September 12, 2022 town meeting several individuals spoke during public comment urging the Town to pursue options to slow traffic and increase safety. In addition, Emmitsburg has had six instances of spray paint vandalism the past two years. The Town was able to apply for and obtain Community Safety Work grant funds in 2023 to purchase two speed trailers and two surveillance cameras to deter speeding and vandalism. If it was not for this grant, the Town would not have been able to afford these safety efforts. If funding is available in the future, Emmitsburg would be able to continue to deter speeding and vandalism through additional security cameras, signage, lighting, litter removal equipment and beautification. Our community is thankful for this funding.

I write in strong SUPPORT of SB874. LifeBridge Health is a regional health system comprising Sinai Hospital of Baltimore, an independent academic medical center; Levindale Geriatric Center and Hospital in Baltimore; Northwest Hospital, a community hospital in Baltimore County; Carroll Hospital, a sole community hospital in Carroll County, and; Grace Medical Center in Baltimore (formerly Bon Secours Hospital).

During LifeBridge Health's hospitals' Community Health Needs Assessments, participants consistently targeted community violence and safety as key concerns. In response, we developed our Center for Hope, addressing all types of violence intervention and prevention - child abuse, elder abuse, human trafficking, domestic violence and community violence. Ensuring sustainable funding for these and other programs supporting community health and safety is critical.

One key component of our community violence strategy is our legacy Safe Streets program and our recent tripling of the number of sites under our operation upon request from the City of Baltimore. We are fortunate to obtain support from the Department of Housing and Community Development's current Community Safety Works program supporting capacity building in the areas of community engagement and infrastructure to ensure that all of our Safe Streets programs across the City succeed in their new format, and sustainable funding will facilitate continued investment in safety-oriented programs and projects.

A crucial component of the program is to mobilize the community to build and energize a base of support for Safe Streets that shifts the norm from violence as a response and recognizes it as the public health crisis it is. This involves building neighborhood-based coalitions of residents, local businesses, service organizations, and members of the faith-based community. Grant funds will support a new Community Liaison position to develop and implement a community-wide violence reduction plan and introduce a local community council.

Grant funds will also enhance use of data to drive outcomes and determine future operations. With the addition of a new data coordinator position, all Safe Streets outcomes reported in a city-wide database will be accessible to us for analysis, program evaluation and planning. Grant funds will also support operations, professional development and program supplies.

For all of the aforegoing reasons, I urge a **FAVORABLE** report for SB874.

Tree trimming is helping to improve the visibility around the property and helps provide a clear line of sight for exterior security cameras to reduce trespassing, vandalism and other safety incidents in the parking lot and around the property.

At Admiral Oaks (Annapolis), we are refreshing the community's two playgrounds to improve the overall durability of the playground's ground cover and plan to incorporate additional projects that will improve bench seating and improve the playground's overall curb appeal. These improvements will provide central outdoor locations where residents can gather in pride and comfort.

incident in VA, killing a woman.

On 3/7/19, an individual broke into ICM facility and tried unsuccessfully to cut into the metal safes in

the lobby to steal the cash donations (MCPD Case #190011200).

On 2/5/17, ICM's main office door was vandalized and broken into (MCPD case # 17-006298). Cash

collected that is kept inside the office before being deposited was stolen.

On 5/3/11, a threatening note was dropped at the front entrance that praised the US operation that

killed Osama bin Laden and warned that more is coming.

On 11/1/08, several structures at ICM were defaced by over 30 paintballs. (MCPD case # 08064997).

On 5/22/08, ICM office was broken into and surveillance system computer was destroyed. Two

security cameras were also tampered.

There are 1400 federally qualified health centers (FQHCs) in the U.S. that serve more than 27 million Americans. FQHCs have proven to be a vital asset for the delivery of health and wellness services to the medically underserved of our nation and the communities of Maryland. Established in 1972 in Northwest Baltimore City, Park West Health System (PWHS) was among the first FQHC models established for what is now conduits to ensure equal access to quality health care services regardless of an individual's or family's ability to pay or insurance status.

PWHS provides comprehensive primary health, dental, mental, and behavioral health services. Its location at 3319 Belvedere Avenue is the anchor of its 3 locations in the provision of services but is house in a building that was constructed in 1950 but was not constructed as a health center. The building is not up to today's building codes and standards and has inhibited the organization's ability to serve the constituents in the PWHS service area more comprehensively.

PWHS is working to rectify this with a 15,245 sf addition and the 10,710 sf renovation of the 2<sup>nd</sup> and 3<sup>rd</sup> floors of Park West Belvedere. Scheduled to break ground in the summer 2023, the Park West Health System Capital Expansion Project would not have gotten off the ground if it wasn't for the programs like BRNI and the Capital Grant program which enabled the funding and support to procure professional services such as legal, architectural, and structural to ensure the building's transformation.

We support SB 874 and appreciate that this funding has made it to its intended.

Surveillance: prevent crime and accentuate architectural details

Maintain Image: Decorative screening attached to fencing and vacant houses.

Future funding by the Community Safety Works could assist us in preventing crime through the following: 1) installation of a 24" deep canopy system with lighting and signage to attract visitors to main entry point; 2) Touchless Security Turnstiles; and 3) installation of two sets of accessible anodized Aluminum Doors to create secure vestibules.

Catholic Charities of Baltimore supports SB 874 which would establish the Community Health and Safety Works Grant Program in the Department of Housing and Community Development.

Inspired by the Gospel to love, serve and teach, Catholic Charities provides care and services to improve the lives of Marylanders in need. For 100 years, Catholic Charities has accompanied Marylanders as they age with dignity, obtain empowering careers, heal from trauma and addiction, achieve economic independence, prepare for educational success and feel welcome as immigrant neighbors. We recognize the need to deliver services in a safe environment.

Catholic Charities was recently a recipient of a Community Health and Safety Works Grant Program for the Cherry Hill Town Center (CHTC). Catholic Charities owns and operates a town center in the Cherry Hill neighborhood of Baltimore. CHTC is the commercial hub of the neighborhood containing a bank, Head Start classrooms, a library, community pharmacy, food vendors and other retail. Violent crime is persistent and pervasive in Cherry Hill, deeply harming residents and business in the neighborhood. According to the Baltimore Police Department, Cherry Hill has the highest percentage of police interactions among every single community in Baltimore City. A significant number of these traumatic events have taken place in or nearby CHTC, as unfortunately local gangs have chosen the shopping center as one of their main locations to conduct their illicit drug operations. The effect of this cyclic violence is felt by CHTC tenants and local residents. As the neighborhood's primary shopping area, residents and business owners should be able to run errands and go to work without jeopardizing their safety, which is not the current reality. We envision the CHTC as a neighborhood hub where residents can shop, eat, play, and connect with each other. But the cost of additional safety precautions was putting pressure on tenant rent so we applied to the Community Health and Safety Works Grant Program.

The grant funding we were recently awarded will allow us to increase the number of hours we have security on site. Additionally, we are in the process of upgrading our surveillance capabilities linking our system with the Baltimore City Police. These are enhancements we had long eyed but did not have the funding to implement. These improvements will benefit the businesses and organizations in CHTC, as well as the entire neighborhood. The Community Health and Safety Works Grant Program should be codified within the Department so that others can benefit from this vital funding.

New cameras will allow easier access for police to view/access for issues. Will allow staff easier remote access to view in real time as a result. Newer cameras have more AI features to track suspicious persons in building, allowing for a quicker response. These cameras will help us keep the children, members and staff in our building safer.

The Town of Thurmont employs their own police department that currently has nine police officers on staff with four openings at this time. Thurmont is a town of 7,000 and our police department has many needs, and unfortunately without raising taxes on residents, grants are the only option for the much-needed equipment to do their job effectively. Small towns have challenges hiring police recruits as the salary is less than the state or county police departments. Thurmont, fortunately, was awarded The Safety Works Grant in 2022 which made it possible to purchase much needed cameras in vandalism areas such as the park which will aid in deterrence and arrests with the current staff able to see the perpetrators without necessarily being at the scene. Yes, hard to imagine, but small towns have crimes and vandalism too, and these cameras will fill a much-needed void with the police staff not able to operate at full capacity due to the shortage of officers. Thurmont has also used this grant for much needed LED

crosswalk signs for safety for those walking on Thurmont's intown trails. This grant also enabled Thurmont to purchase speed signs to aid in traffic slowing down within the business district. Future funding would assist the Town of Thurmont to purchase more camera equipment, and lighting for high concentrated vandalism areas.

In addition, the State of Maryland has mandated that every police department in the State of Maryland have every officer wear a body camera by 2025. This type of expense without grant resources would result in cuts to other town services budgets, or cuts to the police budget for much needed items in order to be in compliance with the 2025 regulation. The Safety Works Grant was/is a lifeline to Thurmont and to any small town who employs their own police department.

### SENATE BILL 874 Community Health and Safety Works Grant Program and Fund - Establishment

### STATEMENT OF INFORMATION

**DATE:** March 7, 2023

**COMMITTEE: Senate Budget and Taxation** 

**SUMMARY OF BILL:** SB 874 establishes the Community Health and Safety Works Grant Program which would provide funding for projects that improve the quality of life or increase the economic potential of the communities through crime prevention strategies. The Department of Housing and Community Development would administer the program. The bill also creates a fund, the Community Health and Safety Works Grant Program Fund, to support the cost of the program. Additionally, the bill establishes a \$10 million mandate annually to the fund and allows the fund to retain all interest earned rather than reverting to the General Fund.

**EXPLANATION:** SB 874 establishes a new program to be administered by the DHCD. This program is supported by an accompanying special fund. That fund would have a mandated annual appropriation of \$10 million in perpetuity and be permitted to retain any interest earned on the funding. This would annually reduce General Funds available for other purposes and eliminate revenue to the General Fund from the interest earned.

The Department of Budget and Management (DBM) is charged with submitting a balanced budget to the General Assembly annually and strives to create a structurally balanced budget, in which the growth in spending is less than the growth in revenues. In light of current economic uncertainty and the potential for a downturn, the Department urges caution in passing legislation significantly expanding State required expenditures without offsetting revenues. General fund mandates can have the effect of crowding out the State's ability to fund staffing, salary adjustments, and in general invest strategically and holistically in State government's human capital and the infrastructure required to carry out State government's mission. State government must be intentional, disciplined, and strategic with its allocation of State funding to ensure maximum impact toward priority outcomes.
