Chesapeake Bay Foundation (CBF) **SUPPORTS** SB 246, which authorizes Wicomico County to create a sanitary district. The locality is currently the only Eastern Shore county without this authority.

There are approximately 18,000 septic systems in Wicomico County. Some of these systems are located in “Sewer Problem Areas” as identified in the 2010 Wicomico County Water and Sewer Plan. These areas are places with known septic system failures or systems with potential to fail. When septic systems fail, high concentrations of nutrients and bacteria can enter the groundwater and surface water. Most residential wells installed in the county prior to 2000 access drinking water from unconfined aquifers that are part of the groundwater table. Septic system failures can contaminate these aquifers and lead to a public health emergency. Nutrient-laden septic effluent in groundwater that leaches to local rivers can also make local waters unsafe for swimming and fishing and can threaten the health of aquatic life in the Chesapeake Bay.

To address these issues, Wicomico County officials are considering establishing a county sanitary district. A sanitary district will enable the county to create a formal structure for correcting septic system failures, that where feasible and intentionally designed to not serve new growth, may include centralized treatment solutions. The County is currently evaluating measures that can help accurately assess the extent of septic failures while involving citizens to validate these problems and inform a local response. The sanitary district authorization enabled by SB 246 will provide Wicomico County with an administrative pathway to identify service area and treatment alternatives, develop and satisfy wastewater policy compliance measures, and create governance, operations, and finance strategies that can help correct septic system failures within the jurisdiction.

Please accept this letter of support for *MD 2023 SB 246 Wicomico County – Sanitary District – Authorization*. In Wicomico County there are approximately 18,000 septic systems. When septic systems fail, high concentrations of nutrients and bacteria can enter the groundwater and surface water. In Wicomico County, most residential wells installed prior to 2000 are in unconfined aquifers. Shallow aquifers that are unconfined, or part of the groundwater table, are subject to contamination from septic system failure. Septic system failure can cause contamination of the drinking water source aquifers and lead to a public health emergency. Nutrient-laden septic effluent is also a primary contaminant of local rivers.

I recently served on the Greater Salisbury Committee's Task Force for Water and Sewer. The Task Force developed a white paper which outlined a process for Wicomico County to follow to implement the County's Water and Sewer Master Plan which was finalized in 2021. The Water and Sewer Master Plan identifies that 10,000 septic systems could be served by existing municipalities, and recommends that approximately 5,000 septic systems in rural communities receive service from new regional systems. In order for the municipal extensions or new regional systems to be implemented, Wicomico County needs to be the responsible entity for the County's water and sewer utilities. The legislation to allow Wicomico County to create a Sanitary District is the first step in this process.

I have over 26 years of engineering experience, primarily on the Eastern Shore of Maryland. I have lived in Wicomico County for the majority of my life and am passionate about the need for the County to take action to reduce the number of septic systems. I respectfully ask the committee for a favorable report for *MD 2023 SB 246 Wicomico County – Sanitary District – Authorization*.

Statement of Support by Bill Sponsor Senator Mary Beth Carozza

Thank you, Chair Feldman, Vice Chair Kagan, and members of the distinguished Education, Energy, and Environment Committee for allowing me to present Senate Bill 246 – Wicomico County – Sanitary District – Authorization.

Senate Bill 246 is an important local bill. It simply would allow Wicomico County to create a Wicomico Sanitary District which is the first step for Wicomico County to implement its Water and Sewer Master Plan which was finalized in 2021.

By way of background, Wicomico County has approximately 18,000 septic systems, with many of the residential wells installed prior to 2000 in unconfined aquifers. The County has developed a plan and a map to correct existing septic and sewer system failures in Wicomico County, and to include new infrastructure that may be connected to existing municipal treatment facilities or new centralized systems.

It is my understanding that Wicomico County is the only county in Maryland that does not have a county-wide department dedicated to managing wastewater. Wicomico County needs to be the responsible entity for the County's water and sewer utilities, and this bill provides that authority by establishing the sanitary district.

I also wanted to share that I personally have participated in several Wicomico County meetings with the Maryland Department of Environment and other state officials, county and municipal elected officials and their engineers, developers, realtors and homeowners to work together to address failing septic systems and outdated, at-capacity municipal wastewater treatment plants. I especially want to thank the Wicomico Water and Sewer Committee of the Greater Salisbury Committee for their leadership as we move forward with this legislation, Senate Bill 246, to address the long-standing challenges surrounding water and sewer in Wicomico County.

I truly appreciate your kind attention and consideration, and I respectfully ask for a swift and favorable report on SB 246.
