#### FAVORABLE

Dear Chair Feldman, Vice Chair Kagan and Members of the Education, Energy and Environment Committee:

The Maryland Military Coalition (MMC) **strongly supports SB 0473**, which will establish a commission to study establishing a memorial dedicated to Marylanders who have fought in the Global War on Terror and their families.

The Global War on Terror began in October 2001 and ended almost 20 years later when the final American forces left Afghanistan. Over 7,000 American Service Members lost their lives in combat in Iraq, Afghanistan and other locations in the Central Command area of operations.

There are more than 3.7 million veterans who have served in the Global War on Terror, including tens of thousands who live in Maryland. Many members of the National Guard and Reserve left their Maryland homes to serve.

Significantly, many Maryland leaders are veterans of the Global War on Terror, including Governor Moore, Attorney General Brown, Veterans Affairs Secretary Woods, Housing Secretary Day, and many members of the General Assembly, including Senator Will Smith, Delegate Mike Rogers, and Delegate Nick Allen, among others.

Approximately 43% of veterans of the Global War on Terror have a service-connected disability. The Global War on Terror affected not only the Service Members but also the family members who supported them at home.

Maryland did not dedicate its World War II Memorial until long after the war ended. Our state should honor the veterans of the Global War on Terror now, while veterans and surviving family members can gather and the Memorial and honor those who served.

The Maryland Military Coalition is a non-partisan organization of 19 Veteran organizations representing over 150,000 Maryland uniformed services men and women and their families -- almost half of the 355,000 veterans in the State.

We urge the Committee to favorably report the bill.

#### Written Statement in Support For Senate Bill 473 Before the Education, Energy and Environment Committee February 21, 2023

The nation's longest war known as the Global War on Terrorism had its origins following the heartbreaking, deadly attacks in World Trade Center and at the nearby Pentagon on September 11, 2001 and concluded August 30, 2021. During that 22-year period 1, 537 Maryland residents have served our country, in post 9/11 wars according to Brown University's Watson Institute.

Senate Bill 473 would help memorialize the 128 service men and women, all from Maryland, who gave their lives in that terrible conflict as well as support and recognize those who returned from Iraq, Afghanistan and other battle areas; many who still live with the devastating effects brought on by the War on Terror.
