Overdoses largely occur with the use of opioids and stigma against the use of medication in the treatment of opioid use disorders results in lack of access to opioid agonist therapy, a reduced willingness to receive treatment, and is a significant barrier to recovery.

Overdose Awareness Day sheds light on not only the devastating impacts of substance use disorders to individuals, but also to the burden on society. It also assists in decreasing the stigma related to the use of medications in the treatment of opioid use disorder. For these reasons, we respectfully request a favorable report on Senate Bill 138.

Chair Feldman, Vice Chair Kagan and Committee Members:

Senate Bill 138 is a very straightforward bill that simply requires the Governor to annually proclaim August 31<sup>st</sup> as Overdose Awareness Day.

Each year Maryland loses thousands of residents to drug overdoses and drugrelated death. The purpose of this legislation is to clearly enshrine August 31<sup>st</sup> as a date to recognize those deaths and this epidemic and to encourage those currently suffering to seek support and treatment.

Good Afternoon Honorable Senators,

#### SB138 - Favorable

I am Chesapeake Beach Mayor Pat Mahoney testifying on behalf of the residents and Town Council of Chesapeake Beach, Maryland to express our support for Senate Bill 138 recognizing August 31<sup>st</sup> as Overdose Awareness Day in the state in recognition of family and friends lost to drug overdoses.

In our small town of Chesapeake Beach, there have been more than 98 reported overdoses and 17 deaths attributed to Opioid Use Disorder since 2016, devastating families. Since January of 2017, I, the Town Council, residents of Chesapeake Beach, and community partners, through our Twin Beach Opioid Abuse Awareness Coalition chaired by Town Councilman Pardieck, have worked diligently to raise addiction awareness with our residents, connect those in need with prevention, recovery and support resources, reduce the shame surrounding this disorder, and most importantly -- help save lives. Outreach and education to connect people with resources and reduce stigma work. In 2016, Chesapeake Beach had 14 non-fatal overdoses and 5 fatal overdoses; in 2022 we had 1 nonfatal overdose and 1 fatal overdose. Yet more needs to be done, especially to reduce the stigma surrounding addiction so the people afflicted with this disease and their family members seek and get the support they need. And SB138 is a step in the right direction.

This bill provides several important messages from our state leaders to our residents. They are: 1) drug addiction is a disease, not a character flaw; 2) those who have died from this affliction, and those who continue to struggle with addiction and their families are valued by us; and 3) overdose death is preventable.

For these reasons we support SB138 and encourage you to support it as well.

Overdose Awareness Day sheds light on not only the devastating impacts of substance use disorders to individuals, but also to the burden on society. Paul Earley, former President of the American Society of Addiction Medicine wrote, "We will continue to advocate for policies that shatter the stigma and discrimination surrounding addiction, expand access to evidence-based care for individuals who are incarcerated or otherwise marginalized, and remove the structural barriers that prevent many Americans from accessing quality addiction treatment."

Awareness is the first step in this process. We respectfully request an favorable report on Senate Bill 138.
