Chairman Barve and Committee Members,

I am Ron Weiss, a resident of Fort Washington, a member of the MD 210 Traffic Safety Committee, and a frequent user of MD 210, our "Main Street".

I am here today to urge your support of HB 431 and HB 435.

**We** are here today because:

10 people were killed in traffic violence on Maryland 210 last year.

Nearly 90 people have been killed on MD 210 since 2007.

Maryland 210 is the deadliest roadway per mile in Prince George's, in Maryland, and in the DC Metro region.

Of the four major roads I traveled to testify, MD 210, I-495, US 50, and Rowe, 210 was the most dangerous.

The existing 3 MD 210 speed cameras have been effective in slowing traffic according to police.

They have been effective with drivers who act their age and just need a nudge to slow down.

They have been in-effective with drivers who act younger than the age they were when they got their driver's license.

This small percentage of the nearly 80,000 drivers who travel 210 on an average day, drive at deadly speeds. One at 168 MPH. In the 8-month period April through November 2022, 684 drivers were clocked at 90 MPH and above on MD 210. 320 of them drove at 100 MPH and above. One of them drove at 168 MPH.

These reckless drivers take advantage of the low \$40 speed camera fine and the many stretches of MD 210 that they use as drag strips or racetracks.

These bills target those reckless drivers by increasing fines for higher speeds and multiple violations. And adding more cameras will eliminate the 210 stretches that lack enforcement.

I want skeptics to know that the MD 210 speed cameras don't generate income, the speeders generate income. If they did not speed, there would be no income. What income speeders generate goes to improve MD 210 safety.

Speed cameras are not "silver bullets". Police enforcement is required to enforce DUI, seatbelt use, and distracted driving. But speed cameras are on the job 24/7/365, they are unbiased, and they don't put lives at risk as in a traffic stop.

In closing, please keep those 10 people who died last year and the scores of others who died before them on Maryland 210 in your prayers. But also take action to stop the killing and pass HB 431m and HB 435.

In the state of Maryland Route 210 is the most dangerous road! Many of my community members, neighbors, friends and even family members have been injured and killed on Route 210. Community civic associations and groups have complained about the dangers of Route 210 for more than 20 years and been ignored while our community suffers daily. Road safety depends on users following the rules of the road to provide a predictable environment for all users. While most people drive responsibly on MD 210, its long sections of straight, level roadway attract speeders and illegal racers. As a result, MD 210 continues to be one of the deadliest roads in Prince George's County and the area. There have been 8 fatalities on MD 210 this year and the minority of irresponsible drivers have not been deterred by \$40 fines. Over 600 vehicles have been clocked at over 90 MPH during the 7month period AprilOctober 2022. One vehicle was recorded at an incredible 168 MPH this year. These drivers inject chaos in our road environment and make our travel much riskier. Reckless drivers value their thrills over our basic rights to safety, peace, and tranquility. PG-303-23-1 will go a long way to deter their life-threatening and irresponsible behavior. I strongly urge you to support PG-303-23-1.

Dear Chair Barve and Committee Members:

The Maryland Department of Transportation (MDOT) takes no position on House Bill 431 but offers the following information for the Committee's consideration.

House Bill 431 increases the fine associated with a speed camera violation on Maryland 210 based on the speed of the vehicle at the time of violation and whether it is a repeat violation. Currently, Maryland statute limits the fines associated with a speed camera violation to \$40 per violation, regardless of the vehicle's speed or number of offenses.

The 13-mile corridor of MD 210 has a fatal crash rate that is significantly higher than the Statewide average for State-maintained highways. To improve safety for all users, MDOT State Highway Administration (SHA) is identifying and constructing safety improvements across the State. Significant projects in Prince George's County include the Kirby Hill interchange that was finished in 2022 and the future grade-separation that will be built at the interchange of MD 210 and Palmer/Livingston Road. SHA is continually assessing and improving the signals and signs along the corridor. SHA also collaborates with local stakeholders quarterly to discuss safety concerns and potential countermeasures, including an ongoing bicycle and pedestrian connectivity projects.

The Prince George's County Police Department (PGPD) patrols MD 210 and administers the County's speed monitoring program. Representatives from the PGPD participate in regular discussions with SHA, community members, and elected officials regarding safety along the corridor. During those discussions, the PGPD informed SHA that repeat speed offenders and those traveling more than 30 miles per hour over the posted speed limit are a major concern. These offenders are currently only receiving a \$40 fine for each violation, with no other civil penalty such as points on their driver's license.

The Maryland Department of Transportation respectfully requests the Committee consider this information when deliberating House Bill 431.
