# Bill:HB 944 – Motorized Minibikes - Regulation and EnforcementCommittee:House – Environment and TransportationPosition:FAVORABLE WITH AMENDMENTS

Dear Chairman Barve, Vice Chairman Stein, and Members:

On behalf of the Charles County Commissioners, this letter is to express the support of the Board for HB 944— Motorized Minibikes - Regulation and Enforcement, with amendments.

The intention of HB 944 is to enable the County Commissioners to pass a local law establishing regulations of off-road motorcycles and all-terrain vehicles. While these vehicles are already illegal for use on public roadways and private property without the permission of the owner, violators have not been adequately deterred, and often times reclaim their vehicles and resume the prohibited activity in short order Off-road motorcycles and all-terrain vehicles, when operated illegally, are a threat to other motor vehicles and pedestrians alike. For this reason, we are seeking the unambiguous authority by the General Assembly to pass a local law to include age restrictions, registration requirements and penalties.

To fully meet the needs of our community in addressing this problem, we respectfully request an amendment to HB 944 in order to include all-terrain vehicles, and our ability to implement registration and impoundment/storage fees. A copy of the proposed amendment is attached hereto.

We appreciate the opportunity to provide our support for HB 944.

#### AMENDMENT NO. 1

On page 1, in line 2, after "**Minibikes**" insert "<u>and All–Terrain Vehicles</u>"; in line 3, after "regulate" insert "<u>all–terrain vehicles operated on four</u> tires <u>and</u>"; in line 5, after "involving" insert "<u>all–terrain vehicles operated on four tires and</u>"; and in line 6, after the second "to" insert "<u>all–terrain vehicles operated on four tires and</u>".

### AMENDMENT NO. 2

On page 3, in line 23, after "REGULATING" insert "<u>ALL-TERRAIN VEHICLES OPERATED</u> <u>ON FOUR TIRES AND MO</u>TORIZED MINIBIKES IN THE COUNTY TO INCLUDE (i) REGISTRATION REQUIREMENTS AND FEES; (II) AGE RESTRICTIONS; AND (III) IMPOUNDMENT AND DAILY STORAGE FEES FOR MINIBIKES AND ALL TERRAIN VEHICLES USED IN VIOLATION OF TITLE 21 SUBTITLE 900 OF THISE ARTICLE, 6-404 OF THE CRIMINAL LAW ARTICLE, OR 6-405 OF THE CRIMINAL LAW ARTICLE"; and in line 25, after "INVOLVING" insert "<u>ALL-</u> TERRAIN VEHICLES OPERATED ON FOUR TIRES AND".
