Testimony of Senator Hayes in Support of

Senate Bill 125: Business Diversity Incubator Program

Chairwoman Griffith and members of the Finance committee,

Senate Bill 125 establishes the Business Diversity Program in the Maryland Technology Development Corporation (TEDCO) for the purpose of providing grants to nonprofit organizations to establish diverse and effective business incubators in the State.

Federally, we created the Civil Rights Division of the Department of Justice in 1957 to uphold the civil and constitutional rights of all persons in the United States, particularly some of the most vulnerable members of our society. 20 years later in 1978, the Maryland General Assembly enacted legislation creating the Minority Business Enterprise (MBE) Program to ensure that socially and economically disadvantaged small business owners are included in the state's procurement and contracting opportunities. However, very little strides were made in the tech space.

In 2017 and 2018, only 10 of TEDCO's 135 investments were made in companies run by Black entrepreneurs. That is 0.85% of the total investment amount during that time period. This bill seeks to create equity in tech by addressing the wide chasm that exists in terms of investment into companies run by socially and economically disadvantaged individuals.

I urge you to vote favorably on SB125.

Employ Prince George's, the principal workforce development entity for Prince George's County, that provides nationally recognized community and workforce development programming, offers this testimony in support of Senate Bill 125: Business Diversity Incubator Program (SB 125). As the administrative and fiscal agent of the Prince George's County Workforce Development Board, Employ Prince George's is responsible for operating the Prince George's County Public Workforce System. Under the leadership of Employ Prince George's, and the Prince George's County Workforce Development Board, the Prince George's County Public Workforce System serves over 25,000 job seekers and businesses annually.

SB 125 creates the Digital Bay Business Diversity Program ("Program") and establishes a grant program for 501(c)(3) nonprofit organizations to facilitate diverse and effective business incubators within Maryland. Further, SB 125 requires the Governor to appropriate \$2 million in the annual budget from FY 2026 to FY 2031, half of which is earmarked to organizations participating in Maryland's Minority Business Enterprise (MBE) program.

Maryland's economy benefits from diverse businesses, and Maryland's nonprofits are prepared to leverage resources to ensure diverse and effective business incubators are established throughout the State. SB 125 would make funding available to nonprofits for small business development, marketing, business education curricula, finance training, and business materials. Funds for these purposes will ensure that diverse and effective business incubators generate sustainable economic opportunities.

By requiring that half of the funding allocated in the annual budget be awarded to organizations that participate in MBE Program, SB 125 incentivizes future participation in the MBE program and ensures that nonprofits who are currently participating in the program receive critical financial support that will facilitate their continued success in Maryland's economy.

In addition to the appropriation of funds, SB 125 includes oversight provisions that will ensure the successful implementation of the program. For example, a grant recipient must enter into a program agreement, and any violation of the agreement is subject to specified remedies. Moreover, no more than 15% of a grant award may be used for operating expenses, and a grant recipient must submit an annual report which will document how the grant recipient utilized the funding.

SB 125 promotes diverse nonprofits and businesses in Maryland, which will benefit every Marylander. For the aforementioned reasons, Employ Prince George's respectfully requests a favorable report from the Committee.

The Maryland Technology Development Corporation (TEDCO) is dedicated to economic growth through the fostering of an inclusive entrepreneurial and innovation ecosystem. TEDCO discovers, invests in, and helps build great Maryland-based, technology companies.

TEDCO supports SB 125 – Business Diversity Incubator Program and the bill sponsor's amendments developed by a coalition of incubator stakeholders, including TEDCO. We thank the bill sponsor, Senator Hayes for his leadership on this important issue. SB 125 creates a new program and fund in TEDCO for the purpose of providing grants to establish diverse and effective business incubators in the State.

TEDCO recognizes the importance of incubators as a valuable component of the of the infrastructure for an innovation-based ecosystem and economy. They serve the ecosystem in several important ways that include:

- Providing guidance and advice to early-stage entrepreneurs and helping them progress to sustainability or venture investment that will lead to growth and the creation of jobs;
- Creating a community of entrepreneurs by making space available so early-stage companies can
 work in close proximity and learn from each other, or by hosting events including speakers,
 investment pitches, and other activities that allow entrepreneurs to interact with and support each
 other:

Senate Bill 125 will intentionally encourage, support, and expand the diversity of incubators across the State. This represents an opportunity to strengthen Maryland's innovation infrastructure and expand the economic impact that incubators, like the Digital Bay Center, are already having on underrepresented entrepreneurs and the economy. An investment in diverse incubators will be an investment in Maryland's economy through the development of diverse entrepreneurs, and it will create a faster road to market for new products launched by Maryland's early-stage companies.

For all these reasons, TEDCO is supportive of SB 125 and requests the bill sponsor's and stakeholder's amendments be adopted.
