We respond to over 300 calls per month from individuals, family members, and professionals seeking information and assistance to help people living with brain injury. In addition, we provide resources, case management, trainings, events, and policy advocacy.

There are an estimated 605,000 Marylanders living with a brain injury. These individuals experience changes in their health, thinking, behavior, self-regulation, and social skills. These Marylanders deserve a seat at the table of the Maryland Commission on Disabilities. **SB 732** will provide those individuals that seat and the ability for their voice to be heard.

The Maryland Commission on Disabilities (MCOD) is an important advocate for individuals with disabilities in this state. It serves as the advisory body for the Maryland Department of Disabilities, which is charged with unifying and improving the delivery of services to people with disabilities. The Maryland Commission on Disabilities (MCOD) serves as the advisory body for the Maryland Department of Disabilities, which is charged with unifying and improving the delivery of services to people with disabilities. MCOD also participates in developing the State Disabilities Plan, a comprehensive multi-year strategic plan that sets performance goals for all agencies in Maryland which serve people with disabilities.

A TBI is a serious and potentially life-changing injury caused by a sudden blow to the head that damages the brain. Suffering a TBI can lead to physical and/or cognitive difficulties requiring intense rehabilitative care. It is far time Maryland recognizes that a TBI is a disability and people suffering from a TBI should have a seat at the table.



The Maryland Department of Disabilities (MDOD) is pleased to submit this letter of support as favorable with amendments for **Senate Bill 732: Department of Disabilities-Maryland Commission on Disabilities-Membership**.

The Maryland Commission on Disabilities (MCOD) is MDOD's statutory board and advises MDOD on its departmental duties as the principal unit of State government responsible for developing, maintaining, revising, and enforcing statewide disability policies and standards throughout the units of State government. To ensure the MCOD reflects MDOD's constituents, there are several designated Governor appointed slots for disability representation such as physical disability, mental illness, Deaf, Blind, developmental and intellectual disability. A disability not currently represented is traumatic brain injury.

SB 732 amends the MCOD membership section of the Maryland Statute Md. Human Services Code Ann. § 7-120 to include traumatic brain injury. Traumatic brain injury representation in Maryland currently has the Traumatic Brain Injury Advisory Board under Maryland Department of Health and MDOD is represented on the Traumatic Brain Injury Advisory Board.

Adding a MCOD slot specifically for traumatic brain injury is intended to balance the state government disability and traumatic brain injury constituent representation. This will result in Maryland having both the existing MDOD representation on the Traumatic Brain Injury Advisory Board and a traumatic brain injury constituent voice on the MCOD.

The suggested amendments are designed to streamline an existing state initiative and to have the State Coordinator for Autism Strategy and the Advisory Stakeholder Group on Autism–Related Needs moved to MDOD.
